### Introduction

Accounting is a business language that elucidates the various kinds of transactions during the given period of time. Accounting is defined as either recording or recounting the information of the business enterprise, transpired during the specific period in the summarized form. The American Institute of Certified Public Accountants Association defines the term accounting as follows: **“Accounting is the process of recording, classifying, summarizing in a significant manner, of transactions which are financial in nature and finally interpreting the results.”**

Management accounting is the accounting system for making decisions of the business enterprise. Management accounting furnishes the necessary information to assist the business enterprise to make rational decisions through the development of policies and procedures in order to meet the day to day commitments of the enterprise.



*Did u know? Is accounting an equivalent function to book-keeping?*

No, accounting is broader in scope than the book-keeping; the former cannot be equated to the later.

### 1.1 Management Accounting as an Area of Accounting

Management accounting as a new branch of accounting is of recent origin. Financial accounting recorded business transactions on double-entry basis and helped ascertainment of profit or loss for the given period and valuation of stock of assets and liabilities on a given date. Financial accounting enabled the concern with the liabilities and safeguard the assets entrusted and therefore,

was also known as custodial or stewardship accounting. Basically meant for consumption of owners, creditors, statutory authorities, the reporting was for a concern as a whole.

In olden days, when the concern was small and catering to the local area of operation, the proprietor who managed the show was aware of all the happenings and could control the business well without additional information. But as businesses grew bigger, and the area of operations widened, there came into existence a separate cadre of people called the management. Since the rewards of management were entirely dependent on performance, they wanted a lot of information on the concern and outside, which was necessary to be effective. They also wanted information quickly, which made financial accounting inadequate.

The need for a new type of accounting was felt. This gave birth to cost accounting. The emergence of cost accounting to large extent satisfied the need of management. Cost accounting identified expenses to the origin (product, department or territory) by classifying them as direct or indirect expenses and depending upon their variability, categorised them as variable or fixed expenses. These helped the cost assembly, planning, fixing of standards and monitoring of variance and made it an easy job to control cost through responsibility accounting.

Responsibility accounting apart from serving as a control mechanism was also a motivational tool for achievement and rewards. Since management knew the incidence of expense and its origin, early steps for correction could be taken promptly. Meaningful reports to suit the hierarchy were instituted for periodical submission. People lower down the order got all the information quantitatively; middle management both quantity and value. The higher echelons got reported on the basis of exceptions on monetary values. Computerization also took place to process voluminous data and for timely submission of reports. In course of time, cost accounting assimilated techniques from various other disciplines like operations research, statistics, economics, behavioural science and techniques of management to aid decision making. The term cost accounting brings to mind only the function of cost finding and therefore, this large comprehensive discipline was renamed management accounting or managerial accounting. Recently, finance has also been brought under this umbrella.



*Caution* The term 'Management Accounting' refers to accounting for the management. Management accounting provides necessary information to assist the management in the creation of policy and in the day-to-day operations. It enables the management to discharge all its functions, i.e., planning, organization, staffing, direction and control efficiently with the help of accounting information.

## 1.2 Branches of Accounting and its Interrelationships

The main objectives of accounting are to record the business transactions and to provide the necessary information to the internal and external users of the financial statements. In order to achieve the above objectives, the accounting is classified into followings branches:

1. **Financial Accounting:** It is the original form of accounting. It refers to the recording of daily business financial transaction. Recording of the transaction is done in such a way that the profit of the business may be ascertained after a definite period and the picture of the financial position of the business may be presented.
2. **Cost Accounting:** As the name indicates, this accounting is related with the ascertainment of cost of the product in a period. Under this system, record of raw materials used in production, wages and labour paid and other expanses incurred on production are kept to control the costs.
3. **Management Accounting:** The accounting which provides the necessary information to the management is called management accounting. Under this, the analysis and interpretation of the accounts, prepared by financial accounting, are done in a manner so that the managers may forecast, plan for future and frame the policy.
4. **Tax Accounting:** Under tax accounting, the accountants prepare the accounts as per the provisions of taxation. The accounts prepared as per taxation provisions may differ from the accounts prepared as per financial accounting.
5. **Inflation Accounting:** The financial statements are prepared on the basis of historical cost which do not present the true picture of the financial position and correct profit or loss of the business due to inflation. Thus, the fresh financial statements are prepared keeping in mind the price level changes under inflation accounting.
6. **Human Resource Accounting:** Human Resource Accounting means the accounting for human being as now in an organization human being is treated as an asset like other physical assets. It is recorded in the books like other assets. HRA deals with the measurement of costs on recruiting, selecting, hiring, training, placing and development of the employees in one side and on the other side it deals with the present economic value of the employees. For the determination of the value of human being different methods are used under HRA.
7. **Responsibility Accounting:** Responsibility accounting is a special technique of management under which accountability is established according to the responsibility delegated to the various levels of management. A management information and reporting system is instituted to give adequate feedback in terms of the delegated responsibility. Under this system, units of an organization, under a specified authority in a person, are developed as responsibility center and evaluated individually for their performance.

### **Relationship of Financial, Cost and Management Accounting**

The ICMA, London, defines management accounting as “the application of professional knowledge and skill in the preparation and presentation of accounting information in such a way as to assist management in the formulation of various policies and in the planning and control of the operation of the undertaking”.

The American Accounting Association, committee on management accounting, defines management accounting as “the application of appropriate techniques and concepts in processing the historical and projected economic data of an entity to assist management in establishing a plan for reasonable economic objectives and in the making of rational decisions with a view towards achieving these objectives”.

**Notes**

Though some number of differences can be identified between cost accounting and management accounting, the line of difference is very thin. Because, cost accounting, at present, comprises of some of the advanced techniques and systems of costing such as budgetary control, marginal costing, standard costing, etc. and therefore, it tends to conform to management accounting. Consequently, not much difference can be found between the two. The main differences between cost accounting and management accounting are given as under:

The cost accounting is very closely-related to financial accounting. Few authorities of accounting consider cost accounting to be the branch of financial accounting. But it may be said that cost accounting is complementary to financial accounting. Financial accounting and cost accounting are both similar in various ways. The main relationship between financial accounting and cost accounting are given as under:

1. The fundamental principles of double entry system are applicable in financial accounting as well as cost accounting.
2. The results of business or organisation are revealed by both the systems of accounts.
3. The determination of future business activities and policy is guided by both accounting systems.
4. A basis for comparison of expenditures is being provided by both the accounting systems.
5. The invoices and vouchers constitute the common basis for recording transactions under both the systems of accounting.
6. The causes for losses and wastages of a business or industry are provided by financial and cost accounting.

The main differences between financial accounting and cost accounting are given as under:

### **1.3 Role of Management Accountants**

A management accountant is a very important key person in the organization. His main job in the organization is planning and control.

Planning is of two types. One is a short-term plan known as a budget. A budget is a quantitative expression of management's short-term intentions. Budget serves also as a tool for co-ordinating the various activities and to the extent the actuals compared to budget works as a tool of control.

The other type of planning is called long-term plan or corporate plan or strategic plan. This type of plan is usually prepared for three to five years. Long-term plans indicate the management's intent where the organization should reach in that time span. By a series of budgets, long-term plans are reached.

It is the responsibility of the management accountant to prepare both the type of plans and watch their actual performance. For this purpose, he has to re-classify the accounting data and assemble them to suit the user department's need. He also has to scan the environment for external information. He has to be particularly careful of the performance of his competitors and try and obtain information about their long-term strategy.

The management accountant should arrange for various reviews of the budget and corporate plan in order to take action on deviations. If the deviation or variances are seasonal he may not take steps to correct the plans; otherwise he should modify the plan in consultation with the top management.

The management accountant will undertake a number of special studies for capital expenditure; make or buy decisions, lease or buy decisions.

It will be the responsibility of the management accountant to establish a good system for the use of management, devise all paper work and prescribe the periodicity of reports and manner of submission.

We have already seen the management accountant's role as a purely staff function, in relation to other departments. In view of the great use of management accounting, the controller now attends all important policy meetings and participates. As one foreign publication has stated, "the management accountant participates as the part of management in assuring that the organization operates as a unified whole in its long-run, intermediate and short-run best interests."

We may sum up saying, 'the management accountant's role is that of purveyor, processor and presenter of information and also a planner for the achievement of corporate goals both short and long-run.'

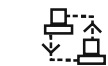

### Introduction

Financial statements are also known as financial reports. These are formal records of the financial activities of a business, person, or other entity. Since we are referring to the corporate financial statements, the corporate financial reports refer to the records of a corporate house.

Corporate financial statements provide an overview of a business's financial condition in both short-term and long-term. All the relevant financial information of a business enterprise, presented in a structured manner and in a form easy to understand, is thus called the financial statement. These statements comprise Balance Sheet or Position Statement and Profit and Loss Account or Income Statement. Of course, to give a full view of the financial affairs of an undertaking, in addition to the above, the business may also prepare a Statement of Retained Earnings and a Cash Flow Statement.



*Caution* In India, every company has to present its financial statements in the form and contents as prescribed under Section 211 of the Companies Act, 1956.

## 2.1 Types of Financial Statements

There are four different types of financial statements. The different types of financial statements indicate the different activities occurring in a particular business house.

1. Income Statement
2. Retained Earnings Statement
3. Balance Sheet
4. Statement of Cash Flows
5. Fund Flow Statement

Let us understand each of them one by one.

1. **Income Statement:** Income statement, also called profit and loss statement (P&L) and Statement of Operations, is a company's financial statement that indicates how the revenue (money received from the sale of products and services before expenses are taken out, also known as the "top line") is transformed into the net income (the result after all revenues and expenses have been accounted for, also known as the "bottom line"). The purpose of the income statement is to show managers and investors whether the company made or lost money during the period being reported. The important thing to remember about an income statement is that it represents a period of time.

2. **Retained Earnings Statement:** As the name suggests, a retained earnings statement explains the changes in a company’s retained earnings over the reporting period. It breaks down changes affecting the account, such as profits or losses from operations, dividends paid, and any other items charged or credited to retained earnings. A retained earnings statement is required by Generally Accepted Accounting Principles (GAAP) whenever comparative balance sheets and income statements are presented. It may appear in the balance sheet, in a combined income statement and changes in retained earnings statement, or as a separate schedule.



Example: Written below is a sample of a retained earnings statement.

3. **Balance Sheet:** The balance sheet provides an insight into the financial status of a company at a particular time. The balance sheet is different in comparison to the other types of financial statements. Other financial statements are prepared by taking into account the financial health of the company over a considerable span of time.

4. **Fund-flow Statement:** Fund Flow Statements can be understood as the summary of a firm’s changes in financial position from one period to another; it is also called a “sources and uses of funds statement” or a “statement of changes in financial position”. Simply put, it tells

investors where funds have come from and where funds have gone. The statements are often used to determine whether companies efficiently source and utilize funds available to them.



*Did u know?* **How to Prepare a Fund Flow Statement**

Fund flow statements are prepared by taking the balance sheets for two dates representing the coverage period. The increases and decreases must then be calculated for each item. Finally, the changes are classified under four categories: (1) Long-term sources, (2) long-term uses, (3) short-term sources, (4) short-term uses.

It is also important to zero out the non-fund based adjustments in order to capture only the changes that are accompanied by flow of funds. However, income accrued but received and expenses incurred but not received reckoned in the profit and loss statement should not be excluded from the profit figure for the fund flow statement.

Fund flow statements can be used to identify a variety of problems in the way a company operates. For example, companies that are using short-term money to finance long-term investments may run into liquidity problems in the future. Meanwhile, a company that is using long-term money to finance short-term investments may not be efficiently utilizing its capital.

The notes typically describe each item on the balance sheet, income statement and cash flow statement in further detail. Notes to financial statements are considered an integral part of the financial statements.

### 2.2 Form and Contents of Financial Statements

The following are some important forms and their contents of financial statements:

## 2.2.1 Trading and Profit & Loss Account

Notes

In the Trading and Profit & Loss Account all those accounts are disclosed which affect the profit or loss of the business. In other words, all the nominal accounts of the Trial Balance are used to prepare the Trading and Profit & Loss Account. In the left hand side, all the expenses incurred during a period and in the right hand side all the incomes earned during a period are disclosed.



*Did u know? What are the capital and revenue expenditure?*

The expenditure incurred for acquiring a fixed asset or which results in increasing the earning capacity of the business is known as Capital Expenditure. For example, acquisition of a fixed asset.

An expenditure incurred in the course of regular business transactions of a concern is availed during the same accounting year is known as Revenue Expenditure. For example, expenditure incurred on the purchase of raw materials.

This account contains two parts:

1. Trading Account
2. Profit & Loss Account

### Trading Account

This is first financial statement prepared by the owner of the enterprise to determine the gross profit during the year, through the matching concept of accounting. The gross profit of the enterprise is calculated through the comparison of purchase expenses, manufacturing expenses, and other direct expenses with the sales.

It is prepared normally for one year in accordance with accounting period concept, i.e. operating cycle of the enterprise, which should not exceed 15 months with reference to the Companies Act 1956. The proforma of Trading Account is given below:

**Profit & Loss Account**

It is a second statement of accounting in connection with the earlier to determine the net profit/loss of the enterprise out of the early found gross profit/loss. This is an accounting statement which matches the administrative, selling and distribution expenses with the gross profit and other incomes of the enterprise.

This is an account prepared for one operating cycle of the firm, i.e. 12 months in period. The transactions are recorded in accordance with golden rules of nominal account. In the profit & loss account, the expenses and losses are debited and incomes and gains are credited. The reason for bringing down the gross loss/gross profit of the trading account into the debit and credit side of Profit & Loss A/c respectively, are only to the tune of nominal accounting ruling with reference to debit all expenses and losses, and credit all incomes and gains.

The expenses that are matched with the credit total of the profit and loss account classified into various categories:

1. Administrative Expenses
2. Selling & Distribution Expenses
3. Financial Expenses
4. Legal Expense.

- Net profit is the resultant of excess of income in the credit side over the expenses in the debit side of the Profit and Loss account.
- Net Loss is an outcome of excess of expenses in the debit side over the incomes in the credit side.

## 2.2.2 Balance Sheet

Notes

After the determination of the net profit of the business through the Trading and Profit and Loss Account, the businessman wants to know the financial position of the business. For this purpose he prepares a statement which is called the Balance Sheet. The Balance Sheet depicts the financial position of the business on a fixed date. A Balance Sheet is prepared with those balances of Trial Balance which are left out (personal and real accounts) after taking out the nominal accounts' balances to prepare the Trading and Profit and Loss Account. A Balance Sheet has two sides – assets side and liabilities side. The assets and liabilities are shown in a particular order.

### Marshalling of Assets and Liabilities

Order of presenting the assets and liabilities in the balance sheet is called marshalling of assets and liabilities. A balance sheet may be prepared by marshalling the assets and liabilities in the following orders:

#### *Balance Sheet prepared in Liquidity Order*

Here liquidity means conversion of assets into cash. When a Balance Sheet is prepared on the basis of liquidity order, more easily convertible assets into cash are shown first and those assets which can not be easily converted into cash are shown later and so on. In the case of liabilities, first those liabilities are shown which are payable earlier and then those liabilities are shown which are payable later. The proforma of such a Balance Sheet is given below:

**2.3 Uses of Financial Statements**

The uses of financial statements vary from entity to entity. For different people, they have different uses. Though no complete list can be provided for their uses, presented under is a brief list of benefits they give to their users:

1. **For Equity Investors and Lenders:** The existing equity investors and lenders to a company need to monitor their investments and to evaluate the performance of management. For this purpose, they have no aid else than the financial statements of a firm.  
  
The prospective equity investors and lenders use financial statements to decide whether or not to invest in an organisation.
2. **For Finance Specialists:** Investment analysts, money managers, and stockbrokers, use financial statements to make buy/sell/hold recommendations to their clients.
3. **For Credit Rating Agencies:** Rating Agencies such as Moody's and Standard & Poor's assign credit ratings on the basis of the financial statements of a company.

4. **For Customers and Suppliers:** Major customers of and suppliers to an organization evaluate the financial strength and staying power of the company as a dependable resource for their business. For this purpose, the best possible aids are those of the financial statements of the organization.
5. **For Labor Unions:** Labor unions use financial statements of a company to gauge how much of a pay increase a company is able to afford in upcoming labor negotiations.
6. **For the Board of Directors:** Board of directors of an organization uses its financial statements to review the performance of management in general and company in particular.
7. **For Managers:** Managers, too, are interested in measuring the operating performance in terms of profitability and return on invested capital. If they are not owners, managers must still satisfy the owners' expectations in this regard. As managers, they are interested in measures of operating efficiency, asset turnover, and liquidity or solvency. These will help them manage day-to-day activities and evaluate potential credit customers and key suppliers.
8. **For Competitors:** Existing Competitors of an organization use its financial statements to benchmark their own financial results.  
  
Potential competitors of an organization use its financial statements to assess how profitable it may be to enter the industry.
9. **For Government Agencies:** The financial statements of a company are very useful for the government agencies responsible for taxing, regulating, or investigating the company.
10. **For Associated Personnel:** The financial statements of a company are also useful for politicians, lobbyists, issue groups, consumer advocates, environmentalists, think tanks, foundations, media reporters, and others who are supporting or opposing any particular public issue the company's actions affect.
11. **For Partners:** The financial statements of a company are used by actual or potential joint venture partners, franchisors or franchisees, and other business interests who need to know about the company and its financial situation.

## 2.4 Limitations of Financial Statements

Some of the limitations of the financial statements are as follows:

1. As the historical costs and money measurement concepts govern the preparation of the balance sheet and income statements, hence these financial statements are essentially statements reflecting historical facts. It ignore inflationary trend and does not reflect the true current worth of the enterprise,
2. Certain important qualitative elements are omitted from the financial statements because they are incapable of being measured in monetary terms like the quality and reputation of the management team, employee and other,

3. There are items in the assets side of the balance sheet which has no real value and are merely deferred charges to future incomes like preliminary/pre-incorporation expenses and other,
4. There are still the following issues or challenges in preparing the financial statements which may amount to overstatement of the accounting profit of an entity:
  - (a) When to and how much to recognize revenue in the Income statement.
  - (b) The constant challenge of when to expense or to capitalize the expenses. It is important to determine definitely what is revenue expenditure and capital expenditure otherwise the accounting profit will be overstated or understated. For example, Capitalization of borrowing costs, etc.
  - (c) Method of depreciations and the rates to depreciate into the income statement are selected by management to suit their business needs. Are the rates intentionally been made lower or the depreciation rates are higher to accelerate the depreciation of the fixed assets,
  - (d) Adequacy of provisions and method of providing for doubtful debts. Are the trade debtors recoverable and to what extent the accounting method for provision for doubtful debts shows the realistic picture.
  - (e) Basis of valuation of assets-when can costs change to reflect current values? Using replacement or current costs?
  - (f) Consolidation challenges-what to eliminates to reflects the overall group performance. Some items might be omitted to show a higher accounting profits.

### Introduction

Financial statement analysis is the process of examining relationships among financial statement elements and making comparisons with relevant information. It is a valuable tool used by investors and creditors, financial analysts, and others in their decision-making processes related to stocks, bonds, and other financial instruments. The goal in analyzing financial statements is to assess past performance and current financial position and to make predictions about the future performance of a company. Investors who buy stock are primarily interested in a company's profitability and their prospects for earning a return on their investment by receiving dividends and/or increasing the market value of their stock holdings. Creditors and investors who buy debt securities, such as bonds, are more interested in liquidity and solvency: the company's short- and long-run ability to pay its debts. Financial analysts, who frequently specialize in following certain industries, routinely assess the profitability, liquidity, and solvency of companies in order to make recommendations about the purchase or sale of securities, such as stocks and bonds.

### 3.1 Meaning and Concept of Financial Statement Analysis

Analysts can obtain useful information by comparing a company's most recent financial statements with its results in previous years and with the results of other companies in the same industry. Three primary types of financial statement analysis are commonly known as horizontal analysis, vertical analysis, and ratio analysis.

#### **Horizontal Analysis**

When an analyst compares financial information for two or more years for a single company, the process is referred to as horizontal analysis, since the analyst is reading across the page to compare any single line item, such as sales revenues.

#### **Vertical Analysis**

When using vertical analysis, the analyst calculates each item on a single financial statement as a percentage of a total. The term vertical analysis applies because each year's figures are listed vertically on a financial statement. The total used by the analyst on the income statement is net sales revenue, while on the balance sheet it is total assets.

#### **Ratio Analysis**

Ratio analysis enables the analyst to compare items on a single financial statement or to examine the relationships between items on two financial statements. After calculating ratios for each year's financial data, the analyst can then examine trends for the company across years. Since ratios adjust for size, using this analytical tool facilitates inter-company as well as intra-company comparisons.

### 3.2 Tools for Analysis and Interpretation of Financial Statement

Notes

In assessing the significance of various financial data, experts engage in ratio analyses, the process of determining and evaluating financial ratios. A financial ratio is a relationship that indicates something about a company's activities, such as the ratio between the company's current assets, current liabilities or between its accounts receivable and its annual sales. The basic sources for these ratios are the company's financial statements that contain figures on assets, liabilities, profits, or losses. Financial ratios are only meaningful when compared with other information. Since they are most often compared with industry data, ratios help an individual understand a company's performance relative to that of competitors; they are often used to trace performance over time.

Ratio analysis can reveal much about a company and its operations. However, there are several points to keep in mind about ratios. First, financial statement ratios are "flags" indicating areas of strength or weakness. One or even several ratios might be misleading, but when combined with other knowledge of a company's management and economic circumstances, ratio analysis can tell much about a corporation. Second, there is no single correct value for a ratio. The observation that the value of a particular ratio is too high, too low, or just right depends on the perspective of the analyst and on the company's competitive strategy. Third, a ratio is meaningful only when it is compared with some standard, such as an industry trend, ratio trend, a ratio trend for the specific company being analyzed, or a stated management objective.

In trend analysis, financial ratios are compared over time, typically years. Year-to-year comparisons can highlight trends, pointing to the need for action. Trend analysis works best with five years of data.

The second type of ratio analysis, cross-sectional analysis, compares the ratios of two or more companies in similar lines of business. One of the most popular forms of cross-sectional analysis compares a company's financial ratios to industry ratio averages.

Your report containing the analysis of the financial statements is broken down into the various ratio categories:

1. Predictor Ratios indicate the potential for growth or failure.
2. Profitability Ratios which use margin analysis and show the return on sales and capital employed.
3. Asset Management Ratios which use turnover measures to show how efficient a company is in its operations and use of assets.
4. Liquidity Ratios which give a picture of a company's short-term financial situation or solvency.
5. Debt Management Ratios which show the extent that debt is used in a company's capital structure.

**3.3 Common-size Statements**

A company financial statement that displays all items as percentages of a common base figure is known as common size financial statement. This type of financial statement allows for easy analysis between companies or between time periods of a company.

The values on the common size statement are expressed as percentages of a statement component such as revenue. While most firms don't report their statements in common size, it is beneficial to compute if you want to analyze two or more companies of differing size against each other.

Formatting financial statements in this way reduces the bias that can occur when analyzing companies of differing sizes. It also allows for the analysis of a company over various time periods, revealing,



*Example:* What percentage of sales is cost of goods sold and how that value has changed over time.

Common size financial statements put all numbers in context, since the act of producing them involves calculating a ratio for each number on the statements. Without common sizing the statements, it is difficult to attach meaning to the numbers or to pick up trends. That is why common size financial statements are used for financial analysis instead of the actual statements themselves.



**Caution** For Balance sheet, total volume of assets and liabilities are taken into consideration for the computation of a share of each financial factor available under the heading of assets and liabilities.

### 3.4 Comparative Statements

Comparative statements are the financial statements which follow a consistent format but which cover different periods of time. Comparative statements are very useful for spotting trends.

#### Objectives of Comparative Financial Statements

- Changes taken place in the financial performance are taken into consideration for further analysis.
- To reveal qualitative information about the firm in terms of solvency, liquidity profitability and so on are extracted from the analysis of financial statements.
- With reference to yester financial data of the enterprise, the firm is facilitated to undergo for the preparation of forecasting and planning.

The major part of financial statement analysis is mainly focused on the comparative analysis.

#### 3.4.1 Comparative Balance Sheet

The first and foremost important step is to have the following information and should take preparatory steps:

- While preparing the comparative statement of balance sheet, the particulars for the financial factors are required.
- The second most important for the preparation of the comparative balance sheet is yester financial data extracted from the balance sheet or balance sheets.
- The next most important requirement to have an effective comparison with the yester financial data is current year information extracted from the balance sheet or balance sheet of the firms.

### 3.4.2 Comparative (Income) Financial Statement Analysis

This analysis is being carried out in between the income statements of the various accounting durations of the firm, with other firms in the industry and with the industrial average.

This will facilitate the firm to know about the stature of itself regarding the financial performance. It facilitates to understand about the changes pertaining to various financial data which closely relevantly connected with the financial performance:

1. Change in the gross sales
2. Change in the net sales
3. Change in gross profit and net profit
4. Change in operating profit
5. Change in operating expenses
6. Change in the volume of non-operating income
7. Change in the non operating expenses.

The ultimate purpose of the comparative (income) financial statement analysis is as follows:

1. To study the income earning and expenditure spending pattern of the firm for two or more years.
2. To identify the changing pattern of the income and expenditure of the firms.
3. The preparatory steps for the preparation of the comparative financial statement (income) analysis

The first and foremost important step is to have the following information and should take preparatory steps

1. While preparing the comparative statement of Profit & Loss Account, the particulars for the financial factors are required.
2. The second most important for the preparation of the comparative Profit & Loss account is yester financial data extracted from the Profit and Loss A/c or Profit and Loss Accounts.
3. The next most important requirement to have an effective comparison with the yester financial data is current year information extracted from the balance sheet of the firm or of the other firms.
4. After having been procured the financial data pertaining to various time periods are ready for comparison; to determine or identify the level of increase or decrease taken place in the operating financial performance of the firms.
5. To determine the level of increase or decrease in financial performance, the percentage analysis to be carried out in between them.

### 3.5 Trend Analysis

The next important tool of analysis is trend percentage which plays significant role in analyzing the financial stature of the enterprise through base years' performance ratio computation. This not only reveals the trend movement of the financial performance of the enterprise but also highlights the strengths and weaknesses of the enterprise.

The following ratio is being used to compute the trend percentage

$$= \frac{\text{Current year}}{\text{Base year}} \times 100$$

This trend ratio is being computed for every component for many numbers of years which not only facilitates comparison but also guides the firm to understand the trend path of the firm.

In the analysis of financial information, trend analysis is the presentation of amounts as a percentage of a base year.



*Example:* If I want to see the trend of a company's revenues, net income, and number of clients during the years 2001 through 2007, trend analysis will present 2001 as the base year and the 2001 amounts will be restated to be 100. The amounts for the years 2002 through 2007 will be presented as the percentages of the 2001 amounts.

In other words, each year's amounts will be divided by the 2001 amounts and the resulting percentage will be presented. If revenues for the years 2001 through 2007 might have been ₹ 31,691,000; ₹ 40,930,000; ₹ 50,704,000; ₹ 63,891,000; ₹ 79,341,000; ₹ 101,154,000; ₹ 120,200,000. These revenue amounts will be restated to be 100, 129, 160, 202, 250, 319, and 379.

From this trend analysis we can see that revenues in 2007 were 379% of the 2001 revenues, net income in 2007 was 467% of the 2001 net income, and the number of clients in 2007 was 317% of the number in 2001.

Let's assume that the net income amounts divided by the 2001 amount ended up as 100, 147, 206, 253, 343, 467, and 423. The number of clients when divided by the base year amount are 100, 122, 149, 184, 229, 277, and 317.

**Solution:** We have to remember that the base year trend percentage is always 100.0%. A trend percentage of less than 100.0% means the balance has decreased below the base year level in that particular year. A trend percentage greater than 100.0% means the balance in that year has increased over the base year. A negative trend percentage represents a negative number.

Also, if the base year is zero or negative, the trend percentage calculated will not be meaningful.

In this example, the sales have increased 59.3% over the five-year period while the cost of goods sold has increased only 55.9% and the operating expenses have increased only 57.5%. The trends look different if evaluated after four years. At the end of 2008, the sales had increased almost 20%, but the cost of goods sold had increased 31%, and the operating expenses had increased almost 41%. These 2008 trend percentages reflect an unfavorable impact on net income because costs increased at a faster rate than sales. On an overall basis, the trend percentages for net income appear to be higher because the base year amount is much smaller than the other balances.

Using the restated amounts from trend analysis makes it much easier to see how effective and efficient the company has been during the recent years. Trends may be categorized as:

1. Short-term trends capture rapidly emerging trends.
2. Mid-term trends capture trends developing in between.
3. Long-term trends capture trends developing over long periods.

Trend analysis is also advantageous for (short-term) sales forecasting, growth rates, growth percentages, trend significance, trending types, and so on. Use of trend analysis includes:

1. Sales trend analysis – revenue and volume analysis.
2. Product sales trend analysis.
3. Market trend analysis.
4. Equity (share) price trend analysis.
5. Accounting trend analysis.
6. Work force recruit forecasting.
7. Healthcare fraud detection and so on.

Timely identification of newly emerging trends is very important to businesses. Trend analysis can also include the monitoring of a company’s financial ratios over a period of many years.

*Case Study*

### **Evaluation of Ford on the basis of Accounting Trends**

The success of Ford Motor Company, as well as other corporations, can be measured by analyzing the two most important goals of management, maintaining adequate liquidity and achieving satisfactory profitability. Liquidity can be defined as having enough money on hand to pay bills when they are due and to take care of unexpected needs for cash, while profitability refers to the ability of business to earn a satisfactory income. To enable investors and creditors to analyze these goals, Ford Motor Company distributes annual financial statements. With these financial statements, liquidity of Ford Motor Company is measured by analyzing factors such as working capital, current ratio, quick ratio, receivable turnover, average days' sales uncollected, inventory turnover and average days' inventory on hand; whereas profitability analyzes the profit margin, asset turnover, return on assets, debt to equity, and return on equity factors.

#### **Liquidity**

##### ***Working Capital***

Ford Motor Company's working capital fluctuated significantly in the years 1991-1995. This phenomenon is directly attributable to the fact that Financial Services current assets and current liabilities are not included in the total company current asset and current liability accounts. For example, the fluctuation from 1994 (\$1.4 billion) to 1995 (-\$1.5 billion) of \$2.5 billion would suggest that Ford would be unable to pay liabilities during the current period. However, examination of the Financial Services side of the business reveals that surpluses of \$13.6 billion existed in both 1994 and 1995, convincingly mitigating the figures indicating negative working capital.

##### ***Current Ratio & Quick Ratio***

The current ratio in the years 1991-1995 has remained stable, fluctuating between 0.9 and 1.1. The quick ratio has also remained stable, fluctuating between 0.5 and 0.6. The larger fluctuation in the current ratio versus the quick ratio is caused by inventories being included in the asset side of the equation. Although inventories were significantly higher in both 1994 and 1995, current liabilities were also higher. In addition, marketable securities decreased substantially in 1994 and 1995. These factors resulted in the stability of both the current ratio and quick ratio.

##### ***Receivable Turnover & Average Days' Sales Uncollected***

An examination of trends in Ford Motor Company's receivable turnover and average days' sales uncollected ratios reveal positive indicators of Ford's liquidity position. The receivable turnover, a function of net sales and average accounts receivable, has nearly doubled in the years 1993-1995 versus 1991-1992. This trend indicates an extensive increase of net sales in relation to accounts receivable. Receivables were relatively higher in 1994 than in any other of the five years, affecting the ratio for both 1994 and 1995. However, net sales increased 30% in 1994 and 34% in 1995 over the average net sales of 1991-1993. The average days' sales uncollected ratio has decreased significantly over the same period, from 16.9 days in

Notes

1991 to 9.7 days in 1995. The substantial decrease in average days' sales uncollected ratio coupled with the near doubling of the receivable turnover ratio is a reflection of Ford's strong sales and effective credit policies in years 1993-1995.

**Inventory Turnover & Average Days' Inventory on Hand**

An examination of trends in the inventory turnover and average days' inventory on hand ratios also reveal positive indicators of Ford's liquidity position. Inventory turnover, a function of cost of goods sold and inventories, has remained stable between 14.0 and 16.0 times from 1992-1995. The average ratio over these four years (15.1 times) is 40% higher than that of 1991. The average days' inventory on hand, a derivative of the inventory turnover, has conversely decreased to stable level fluctuating between 23.5 and 26.0 days in the years 1992-1995. The operating cycle of Ford Motor Company has decreased significantly as the table below indicates.

**Profitability**

**Profit Margin**

Profit margin, which is net income divided by net sales, is a measure of how many dollars of net income is produced by each dollar of sales. Ford Motor Company had a substantial 4 year rise in profit margin. Using horizontal analysis, the profit margin increased 98% from 1991 to 1992, 566% from 1992 to 1993 and then 79% from 1993 to 1994. Although the profit margin from 1994 to 1995 decreased 26%, that is more than acceptable when you look at the substantial increases in the past few years. In the first year, Ford had a profit margin of -3.1%. That means for every dollar of sales, Ford lost \$3.10. This is obviously not a good position to be in. During 1991 and then carried over into 1992, it cost Ford more money to make sales than it did when it recorded the income for those sales. They realized at this time it was important for them to keep things such as selling and administrative expenses lower, as well as the cost of sales, which included their production, manufacturing, and warehousing costs. By following a plan more complex than I can describe here, Ford steadily increased it's sales while it lowered it's expenses and it's cost of sales. This directly increased Ford's profit margin at a substantial rate within the next three years.

**Asset Turnover**

Asset turnover involves Ford's net sales divided by their average total assets. This ratio demonstrates the efficiency of assets used in producing sales. A company like Ford Motor Company has an enormous amount of assets. Computers to heavy equipment to buildings. All of those assets, plus many more, are all taken into consideration when figuring asset turnover. For example, Ford would like to know that if it decides to purchase 20 new computer-aided engineering stations for a cost of about \$2,400,000, they would like to see a higher asset turnover to give them the proof that the investment is being used at maximum efficiency. Ford's asset turnover steadily increased in incremental amounts between the years of 1991-1995, but on average it was about .43 for the entire 5 year period. Using trend analysis to understand this ratio would give you a pretty good idea that the asset turnover of Ford Motor Company is stable. Trend analysis would give you an index number for 1992 of 100, while the index number for 1995 would be 112. These index numbers would result in a slightly positive but relatively straight line across the page. As a prospective investor this would probably cause you to investigate more deeply as to why Ford can't more efficiently use their assets to produce sales. As a current stockholder, this trend over the past five years may give you some comfort because of the incremental increases (at least it isn't going down).

**Return on Assets**

Return on assets is a very good profitability ratio. It is comprehensive when compared to profit margin and asset turnover. Return on assets overcomes the deficiency of profit margin by relating the assets necessary to produce income and it overcomes the deficiency of asset turnover by taking into account the amount of income produced. Mathematically, return on assets is equal to net income divided by average total assets, or more simply put, profit margin times asset turnover. Ford can improve its overall profitability by increasing its profit margin, the asset turnover, or both. Looking at the numbers, it was actually Ford's increase in profit margin that really gave it the boost it needed to raise the return on assets from the black to the red. A steady increase in return on assets from -1.3% in 1991 to an acceptable 2.2% in 1994 is a good sign to investors. This steady climb of 169% resulted in an overall increase in the earning power of Ford Motor Company. Ford's increase in profitability shows satisfactory earning power which results in investors continuing to provide capital to it.

**Debt to Equity**

The debt to equity ratio shows the portion of the company financed by creditors in comparison to that financed by the stockholders. It is total liabilities divided by stockholder's equity. Ford's debt to equity ratio is relatively high. When measuring profitability, a high debt to equity ratio means the company has high debt and must earn more profit to protect the payment of interest to its creditors. This high debt to equity ratio would also interest stockholders because it shows what part of the business is financed through borrowing or in other words, is debt financed. Of the five years we analyzed, the lowest debt to equity ratio was during 1991 (6.65) and the highest was in 1993 (11.71). In comparison to return on assets, a higher creditor financed year such as 1991 did not have a positive effect on profitability. It seemed that through increased borrowing in 1993, a higher debt to equity ratio was produced, but overall profitability also went up. Debt to equity is only one part in a full profitability analysis. The only real information that the debt to equity ratio can produce is it can show how much expansion is possible through the borrowing of long-term funds; basically it shows a company's long-term solvency. A higher debt to equity ratio essentially means that the company will be able to borrow less money. The company must rely more on stockholder investment. Ford was able to lower its borrowing of funds from 1993 through 1994 and into 1995, while still effectively increasing its profit margin and return on assets. This means Ford was able to use stockholder's investments to increase its profitability rather than borrow the funds to do it.

**Return on Equity**

Return on equity is the ratio of net income divided by the average stockholder's equity. This ratio is of great interest to stockholders because it shows how much they have earned on their investment in the business. In the years of 1991 and 1992, stockholders lost money on their investment in Ford Motor Company. No one likes to lose money, even if it is a couple of cents on the dollar. A major stockholder could incur quite a loss because of this. In the next three years, return on equity was on the positive side, the peak being in 1994 when stockholders earned about 28% on every dollar invested. Quite a good return considering some investors are happy with a steady 8% return. Considering the previous years, the return on equity for Ford seems to be positive. Common knowledge dictates that most companies experience a downturn every now and then. Ford's investors are able to remain invested in the company because its overall 5 year return on equity is high enough to give investors the high returns they seek. A return on equity consistently above 16% with a few negative years mixed in is certainly lucrative enough to maintain a strong profitability measurement and project a positive image to the investors of Ford Motor Company.

**Conclusion**

Although Ford Motor Company is one of the largest companies in the world, we can still attribute accounting trends to some of the key events in Ford's history. In 1990, Ford acquired Jaguar Cars, Ltd. Jaguar was a company suffering terrible losses due to poor quality, and lack of sales. Jaguar has been in the black since Ford purchased them until 1994. It is important to note that Ford's net income trend from 1991 to 1995 illustrates this. In 1992, the Ford Taurus became the number one selling car in the United States, which helped increase 1992 net earnings, and in 1994 the Ford Falcon was the top selling car in Australia, helping maintain the trend of increasing net income. It is important to note that Ford's net income has increased from 1991 to 1994, and then decreased in 1995. There are several possible causes for this change in the trend. In 1995, Ford acquired 20% equity in a major Chinese truck manufacturer, and launched several new vehicles; including the Ford Contour, Ford Mondeo, Mercury Mystique, Ford F-150, and Ford Taurus. These additional investments and expenses help explain the decrease in net income in 1995. Overall, the company has done well, and with reorganization in 1996 to decrease spending and increase efficiency, Ford is striving for future periods of growth.

### **3.6 Summary**

- Financial statement analysis can be explained as a method used by interested parties such as investors, creditors, and management to evaluate the past, current, and projected conditions and performance of the firm.
- Under the financial statement analysis, the information available are grouped together in order to cull out the meaningful relationship which is already available among them; for interpretation and analysis.
- Three primary types of financial statement analysis are commonly known as horizontal analysis, vertical analysis, and ratio analysis.

## Introduction

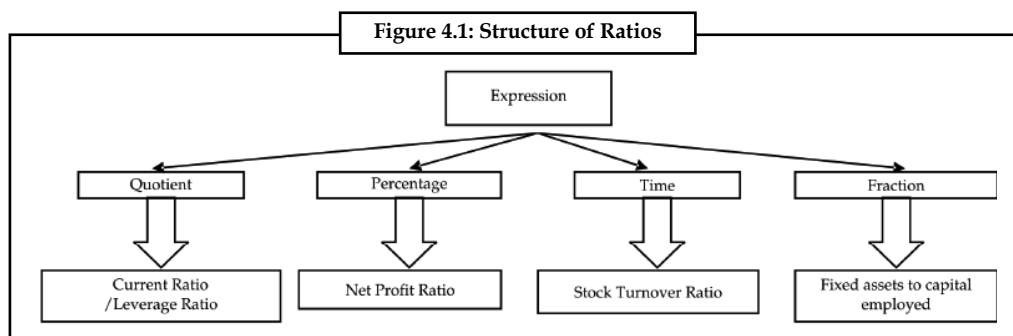
The ratio analysis is one of the important tools of financial statement analysis to study the financial stature of the business fleeces, corporate houses and so on.

According to J. Batty, "The term accounting ratio is used to describe significant relationships which exist between figures shown in a balance sheet, in a profit and loss account, in a budgetary control system or in any other part of the accounting organization".

Financial statements contain substantial information (figures) relating to profit or loss and financial position of the business. If these items in financial statements are considered independently it may or may not be of much use. To make a meaningful reading of financial statements, these items found in financial statements have to be compared with one another. Ratio analysis, as a technique or analysis of financial statement uses this method of comparing the various items found in financial statements.

### 4.1 Definition

According to J. Betty, "The term accounting is used to describe relationships significantly which exist in between figures shown in a balance sheet, Profit & Loss A/c, Trading A/c, Budgetary control system or in any part of the accounting organization."



According to Myers "Study of relationship among the various financial factors of the enterprise".



*Did u know? What is meant by the accounting ratio?*

The accounting ratios are computed on the basis available accounting information extracted from the financial statements which are not in a position to reveal the status of the enterprise.

The accounting ratios are applied to study the relationship in between the quantitative information available and to take decision on the financial performance of the firm.

**Notes**

To understand the methodology of expressing the ratios, various expressions of ratios are highlighted in the Figure 4.1.



*Notes* Purposes of the Ratio Analysis:

1. To study the short-term solvency of the firm – liquidity of the firm
2. To study the long-term solvency of the firm – leverage position of the firm
3. To interpret the profitability of the firm – Profit earning capacity of the firm
4. To identify the operating efficiency of the firm – turnover of the ratios

## **4.2 Classification of Ratios**

The accounting ratios are classified into various categories, viz.:

1. On the basis of financial statements
2. On the basis of functions

### **4.2.1 On the basis of Financial Statements**

1. **Income Statement Ratios:** These ratios are computed from the statements of Trading, Profit & Loss account of the enterprise. Some of the major ratios are as following GP ratio, NP ratio, Expenses Ratio and so on.
2. **Balance Sheet or Positional Statement Ratios:** These types of ratios are calculated from the balance sheet of the enterprise which normally reveals the financial status of the position i.e. short-term, long-term financial position, share of the owners on the total assets of the enterprise and so on.
3. **Inter Statement or Composite Mixture of Ratios:** These ratios are calculated by extracting the accounting information from the both financial statements, in order to identify stock turnover ratio, debtor turnover ratio, return on capital employed and so on.

### **4.2.2 On the basis of Functions**

1. **On the basis of solvency position of the firms:** Short-term and long-term solvency position of the firms.
2. **On the basis of profitability of the firms:** The profitability of the firms are studied on the basis of the total capital employed, total asset employed and so on.
3. **On the basis of effectiveness of the firms:** The effectiveness is studied through the turnover ratios – Stock turnover ratio, Debtor turnover ratio and so on.
4. **Capital structure ratios:** The capital structure position are analysed through leverage ratios as well as coverage ratios.

### 4.3 Liquidity Ratios

To study the short-term solvency or liquidity of the firm, the following are various ratios:

1. Current Assets Ratio
2. Acid Test Ratio or Quick Assets Ratio
3. Super Quick Assets Ratio

#### 4.3.1 Current Assets Ratio

It is one of the important accounting ratios to find out the ability of the business fleeces to meet out the short financial commitment. This is the ratio establishes the relationship in between the current assets and current liabilities.



*Did u know? What is meant by current assets and current liabilities?*

Current assets are nothing but available in the form of cash, equivalent to cash or easily convertible in to cash.

Current liabilities are nothing but short-term financial resources or payable in short span of time within a year.

$$\text{Current Ratio} = \frac{\text{Current Assets}}{\text{Current Liabilities}}$$



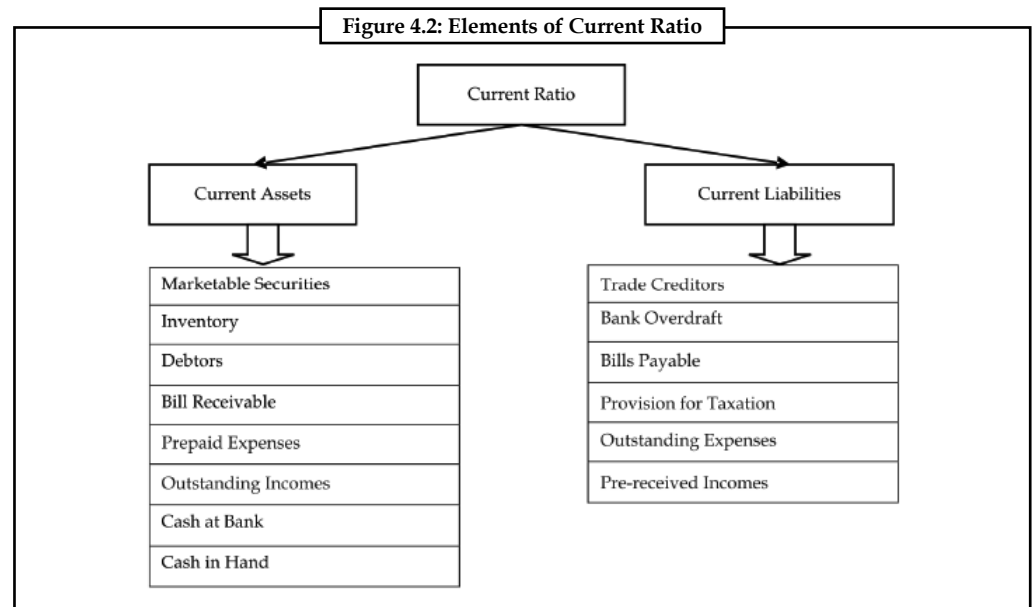
*Example:* Company XYZ has current assets worth of ₹ 5 lac, while the liabilities amount to ₹ 3 lac. What is the current ratio of the firm?

**Solution:**

$$\text{Current Ratio} = \frac{\text{Current Assets}}{\text{Current Liabilities}}$$

$$\text{Current Ratio} = 5/3 = 1.666 \text{ (approx)}$$

Notes



*Caution* Standard norm of the current ratio:

The ideal norm is 2:1; which means that every one rupee of current liability is appropriately covered by two rupees of current assets.

High ratio leads to greater the volume of current assets more than the specified norm denotes that the firm possesses excessive current assets than the requirement portrays idle funds invested in the current assets.

A big limitation of current ratio is that under this ratio, the current assets are equally weighed against each other to match the current liabilities. One rupee of cash is equally weighed at par with the one rupee of closing stock, but the closing stock and prepaid expenses cannot be immediately realized like cash and marketable securities.

### 4.3.2 Acid Test Ratio

It is a ratio expresses the relationship in between the quick assets and current liabilities. This ratio is to replace the bottleneck associated with the current ratio. It considers only the liquid assets which can be easily translated into cash to meet out the financial commitments.

$$\text{Acid Test Ratio (Quick Assets Ratio)} = \frac{\text{Liquid Assets}}{\text{Current Liabilities}}$$

$$\text{Liquid Asset} = \text{Current Assets} - (\text{Closing Stock} + \text{Prepaid Expenses})$$



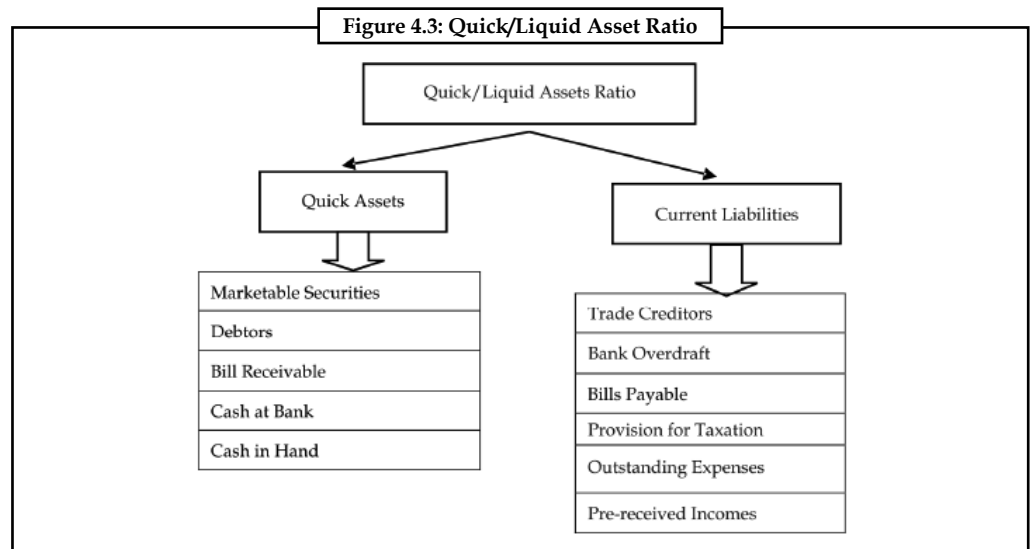
*Example:* A company has a closing stock of ₹ 30,000 while its prepaid expenses are ₹ 5000. What will be its quick assets ratio if the current assets are worth ₹ 50000 while current liabilities are worth ₹ 15000?

**Solution:**

$$\begin{aligned} \text{Liquid Asset} &= \text{Current Assets} - (\text{Closing Stock} + \text{Prepaid Expenses}) \\ &= 50000 - (30000 + 5000) \\ &= 15000 \end{aligned}$$

$$\begin{aligned} \text{Quick Assets Ratio} &= \frac{\text{Liquid Assets}}{\text{Current Liabilities}} \\ &= 15000/15000 = 1:1 \end{aligned}$$

Notes



**Caution** Standard norm of the ratio:

The ideal norm is 1:1 which means that one rupee of current liabilities is matched with one rupee of quick assets.

### 4.3.3 Super Quick Assets Ratio

It is the ratio which establishes the relationship in between the super quick assets and quick liabilities of the firm.

The super quick assets are nothing but the current assets which can be more easily converted into cash to meet out the quick liabilities.

The super quick liabilities are the current liabilities should have to be met out at faster pace within shorter span in duration.

$$\text{Super Quick Assets} = \text{Cash} + \text{Marketable Securities}$$

$$\text{Super Quick Liabilities} = \text{Current Liabilities} - \text{Bank Overdraft}$$

$$\text{Super Quick Assets Ratio} = \frac{\text{Super Quick Assets}}{\text{Super Quick Liabilities}}$$



**Caution** Standard norm of the ratio:

Higher the ratio, better is the position of the firm.

Calculate the current assets ratio and liquid assets ratio.

For the computation of current assets ratio, the current assets volume must be known. It is not available in our problem; instead the liquid assets and prepaid expenses are given together which will help to find the total volume of current assets.

$$\begin{aligned} \text{Current Assets} &= \text{Liquid Asset} + \text{Prepaid expenses} + \text{Closing stock} \\ &= ₹65,000 + ₹5,000 + 20,000 \\ &= ₹90,000 \end{aligned}$$

The next step is to find out the current liabilities. The volume of current liabilities could be found out through the available information of working capital.

$$\text{Net working capital} = \text{Current Assets} - \text{Current Liabilities}$$

$$₹60,000 = ₹90,000 - \text{Current liabilities}$$

$$\text{Current liabilities} = ₹90,000 - ₹60,000 = ₹30,000$$

From the above, the current ratio could be found out.

$$\text{Current Ratio} = \frac{₹90,000}{₹30,000} = 3 > 2$$

The firm satisfies more than the norm of the current ratio. It means that the firm keeps excessive current assets more than that of requirement.

$$\text{Quick Assets Ratio} = \frac{₹65,000}{₹30,000} = 2.17$$

The firm keeps more liquid assets than that of the specified norm, meaning that excessive liquid assets are held by the firm than the requirement in the form of idle assets not productive in utility.

2. The current ratio of Bicon Ltd. is 4.5:1 and liquidity ratio is 3:1; stock is ₹6,00,000. Find out the current liabilities.

To find out the volume of current liabilities, initially the share of closing stock should be found out in the total of current assets.

$$\begin{aligned} \text{Share of stock} &= \text{Current Assets Ratio} - \text{Liquid Assets Ratio} \\ &= 4.5 - 3.0 = 1.5 \end{aligned}$$

$$\text{Share of the stock} = 1.5$$

If the share of the stock is 1.5, which amounted to ₹6,00,000.

$$\text{Current liabilities} = \frac{\text{₹6,00,000}}{1.5} = \text{₹4,00,000}$$

**4.4 Solvency Ratios**

Solvency ratios indicates company’s ability to meet its long-term liabilities. Therefore, these ratios are also called long-term solvency ratios. The long-term liability of a company comprises of debentures, long-term loans, unpaid installment on hire-purchase, and long-term creditors. The long-term creditors take interest in those ratios which highlight the long-term financial position of the company so that they may ensure regarding the repayment of their principal amount on maturity as well as regular interest on their dues. For this purpose the following solvency ratio are calculated:

**4.4.1 Debt-equity Ratio**

It is the ratio expresses the relationship between the ownership funds and the outsiders’ funds. It is more specifically highlighted that an expression of relationship in between the debt and shareholders’ funds. The debt-equity ratio can be obviously understood into two different forms:

1. Long-term debt-equity ratio
2. Total debt-equity ratio

Let us understand each of them one by one.

**Long-term Debt-equity Ratio**

It is a ratio expressing the relationship in between the outsiders’ contribution through debt financial resource and shareholders’ contribution through equity share capital, preference share capital and past accumulated profits. It reveals the cover or cushion enjoyed by the firm due to the owners’ contribution over the outsiders’ contribution.

$$\text{Debt-equity Ratio} = \frac{\text{Debt (Long-term Debt = Debentures/Term Loans)}}{\text{Net Worth/Equity (Shareholders' Fund)}}$$



*Example:* The long-term debt of company ABC is ₹ 3 crores and the networkth of the company is ₹ 5 crores. What is the long-term debt-equity ratio of ABC?

**Solution:****Notes**

$$\text{Long-term debt-equity Ratio} = \frac{\text{Debt}}{\text{Net Worth}} = 3/5 = .6$$

Higher ratio indicates the riskier financial status of the firm which means that the firm has been financed by the greater outsiders' fund rather than that of the owners' fund contribution and vice versa.



**Caution** Standard norm of the Debt-Equity Ratio:

The ideal norm is 1:2 which means that every one rupee of debt finance is covered by two rupees of shareholders' fund.

The firm should have a minimum of 50% margin of safety in meeting the long-term financial commitments. If the ratio exceeds the specification, the interest of the firm will be ruined by the outsiders' during the moment at when they are unable to make the payment of interest in time as per the terms of agreement reached earlier. During the moment of liquidation, the greater ratio may facilitate the creditors to recover the amount due lesser holding held by the owners.

### Total Debt-equity Ratio

The ultimate purpose of the ratio is to express the relationship total volume of debt irrespective of nature and shareholders' funds. If the owners' contribution is lesser in volume in general irrespective of its nature leads to worse situation in recovering the amount of outsiders' contribution during the moment of liquidation.

$$\text{Total Debt-equity Ratio} = \frac{\text{Short-term Debt} + \text{Long-term Debt}}{\text{Equity (Shareholders' Fund)}}$$



**Example:** The long-term debt of company ABC is ₹ 3 crores and the networth of the company is ₹ 5 crores. If the company has a short term debt of ₹ 1 crore, what is the total debt-equity ratio of ABC?

**Solution:**

$$\text{Total Debt-equity Ratio} = \frac{\text{Short-term Debt} + \text{Long-term Debt}}{\text{Equity(Shareholders' Fund)}} = \frac{1+3}{5} = 4:5$$

### 4.4.2 Proprietary Ratio

The ratio illustrates the relationship in between the owners' contribution and the total volume of assets. In simple words, how much funds are contributed by the owners in financing the assets of the firm. Greater the ratio means that greater contribution made by the owners' in financing the assets.

$$\text{Proprietary Ratio} = \frac{\text{Owners' Funds or Equity or Shareholders' Funds}}{\text{Total Assets}}$$



**Caution** **Standard Norm of the ratio:** Higher the ratio, better is the position

Higher ratio is better position for the firm as well as safety to the creditors.

Notes



*Example:* The net worth of company ABC is ₹ 30 crores and the total assets are worth ₹ 10 crores. What is the proprietary ratio of the firm?

*Solution:*

$$\text{Proprietary Ratio} = \frac{\text{Owners' Funds or Equity or Shareholders' Funds}}{\text{Total assets}} = \frac{30}{10} = 3 : 1$$

The ratio shows that the firm is in quite a good financial position.

#### 4.4.3 Fixed Assets Ratio

The ratio establishes the relationship in between the fixed assets and long-term source of funds. Whatever the source of long-term funds raised should be used for the acquisition of long-term assets; it means that the total volume of fixed assets should be equivalent to the volume of long term funds, i.e. the ratio should be equal to 1.

$$\text{Fixed Assets Ratio} = \frac{\text{Shareholders' Funds} + \text{Outsiders' Funds}}{\text{Net Fixed Assets}}$$

If the ratio is lesser than one means that the firm made use of the short-term fund for the acquisition of long-term assets. If the ratio is greater than one means that the acquired fixed assets are lesser in quantum than that of the long-term funds raised for the purpose. In other words, the firm makes use of the excessive funds for the built of current assets.



*Caution Standard norm of the ratio:* The ideal norm of the ratio is 1:1, which means that the long-term funds raised are utilised for the acquisition of long-term assets of the enterprise.

It facilitates to understand obviously about the over capitalization or under capitalization of the assets of the enterprise.



*Example:* The networth of company ABC is ₹ 30 crores and the net fixed assets are worth ₹ 100 crores. If the outsider's funds are worth ₹ 70 crores, what is the fixed assets ratio of the firm?

*Solution:*

$$\text{Fixed Assets Ratio} = \frac{\text{Shareholders' Funds} + \text{Outsiders' Funds}}{\text{Net Fixed Assets}} = \frac{30 + 70}{100} = \frac{100}{100} = 1 : 1$$

Since the ratio is 1:1, it shows that the firm raises the long term funds utilises them only for the acquisition of long term assets of the enterprise.

#### 4.4.4 Coverage Ratios

These ratios are computed to know the solvency of the firm in making the periodical payment of interest and preference dividends. The interest and preference dividends are to be paid irrespective of the earnings available in the hands of the firm. In other words, these are known as fixed commitment charge of the firm.

## Interest Coverage Ratio

Notes

The firms are expected to make the payment of interest on the amount of borrowings without fail. This ratio facilitates the prospective lender to study the strength of the enterprise in making the payment of interest regularly out of the total income. To study the capacity in making the payment of interest is known as interest coverage ratio or debt service coverage ratio.

The ability or capacity is analysed only on the basis of Earnings Before Interest and Taxes (EBIT) available in the hands of the firms.

Greater the ratio means that better the capacity of the firm in making the payment of interest as well as greater the safety and vice versa.

$$\text{Interest Coverage Ratio} = \frac{\text{Earnings before Interest and Taxes}}{\text{Interest}}$$

Lesser the times the ratio means that meager the cushion of the firm which may lead to affect the solvency position of the firm in making payment of interest regularly.



*Example:* Mr Ashmit Ahuja had an earning of ₹ 3,00,000 before he paid the interests and taxes. What will be the interest coverage ratio if he pays ₹ 30,000 as an interest? What will it mean?

**Solution:**

$$\text{Interest Coverage Ratio} = \frac{\text{Earnings before Interest and Taxes}}{\text{Interest}} = \frac{3,00,000}{30,000} = 10 : 1$$

Since the interest coverage ratio is substantially high, it means that Mr. Ahuja has quite a good capacity in making the payment of interest and has a high safety.

## Dividend Coverage Ratio

It illustrates the firms' ability in making the payment of preference dividend out of the earnings available in the hands of the firm after the payment of taxation. Greater the size of the profits after taxation, greater is the cushion for the payment of preference dividend and vice versa.

The preference dividends are to be paid without fail irrespective of the profits available in the hands of the firm after the taxation.

$$\text{Dividend Coverage Ratio} = \frac{\text{Earnings after Taxation}}{\text{Preference Dividend}}$$



*Example:* Hindustan Manufacturers have to make a preference dividend of ₹ 60,000. The earnings after taxation is ₹ 3,00,000. What will be the Dividend coverage ratio? What does it mean?

**Solution:**

$$\text{Dividend Coverage Ratio} = \frac{\text{Earnings After Taxation}}{\text{Preference Dividend}} = \frac{3,00,000}{60,000} = 5 : 1$$

Since the value of the dividend coverage ratio is quite high, the company has a strong cushion for the payment of preference dividend.

### 4.5 Profitability Ratios

These ratios are measurement of the profitability of the firms in various angles, viz.

1. On sales
2. On investments
3. On capital employed and so on



While discussing the measure of profitability of the firm, the profits are normally classified into various categories:

1. Gross Profit
2. Net Profit
3. Operating Profit Ratio
4. Return on Assets Ratio
5. Return on Capital Employed

All profitability ratios are normally expressed only in terms of (%). The return is normally expressed only in terms of percentage which warrants the expression of this ratio to be also in percentage.

### 4.5.1 Gross Profit Ratio

The ratio elucidates the relationship in between the gross profit and sales volume.

It facilitates to study the profit earning capacity of the firm out of the manufacturing or trading operations.

$$\text{Gross Profit Ratio} = \frac{\text{Gross Profit}}{\text{Sales}} \times 100$$



*Example:* Om enterprises has earned a gross profit of ₹ 6,00,000 in the first quarter. Calculate the gross profit ratio if the corresponding sales amounted to a value of ₹ 30,00,000. What does it imply?

**Solution:**

$$\text{Gross Profit Ratio} = \frac{\text{Gross Profit}}{\text{Sales}} \times 100 = \frac{6,00,000}{30,00,000} \times 100 = 20 : 1$$

The ratio implies that the firm has earned good profits out of sales in the first quarter.



**Caution** *Standard norm of the ratio:* Higher the ratio means that the firm has greater cushion in meeting the needs of preference dividend payment against Earnings After Taxation (EAT) and vice versa.

### 4.5.2 Net Profit Ratio

The ratio expresses the relationship in between the net profit and sales volume. It facilitates to portray the overall operating efficiency of the firm. The net profit ratio is an indicator of over all earning capacity of the firm in terms of return out of sales volume.

$$\text{Net Profit Ratio} = \frac{\text{Net Profit}}{\text{Sales}} \times 100$$



*Example:* Om enterprises has earned a net profit of ₹ 3,00,000 in the first quarter. Calculate the net profit ratio if the corresponding sales amounted to a value of ₹ 30,00,000. What does it imply?

Notes

Solution:

$$\text{Net Profit Ratio} = \frac{\text{Net Profit}}{\text{Sales}} \times 100 = \frac{30,000}{30,00,000} \times 100 = 1 : 1$$

The ratio shows that the company is running on a no profit - no loss state.



**Caution** *Standard Norm of the Ratio:* Higher the ratio, the better the position of the firm is, which means that the firm earns greater profits out of the sales and vice versa.

### 4.5.3 Operating Profit Ratio

The operating ratio is establishing the relationship in between the cost of goods sold and operating expenses with the total sales volume.

$$\text{Operating Ratio} = \frac{\text{Cost of Goods Sold} + \text{Operating Expenses}}{\text{Net Sales}} \times 100$$



*Example:* The cost of goods sold by Mangamal operators is ₹ 2,000. What will be the operating ratio of the firm if the operating expenses are ₹ 50,000 and net sales is that of ₹ 5,00,000? What does it mean?

Solution:

$$\text{Operating Ratio} = \frac{\text{Cost of goods sold} + \text{Operating expenses}}{\text{Net sales}} \times 100 = \frac{2,000 + 50,000}{5,00,000} \times 100 = 1 : 2$$

Since the ratio is quite low, this means that the firm is in quite favourable position and thus has a high margin of operating profit.



**Caution** *Standard norm of the ratio:* Lower the ratio, the more favourable and better the firm's position is, which highlights the percentage of absorption, cost of goods sold and operating expenses out of sales and vice versa. The lower ratio leads to a higher margin of operating profit.

### 4.5.4 Return on Assets Ratio

This ratio portrays the relationship in between the earnings and total assets employed in the business enterprise. It highlights the effective utilization of the assets of the firm through the determination of return on total assets employed.

$$\text{Return on Assets} = \frac{\text{Net Profit After Taxes}}{\text{Average Total Assets}} \times 100$$



*Example:* If one company has an income of ₹ 1 crore and total assets of ₹ 10,00,000, what will be the return on assets if net profit after taxes is ₹ 500000?

Solution:

$$\text{Return on Assets} = \frac{\text{Net Profit After Taxes}}{\text{Average Total Assets}} \times 100 = \frac{5,00,000}{1,00,000} \times 100 = 50\%$$



**Caution** *Standard norm of the ratio:* Higher the ratio illustrates that the firm has greater effectiveness in the utilization of assets, means greater profits reaped by the total assets and vice versa.

#### 4.5.5 Return on Capital Employed

The ratio illustrates that how much return is earned in the form of Net profit after taxes out of the total capital employed. The capital employed is nothing but the combination of both non current liabilities and owners' equity. The ratio expresses the relationship in between the total earnings after taxation and the total volume of capital employed.

$$\text{Return on Total Capital Employed} = \frac{\text{Net Profit After Taxes}}{\text{Total Capital Employed}} \times 100$$



**Caution** *Standard norm of the ratio:* Higher the ratio is better the utilization of the long term funds raised under the capital structure means that greater profits are earned out of the total capital employed.



*Example:* In the previous example, if the total capital employed is worth ₹ 25,00,000, what is the return on total capital employed?

**Solution:**

$$\text{Return on Total Capital Employed} = \frac{\text{Net Profit After Taxes}}{\text{Total Capital Employed}} \times 100 = \frac{5,00,000}{25,00,000} \times 100 = 20\%$$

(i) Gross profit ratio =

$$\text{Gross profit ratio} = \frac{\text{Gross profit}}{\text{Sales}} \times 100$$

While calculating the gross profit ratio, which sales should be taken into consideration?

The net sales alone has to be taken into consideration for the computation of calculating the gross profit ratio. What is meant by net sales ?

$$\text{Net Sales} = \text{Gross sales} - \text{Sales Return}$$

The firm has not earned any profit on the sales return made by its customers/ consumers. When the firm has not earned any profit out of the sales return, that should be deducted from the gross sales. The chance of earning profit usually prevails only at the moment of payment by the customers, but the customers who returned the goods need not pay in this regard, which does not carry any opportunity for the firm to earn profit.

$$\text{GP Ratio} = \frac{₹4,00,000}{₹10,00,000} \times 100 = 40\%$$

(ii) Operating ratio =

$$\frac{\text{Cost of goods sold} + \text{Administration expenses} + \text{Selling \& Distribution expenses}}{\text{Net sales}} \times 100$$

The information pertaining to cost of goods sold is not available directly.

The cost of goods sold could be found out in two different ways:

$$\text{Cost of goods sold} = \text{opening stock} + \text{Purchases} - \text{Closing stock}$$

Substitute the values in the above equation

$$= ₹1,50,000 + ₹6,50,000 - ₹2,00,000$$

$$= ₹6,00,000$$

Alternately, the cost of goods sold could be found out as follows:

$$\text{Cost of goods sold} = \text{Sales} - \text{Gross profit}$$

$$= ₹10,00,000 - ₹4,00,000$$

$$= ₹6,00,000$$

$$\text{Operating ratio} = \frac{\text{₹6,00,000} + \text{₹1,30,000}}{10,00,000} \times 100 = 73\%$$

## 4.6 Turnover Ratios

It highlights the relationship in between the sales and various assets. The ratio indicates that the rate of speed which is taken by the firm for converting the assets into sales.

### 4.6.1 Stock Turnover Ratio

The ratio expresses the speed of converting the stock into sales. In other words, how fast the stock is being converted into sales in a year. The greater the ratio of conversion leads to lesser the number of days/weeks/months required to convert the stock into sales.

$$\text{Stock Turnover Ratio} = \frac{\text{Cost of Goods Sold}}{\text{Average Stock}} \text{ or } \frac{\text{Sales}}{\text{Closing Stock}}$$

Notes



**Caution** *Standard norm of the ratio:* Higher the ratio is better the firm in converting the stock into sales and vice versa.

The next step is to find out the number of days or weeks or months taken or consumed by the firm to convert the stock into sales volume.

$$\text{Stock Velocity} = \frac{365 \text{ days} / 52 \text{ weeks} / 12 \text{ months}}{\text{Stock Turnover Ratio}}$$



**Caution** *Standard norm of the ratio:* Lower the duration is better the position of the firm in converting the stock into sales and vice versa.



*Example:* The cost of goods sold is ₹ 500,000. The opening stock is ₹ 40,000 and the closing stock is ₹ 60,000 (at cost). Calculate inventory turnover ratio.

**Solution:**

$$\text{Average Stock} = \frac{\text{Opening Stock} + \text{Closing Stock}}{2} = \frac{40,000 + 60,000}{2} = 50,000$$

$$\text{Stock Turnover Ratio} = \frac{\text{Cost of Goods Sold}}{\text{Average stock}} = \frac{5,00,000}{50,000} = 10 : 1$$

#### 4.6.2 Debtors Turnover Ratio

This ratio exhibits the speed of the collection process of the firm in collecting the overdues amount from the debtors and against Bills receivables. The speediness is being computed through debtors velocity from the ratio of Debtors Turnover Ratio.

$$\text{Debtors Turnover Ratio} = \frac{\text{Net Credit Sales}}{\text{Average Debtors}} \text{ or } \frac{\text{Net Credit Sales}}{\text{Debtor} + \text{Bills Receivable}}$$



**Caution** *Standard norm of the ratio:* Higher the ratio is better the position of the firm in collecting the overdue means the effectiveness of the collection department and vice versa.

**Debtors velocity:** This is an extension of the earlier ratio to denote the effectiveness of the collection department in terms of duration.

$$\text{Debtors Velocity} = \frac{365 \text{ days} / 52 \text{ weeks} / 12 \text{ months}}{\text{Debtor Turnover Ratio}}$$



**Caution** *Standard norm of the ratio:* Lesser the duration shows greater the effectiveness in collecting the dues which means that the collection department takes only minimum period for collection and vice versa.



*Example:* Sundaram & Co. Sells goods on cash as well as credit basis. The following particulars are extracted from the books of accounts for the calendar 2005:

To find out the average collection period, first debtors turnover ratio has to be computed

$$\text{Debtors Turnover Ratio} = \frac{\text{Net Credit Sales}}{\text{Bills Receivable} + \text{Debtors}}$$

$$\begin{aligned} \text{Net Credit Sales} &= \text{Gross Sales} - \text{Cash Sales} - \text{Sales Return} \\ &= 2,00,000 - 40,000 - 14,000 = 1,46,000 \end{aligned}$$

$$\text{Debtor Turnover Ratio} = \frac{1,46,000}{4,000 + 18,000} = 6.64 \text{ times}$$

$$\text{Debtors Velocity} = \frac{365 \text{ days}}{\text{Debtors Turnover Ratio}} = \frac{365 \text{ days}}{6.64 \text{ times}} = 55 \text{ days}$$

### 4.6.3 Creditors Turnover Ratio

It shows effectiveness of the firm in making use of credit period allowed by the creditors during the moment of credit purchase.

$$\text{Creditors Turnover Ratio} = \frac{\text{Credit Purchase}}{\text{Average Creditors}} \text{ or } \frac{\text{Credit Purchase}}{\text{Bills Payable} + \text{Sundry Creditors}}$$



**Caution Standard norm of the ratio:** Lesser the ratio is better the position of the firm in liquidity management means enjoying the more credit period from the creditors and vice versa.

$$\text{Creditors Velocity} = \frac{365 \text{ days} / 52 \text{ weeks} / 12 \text{ months}}{\text{Creditors Turnover Ratio}}$$



**Caution Standard norm of the ratio:** Greater the duration is better the liquidity management of the firm in availing the credit period of the creditors and vice versa.



**Example:** Find out the value of creditors from the following:

Sales ₹1,00,000	Opening stock ₹10,000
Gross profit on sales 10%	Closing stock ₹20,000
Creditors velocity 73 days	Bills payable ₹16,000

To find out the value creditors, the creditor velocity and creditors turnover ratio

$$\text{Creditors Velocity} = \frac{365 \text{ days}}{\text{Creditors Turnover Ratio}}$$

$$\begin{aligned} \text{Creditors Turnover Ratio} &= \frac{\text{Credit Purchases}}{\text{Bills Payable} + \text{Sundry Creditors}} \\ &= \frac{1,00,000}{16,000 + \text{Sundry Creditors}} \end{aligned}$$

The next step is to find out the sundry creditors, the reversal process to be adopted

$$73 \text{ days} = \frac{365 \text{ days}}{\text{Creditors Turnover Ratio}}$$

$$\text{Creditors Turnover Ratio} = \frac{365 \text{ days}}{73 \text{ days}} = 5 \text{ times}$$

The next step is to substitute the found value in the equation of creditors turnover ratio

$$16,000 + \text{Sundry creditors} = \frac{₹1,00,000}{5}$$

$$\text{Sundry Creditors} = 20,000 - 16,000 = 4,000$$

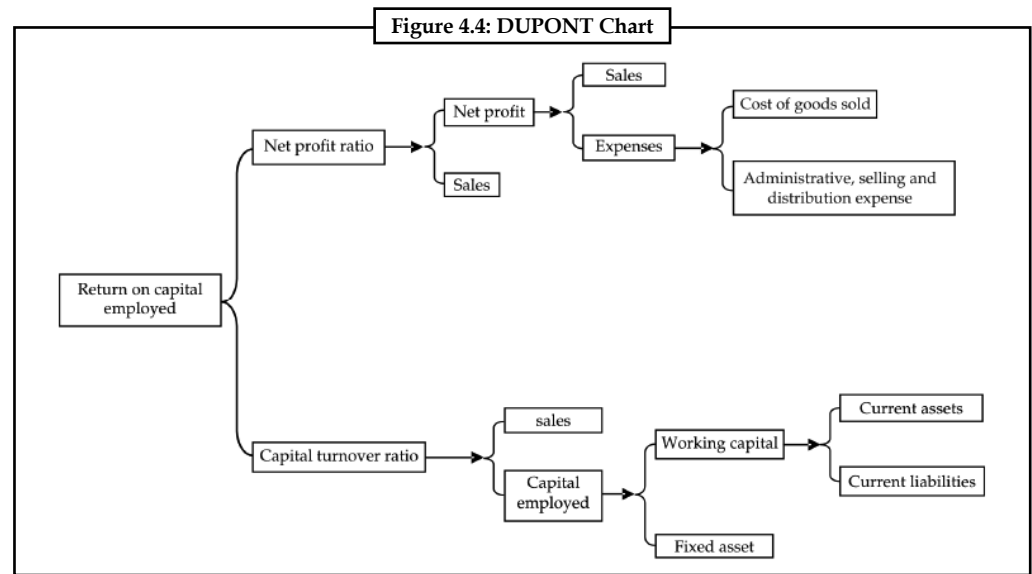

### 4.7 DUPONT Analysis

This was an analysis established by the DUPONT INC., USA to study the return on investment. It was the first company developed the chart which depicted the influences of Return on Investment. The company underwent for the consideration two important ratios, Net profit ratio and Capital turnover ratio, for the return on investment. A change in any one of the two ratios reflects immediately on the Return on investment. The various associated factors are considered to study the impact of the profitability of the firm. This type of analysis to correct the problems not only to identify with the specific cause which drastically affects the profitability but also to find the possible ways and means to improve the profitability. Having developed the chart for analysis was called as DUPONT Chart.

### 4.8 Relevance of Ratio Analysis

Ratio analysis has a lot of utility which may be understood by the following discussion:

1. **Easy to understand the financial position of the firm:** The ratio analysis facilitates the parties to read the changes taken place in the financial performance of the firm from one time period to another.
2. **Measure of expressing the financial performance and position:** It acts as a measure of financial position through Liquidity ratios and Leverage ratios and also a measure of financial performance through Profitability ratios and Turnover Ratios.
3. **Intra-firm analysis on the financial information over many number of years:** The financial performance and position of the firm can be analysed and interpreted with in the firm in between the available financial information of many number of years; which portrays either increase or decrease in the financial performance.
4. **Inter-firm analysis on the financial information within the industry:** The financial performance of the firm is studied and interpreted along with the similar firms in the industry to identify the presence and status of the respective firm among others.
5. **Possibility for financial planning and control:** It not only guides the firm to earn in accordance with the financial forecasting but also facilitates the firm to identify the major source of expense which drastically has greater influence on the earnings.

### Introduction

Every business establishment usually prepares the balance sheet at the end of the fiscal year which highlights the financial position of the yester years It is subject to change in the volume of the business not only illustrates the financial structure but also expresses the value of the applications in the liabilities side and assets side respectively. Normally, Balance sheet reveals the status of the firm only at the end of the year, not at the beginning of the year. It never discloses the changes in between the value position of the firm at two different time periods/dates.

The method of portraying the changes on the volume of financial position is the analysis of fund flow statement.

### 5.1 Meaning of Fund Flow Statement

In a narrow sense, the term fund means cash, and the fund flow statement depicts the cash receipts and cash disbursements/payments. It highlights the changes in the cash receipts and payments as a cash flow statement in addition to the cash balances i.e. opening cash balance and closing cash balance. Contrary to the earlier, the fund means working capital, i.e. the differences between the current assets and current liabilities.

The term flow denotes the change. Flow of funds means the change in funds or in working capital. The change on the working capital leads to the net changes taken place on the working capital,

**Notes**

i.e. especially due to either increase or decrease in the working capital. Some of the transactions may lead to increase or decrease the volume of working capital. Some other transactions register neither an increase nor decrease in the volume of working capital.

According to Foulke, "A statement of source and application of funds is a technical device designed to analyse the changes to the financial condition of a business enterprise in between two dates."

Various facets of fund flow statement are as follows:

1. Statement of sources and application of funds
2. Statement changes in financial position
3. Analysis of working capital changes and
4. Movement of funds statement
5. Depreciation charged on assets
6. Appropriation of profits to reserves
7. Payment of interim dividends
8. Payment and appropriations in relation to provisions for taxation/dividends where they are treated as non-current liabilities.

Fund flow statement has following objectives:

1. It pinpoints the mobilization of resources and the further utilization of resources.
2. It highlights the financing of the general expansion of the business firms.
3. It exemplifies the utilization of debt finance in the structure of financing.
4. It portrays the relationship between the financing, investments, liquidity and dividend decision of the firm during the given point of time.



*Notes* Steps in the Preparation of Fund Flow Statement:

1. First and foremost step is to prepare the statement of changes in working capital, i.e. to identify the flow of fund/movement of fund through the detection of changes in the volume of working capital.
2. Second step is the preparation of Non-current A/c items-Changes in the volume of Non-current A/cs have to be prepared only in order to quantify the flow fund, i.e. either sources or application of fund.
3. Third step is the preparation Adjusted Profit & Loss A/c, which already elaborately discussed in the early part of the unit.
4. Last step is the preparation of fund flow statement.

The ultimate purpose of preparing the schedule of changes in the working capital illustrates the changes in the volume of net working capital which envisages either sources or application of fund. The schedule of changes is focused as follows:

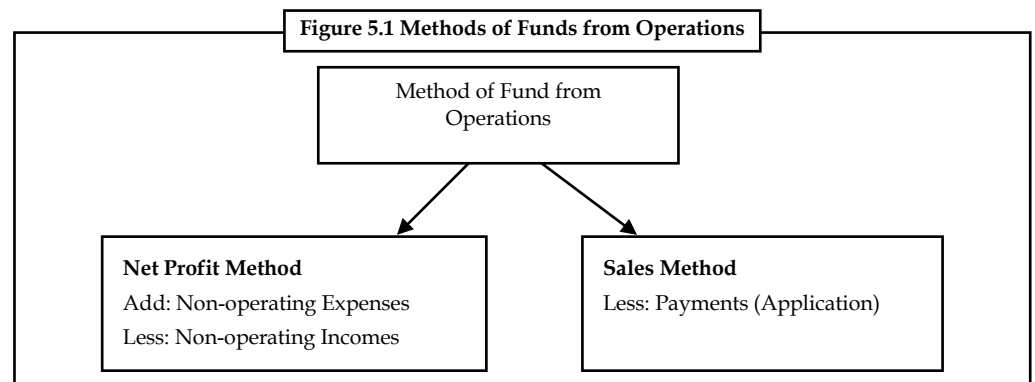

The following are the key methods of preparing fund from operations:

- Net Profit Method
- Sales Method





*Caution* The first method is widely used method by all in determining the volume of Fund from Operations (FFO).

### 5.3.1 Net Profit Method

Under the Net Profit Method, fund flow from operations can be computed. Under this method, fund from operations can be determined in two different ways The first method is through the statement format

### Important Adjustments

1. **Provision for Tax:** At the time of preparation of fund flow statement, there are two approaches to treat this item. These are:
  - (i) Treat it as a current liability
  - (ii) Treat it as an appropriation of profit

As per first approach, the provision for taxation is assumed as a current liability. Therefore, it must be shown in the schedule of working capital changes. All the information relating taxation should be ignored as in the case of other current liabilities. In this approach, the provision, for taxation is neither used in the fund from operation nor in the uses of fund in the Fund Flow Statement as payment of tax liability.

Under second approach, the provision for taxation is treated as an appropriation of profit. Provision for taxation is not shown in the Schedule of Working Capital Changes. As other appropriations it is added back in the net profits to calculate the Fund from Operation. To find the payment of tax of the year provision for taxation account is prepared. Payment of the tax of the year is disclosed in the Uses of Fund in the Fund Flow Statement. Provision for taxation a/c is prepared as hereunder:

However, it is advised to the students to adopt the first approach. This approach is more convenient for the students. Provision for taxation is also disclosed under the heading of current liabilities and provisions in the Balance Sheet of the Company as per the Indian Companies Act. This approach is adopted in the book also.

2. **Proposed Dividend and Dividend Paid:** Dividend paid during the year should be treated as an application of fund, therefore, it must be shown in the fund flow statement. Proposed dividend is not accumulated therefore, it should not be treated as a current liability. It is assumed that the proposed dividend of the previous year is paid during the year whether it is said or not. Therefore, it will be a use of fund. Proposed dividend and interim dividend are the appropriations against profit. So to calculate the fund from operation it must be added back to net profits like other appropriations. It must be noted that the closing balance of the P & L account of a year should be equal to the opening balance of P & L A/c in the next year. If there is any difference between these two figures, difference should be treated as payment of dividend during the year.
3. **Depreciation of the Assets:** It is an item considered to be non-recurring expenditure. It was considered at par with the other expenditures/expenses which do not reduce the volume of working capital. The charge of depreciation never indulges in the payment of cash resources from the firm.

## 5.5 Summary

- Fund flow statements summarize a firm's inflow and outflow of funds.
- Simply put, it tells investors where funds have come from and where funds have gone.
- The statements are often used to determine whether companies efficiently source and utilize funds available to them.
- Fund flow statements are prepared by taking the balance sheets for two dates representing the coverage period.
- The increases and decreases must then be calculated for each item. Finally, the changes are classified under four categories: (1) Long-term sources, (2) Long-term uses, (3) Short-term sources and (4) Short-term uses.
- It is also important to zero out the non-fund based adjustments in order to capture only the changes that are accompanied by flow of funds.
- However, income accrued but received and expenses incurred but not received reckoned in the profit and loss statement should not be excluded from the profit figure for the fund flow statement.
- Fund flow statements can be used to identify a variety of problems in the way a company operates.
- Meanwhile, a company that is using long-term money to finance short-term investments may not be efficiently utilizing its capital.

### Introduction

Cash is considered one of the vital sources of the firm to meet day to day financial commitments. The cash is considered to be as most important source of life blood of the business. The day to day financial commitments are met out only out of the available resources. The cash resources are availed through two different types of receipts viz. sales, dividends, interests known as regular receipts and sale of assets, investments known as irregular receipts of the business enterprise. To have smooth flow of business enterprise, it should have ample cash resources for its operations. The availability of cash resources is mainly depending on the cash inflows of the enterprises. The smoothness in operations of the enterprise is obtained through an appropriate matching of cash inflows and cash outflows.

To have smoothness in the operations of the enterprise, the firm should have an appropriate volume of cash resources at speedier rate as well as more than the financial commitments of the firm. This smoothness could be attained by way of an appropriate planning analysis on the

cash resources of the firm. The meaningful analysis is only possible through cash flow statement analysis which facilitates the firm to identify the possible sources of cash as well as the expenses and expenditures of the firm.

## **6.1 Meaning of Cash Flow Statement**

The cash flow statement is being prepared on the basis of extracted information of historical records of the enterprise. Cash flow statements can be prepared for a year, for six months, for quarterly and even for monthly. The cash includes not only means that cash in hand but also cash at bank.

### **Objectives of Cash Flow Statements**

The following are the main motives of preparing the cash flow statement:

1. To identify the causes for the cash balance changes in between two different time periods, with the help of corresponding two different balance sheets.
2. To enlist the factors of influence on the reduction of cash balance as well as to indicate the reasons though the profit is earned during the year and vice versa.

### **Utility of Cash Flow Statement**

1. To identify the reasons for the reduction or increase in the cash balances irrespective level of the profits earned by the firm.
2. It facilitates the management to maintain an appropriate level of cash resources.
3. It guides the management to take futuristic decisions on the prospective demands and supply of cash resources through projected cash flows.
  - (a) How much cash resources are required?
  - (b) How much cash requirements could be internally settled?
  - (c) How much cash resources are to be raised through external sources?
  - (d) Which types of instruments are going to be floated for raising the required resources?
4. It helps the management to understand its capacity at the moment of borrowing for any further capital budgeting decisions.
5. It paves way for scientific cash management for the firm through maintenance of appropriate cash levels i.e. optimum level cash of resources.
6. It avoids in holding excessive or inadequate cash resources through proper planning of cash resources.
7. It moots control through identification of variations occurred in the cash expenses and expenditures.

**6.2 Classification of Cash Flow**

As per AS-3 (revised) the cash flow statement is prepared in a manner reporting the cash flows into following categories:

**6.2.1 Cash Flow from Operating Activities**

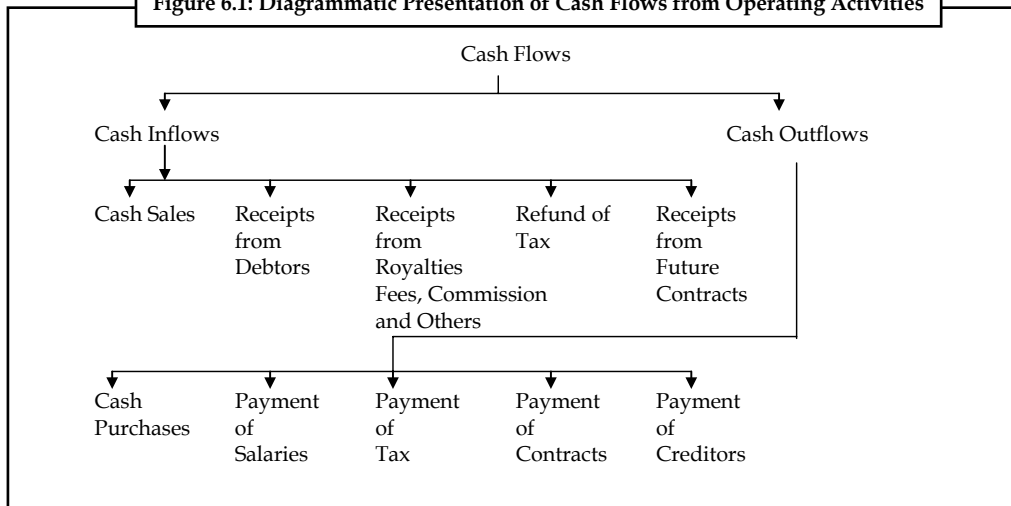
Cash flows from operating activities are earned from the principal revenue - producing activities of an enterprise. Through these activities the net profit or loss of the business is also determined. Examples of such a flow from operating activities are given in AS-3 (revised) as follows:

- (a) Cash receipts from the sale of goods and rendering of services;
- (b) Cash receipts from royalties, fees, commissions and other revenue;
- (c) Cash payments to suppliers for goods and services;
- (d) Cash payments to and on behalf of employees;
- (e) Cash receipts and cash payments of an insurance enterprise for premiums and claims, annuities and other policy benefits;
- (f) Cash payments or refunds of income taxes unless they can be specifically identified with financing and investing activities, and
- (g) Cash receipts and payments relating to future contracts, forward contracts, option contracts and swap contracts when the contracts are held for dealing or trading purposes.



**Caution** Some transactions, such as the sale of an item of plant, may give rise to a gain or loss which is included in the determination of net profit or loss. However, the cash flows relating to such transactions are cash flows from investing activities.

## 6.2.2 Cash Flow from Investing Activities

Investing activities of an enterprise include the purchase of fixed assets (as plant and machinery, land and buildings, furniture and fixtures) with an intention to generate the future incomes. On account of being an important activity, a separate disclosure of the cash flows from these activities is made. Examples of cash flows arising from investing activities are in AS-3 (revised) as follows:

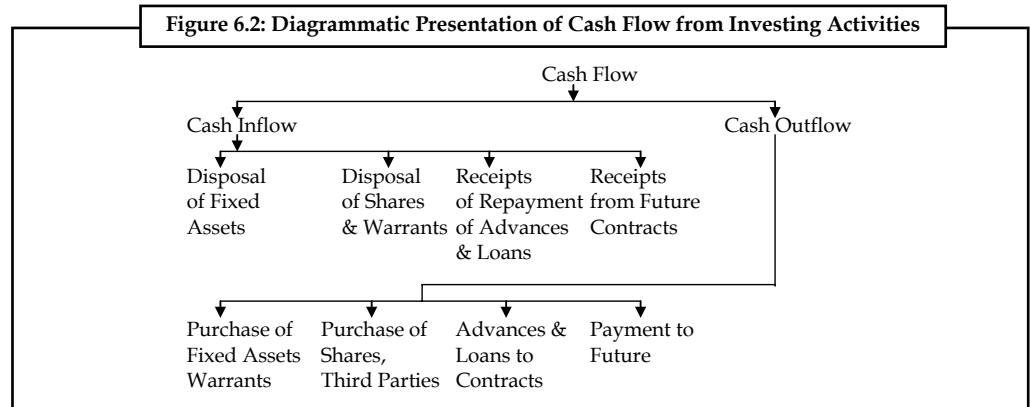
- cash payments of acquired fixed assets (including intangibles). These payments include those relating to capitalized research and development costs and self-constructed fixed assets;
- cash receipts from disposal of fixed assets (including intangibles);
- cash payments to acquired shares, warrants or debt instruments of other enterprises and interests in joint ventures (other than payments for those instruments considered to be cash equivalents and those held for dealing or trading purposes);
- cash receipts from disposal of shares, warrants or debt instruments of other enterprises and interests in joint ventures (other than receipts from those instruments considered to be cash equivalents and those held for dealing or trading purposes);
- cash advances and loans made to third parties (other than advances and loans made by a financial enterprise);
- cash receipts from the repayment of advances and loans made to third parties (other than advances and loans of a financial enterprise);
- cash payments for future contracts, forward contracts, option contracts and swap contracts except when the contracts are held for dealing or trading purposes, or the payments are classified as financing activities; and

Notes

- (h) cash receipts from future contracts, forward contracts, option contracts and swap contracts except when the contracts are held for dealing or trading purposes, or the receipts are classified as financing activities.



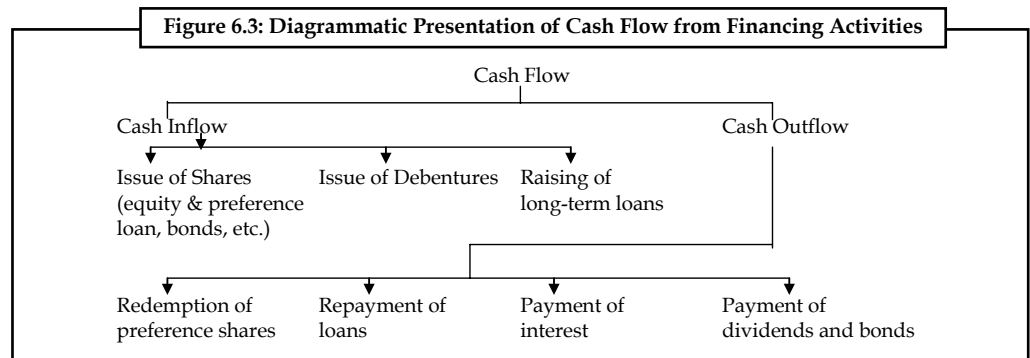
*Did u know?* When a contract is accounted for as a hedge of an identifiable position, the cash flows of the contract are classified in the same manner as the cash flows of the position being hedged.



### 6.2.3 Cash Flow from Financing Activities

Under financial activities those activities are included which are relating to the size and composition of capital (equity and preferences) and borrowing or loans. As per AS-3 (revised), the separate disclosure of cash flows arising from financing activities is important because it is useful in predicting claims on future cash flows by providers of funds (both capital and borrowings) to the enterprise. Examples of cash flows arising from financing activities are:

- (a) cash proceeds from issuing shares or other similar instruments;
- (b) cash proceeds from issuing debentures, loans, notes, bonds and other short or long-term borrowings; and
- (c) cash repayments of amounts borrowed.







### Notes Treatment of Other Items

Besides the above cash flow activities AS-3 (revised) also give the dealing of the some other items. These other items are as follows:

1. **Foreign Currency Cash Flow:** Unrealized gain or loss on account of change in the foreign exchange rate is not treated as cash flow. But the effect of change of foreign exchange on the cash and cash equivalents held in a foreign currency is recorded in the cash flow statement to reconcile the cash and cash equivalents at the beginning and at the end of the period. This amount is not adjusted with operating, investing and financing activities but it is shown separately.
2. **Extra-ordinary Items:** Cash flow arising from the extra-ordinary item is shown in the cash flow statement after classifying it into operating, investing and financing activities. This is done so that ordinary users may understand them easily. For example, loss by fire in store is compensated by insurance company. It will be treated as cash flow from operating activities.
3. **Interest and Dividends:** If a financial enterprise is receiving interest and dividend then such a cash flow arising from interest and dividend will be considered into operating activities. If interest and dividend are received by other enterprise, such a cash flow arising from interest and dividend will be considered into investing activities and if interest and dividend is paid, such a cash flow arising from interest and dividend is considered into financing activities. This cash flow arising from interest and dividend paid or received is disclosed separately.
4. **Taxes on Income:** If no adverse information is given relating to taxes paid on incomes, cash flow arising from the taxes paid as income is classified in operating activities. If taxes are paid on such income which is relating to finance, such a cash flow will be classified into financial activities.
5. **Non-cash Transactions:** The non-cash transactions are not recorded in cash flow statement because they do not have a direct impact on the current cash flow while they affect the capital and assets as purchase of fixed assets by the issue of shares or debentures. In AS-3 (revised) examples of non-cash transactions are mentioned as below:
  - (a) the acquisition of assets by assuming directly related liabilities,
  - (b) the acquisition of an enterprise by means of issue of shares, and
  - (c) the conversion of debt to equity.
6. **Balances of Foreign Branches:** In some situations, the balance of cash and cash equivalent held with foreign branches are not available due to foreign exchange control or other legal restrictions. So the management should use that amount which can be measured in cash and cash equivalent.

### **6.3 Preparation of Cash Flow Statement**

Cash flow statement provides information about the cash receipts and payments of an enterprises for a given period. It provides important information that supplements the profit and loss account and balance sheet.

The statement of cash flows is required to be reported by Accounting Standard-3 (Revised ) issued by the Institute of Chartered Accountants of India in March 1997 Which replaces the 'Changes in Financial Position' as per AS-3.

There are certain changes in the preparation of cash flow statement from the previous methods as a result of the introduction of AS-3 (Revised).

AS-3 (Revised) is mandatory in nature in respect of accounting periods commencing on or after 1-4-2001 for the following:

1. Enterprises whose equity or debt securities are listed on a recognised stock exchange in India, and enterprises that are in the process of issuing equity or debt securities that will be listed on a recognised stock exchange in India as evidenced by the board of directors' resolution in this regard.
2. All other commercial, industrial and business reporting enterprises, whose turnover for the accounting period exceeds ₹ 50 crores.

There are two methods of converting net profit into net cash flows from operating activities:

- (i) Direct method, and
- (ii) Indirect method.

#### **Direct Method**

Under direct method, cash receipts from operating revenues and cash payments for operating expenses are arranged and presented in the cash flow statement. The difference between cash receipts and cash payments is the net cash flow from operating activities. It is in effect a cash basis profit & loss account. In this case, each cash transaction is analysed separately and the total cash receipts and payments for the period are determined. The summarised data for revenue and expenses can be obtained from the financial statements and additional information. We may convert accrual basis of revenue and expenses to equivalent cash receipts and payments. Make sure that a uniform procedure is adopted for converting accrual base items to cash base items.

The following are some examples of usual cash receipts and cash payments resulting from operating activities:

1. Cash sales of goods and services;
2. Cash collected from debtors (customers);
3. Cash receipts of interest or dividends;
4. Cash receipts of royalties, fees, commission and other revenues;

5. Cash payments to suppliers (creditors);
6. Cash payments for various operating expenses, i.e., rent, rates, power, etc.
7. Cash payments for wages and salaries to employees;
8. Cash payments for income tax, etc.

### Indirect Method

In this method, the net profit (loss) is used as the base and converted to net cash provided by (used in) operating activities. The indirect method adjusts net profit for items that affected net profit but did not affect cash. Non-cash and non-operating charges in the profit & loss account are added back to the net profit, while non-cash and non-operating credits are deducted to calculate operating profit before working capital changes. It is a partial conversion of accrual basis profit to cash basis profit. Necessary adjustment are made for increase/decrease in current assets and current liabilities to obtain net cash from operating activities.

## Introduction

Budget is an estimate prepared for definite future period either in terms of financial or non-financial terms. Budget is prepared for any course of action or business or state or Nation, as a whole. The budget is usually expressed in terms of total volume.

According to ICMA, England, a budget is as follows “a financial and or quantitative statement prepared and approved prior to a defined period of time, of the policy to be pursued during the period for the purpose of attaining a given objective.”

It is in other words as “detailed plan of action of the business for a definite period of time.” It is a statement of financial affairs/quantitative terms of an activity for a defined period, to achieve the enlisted objectives.



*Did u know? What is budgeting?*

Budgeting is the course involved in the preparation of budget of an activity.

## 7.1 Meaning and Features of Budgeting

Budgeting means the process of preparing budgets. In other words, budgeting refers to the management action of formulating budgets. Preparation of budgets involves study of business situations and understanding of management goals as also the capacity of the organisation.

According to **Welsch**, “budgeting is the principal tool of planning and control offered to management by accounting functions.”

In the words of **J. Batty**, “the entire process of preparing the budgets is known as budgeting.”

**Rowland and Harr** has defined budgeting as, “budgeting may be said to be the act of building budgets.”

According to the definition, the essential features of a budget are as follows:

1. It is prepared for a definite period well in advance.
2. It may be stated in terms of money or quantity or both.
3. It is a statement defining the objectives to be attained and the policy to be followed to achieve them in a future period.
4. It is a statement expressed in monetary and/or physical units prepared for the implementation of policy formulated by the management.
5. It is laid down prior to the budget period during which it is followed.
6. The policy to be followed to attain the given objective must be laid before the budget is prepared.

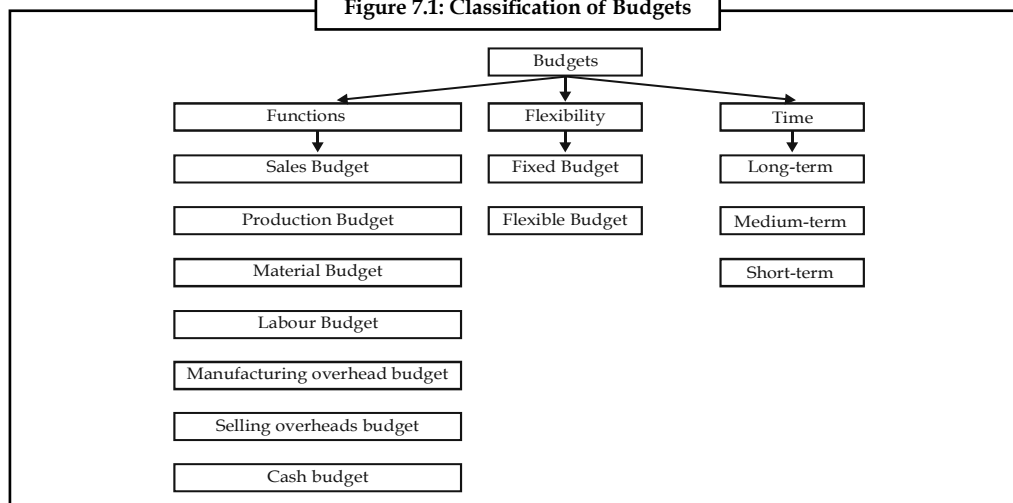

## 7.2 Types and Preparation of Budgets

The following figure explains the classification of budgets:

Figure 7.1: Classification of Budgets

7.2.1 Production Budget

The preparation of the production budget is mainly dependent on the sales budget. The production budget is a statement of goods, how much should be produced. It may be in terms of quantities, Kilograms in monetary terms and so on.



*Did u know? What is the purpose of the production budget?*

The ultimate aim of the production budget is to find out the volume of production to be made during the year based on the sale volume.

The production and sales volume should go hand-in-hand with each other; otherwise the firm would require to face the acute problem on holding unnecessary excessive stock or inadequate stock to meet the needs of the buyers in time; which will disrepute in the supply of goods in time to them as already agreed upon.

$$\text{Units to be produced} = \text{Budgeted Sales} + \text{Closing Stock} - \text{Opening Stock}$$

The methodology of production budget includes three different components, viz. sales, closing stock and opening stock. Sales have to be added with the stock of the year at the end and to be deducted the opening stock.

*Why sales have to be given paramount importance in the preparation of production budget?*

The major sales of the business enterprise is being regularly made out of only through the current year production.

*Why the closing stock has to be added?*

The purpose of the closing stock to be added is that it is a stock at end of the year-end out of the current year production.

*Why the opening stock has to be deducted?*

The aim of deducting the opening stock is that the stock at the beginning is the stock out of the yester or previous year production.

If sales is normally equivalent to the entire year of production, the firm need not to concentrate on the volume of opening stock and closing stock. It means that, what ever produced during the year is equivalent to current year sales. If the entire production is sold out, there won't be closing stock at the end of the year and opening stock i.e. subsequent years.

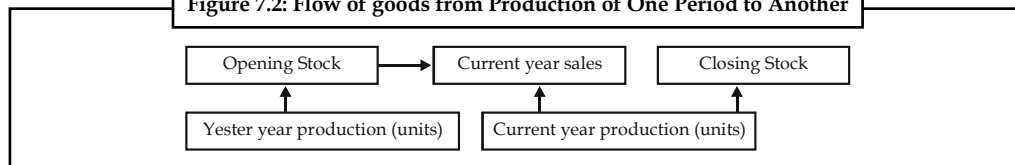
**Resultant:** No closing stock and opening stock for the subsequent years. This situation may not be possible at always

*Why it is not possible at always?*

The production volume is connected to the internal environment of the firm, which can be maintained through a systematic approach, but the sales cannot be easily administered by the firm which is being highly influenced by the demand and supply factors of the goods.

If the current year production is not equivalent to the current year sales

Figure 7.2: Flow of goods from Production of One Period to Another



*Did u know? Why the closing stock arises in the business?*

The closing stock is stock due to the excessive production over the sales volume. The reasons for excessive production are as follows:

1. Ineffective study of market potential through market research leads to the expression of excessive demand from the market, which signals the production department to produce to the tune of MR conducted.
2. Due to price fluctuations in the market may affect the volume of sales.
3. Due to meet the future demand.
4. The excessive production due to the cheaper availability of raw materials, which leads to greater amount of closing stock. If the storage cost is more than the hike takes place on the cost of raw materials leads to abnormal storage of the stock.

The above diagram clearly illustrates that the emergence of the opening stock and closing stock during the year out of sales and production volume of the enterprise.

### 7.2.2 Materials/Purchase Budget

This budget takes place only after identifying the number of finished products expected to produce to the tune of production budget, in meeting the needs and demands of the customers and consumers during the season.

In order to produce to the tune of production budget to meet the market demands, the raw materials for the production should be maintained sufficient to supply them without any interruption. To have uninterrupted flow of production, the firm should go for the immediate procurement of raw materials through the multiplication of raw material required to produce for a single product with number of units expected to produce.



**Caution** Why the stock of raw materials is deducted from the expected volume of materials procured for production to the tune of production budget?

If there is any existing stock of raw materials, i.e. opening stock of raw materials available from the yester seasons or years should be deducted from the volume of materials required for production to be ordered and placed. The remaining volume should be the volume to be ordered for production.



**Example:** The sales manager of the MR Ltd. reports that next year he anticipates to sell 50,000 units of a particular product.

The production manager consults the storekeeper and casts his figures as follows:

Two kinds of raw materials A and B are required for manufacturing the product. Each unit of the product requires 2 units of A and 3 units of B. The estimated opening balances at the commencement of the next year are:

Finished product : 10,000 units

Prepare production budget and materials purchase budget for the next year.

**Solution:**

The first step is to prepare the production budget. To identify the volume of materials required for production by considering the production budget and the closing stock of materials of A and B respectively.

Why the closing stock of raw materials has to be added with estimated consumption? The purpose of adding the closing stock of raw materials is to anticipate the future demand of them, due to market influence; which warrants the firm to go for placement of order not only taking into consideration of expected consumption of raw materials but also the closing stock of raw materials to be maintained at the end of the season, in order to facilitate to have uninterrupted flow of production.

**Why the opening stock of raw materials has to be deducted?**

The opening stock of raw materials, which is available in the firm, should be considered for the placement of order of raw materials. The materials to be ordered should be other than that of the materials available in the firm.

### 7.2.3 Sales Budget

Sales Budget is an estimate of anticipation of sales in the near future prepared by the responsible person for the sale of a product by considering the various factors of influence. Sales budget is usually prepared in terms of quantity and value. The following factors are normally considered for the preparation of sales budget of a firm:

1. Last sales figures
2. Estimates of the salesmen who is frequently operating in the market, known much greater than any body in the market
3. Capacity of the plant and machinery to produce
4. Funds availability
5. Availability of raw materials to the tune of demand in the respective time period
6. Changes in the taste and preferences of the customer or consumer
7. Changers in the competition structure - Monopoly to Perfect competition – Previously BSNL was known as DOT as a monopoly in the market in affording the services till early 2000. Then later, the changes taken place in the market environment i.e. competition due to invasion of new entrants like Reliance, Hutch, Bharti tele ventures and so on; warrants careful preparation of sales budget of number of telephone connection expected to sell.



*Example:* Reynolds Pvt. Ltd. manufactures two brands of pen Light & Elite. The sales department of the company has three departments in different regions of the country.

The sales budgets for the year ending 31st Dec, 2006 Light department I=3,00,000; department II=5,62,500; department III=1,80,000: Elite-department I=4,00,000; department II=6,00,000; department III=20,000.

Sales prices are ₹ 3 and ₹ 1.20 in all departments. It is estimated that by forced sales promotion the sales of Elite in department I will increase by 1,75,000. It is also expected that by increasing production and arranging extensive advertisement, department III will be enabled to increase the sale of Elite by 50,000.

It is recognized that the estimated sales by department II represent an unsatisfactory target. It is agreed to increase both estimates by 20%.

Prepare a sales budget for the year 2006.

**Solution:**

Sales budget should be prepared to the tune of various influences of forthcoming seasons' sales. The expected increase or decrease in the sales volume should be incorporated at the time of preparing the sales budget from the yester periods sale figures.

1. There is no change in the volume of existing sales of the department of I Light; the existing sales of the department I of the Light should be retained as it is for the computation of the budgeted figures, but there is a change expected to occur in the existing volume of sales of the department I of the Elite. The change expected amounted to increase 1,75,000 units in addition to the volume of existing sales, i.e. the total volume of sales is equivalent to 4,00,000 units of existing volume of sales + 1,75,000 units expectation of increase= 5,75,000 units for Elite Department I.
2. In the II department of both Light & Elite expected to have an increase on the volume of existing sales amounted is 20% i.e. 20% increase on the Department II of Light 5,62,500 units amounted 6,75,000 units and similarly in the case of Department II of Elite 6,00,000 units amounted 7,20,000 units.

3. In the III department of Light does not have any change in the volume of existing sales, it means that 1,80,000 units has to be retained as it is in the computation of the budgeted figure but in the case of Elite, department III expected to have an increase in the volume of sales which amounted 20,000 units i.e. 70,000 units.

### 7.2.4 Sales Overhead Budget

It is one of the important sub functional budgets, prepared by the sales manager who is responsible for the sales volume of the enterprise to increase through various devices/tools of sales promotion.

The sales overhead can be classified into two categories viz fixed sales overhead and variable sales overhead.

#### *What is meant by the Fixed Sales Overhead?*

Fixed sales overhead is the expenses incurred for promoting the sales, which remains the same or fixed irrespective of the volume of the sales.



- Example:* 1. Salaries to Sales Department  
2. Salaries to the Administrative Staff  
3. Salary to Salesmen

Variable sales overhead is the expenses incurred for the promotion of the sales, which is varying along with the volume of sales of the firm.



- Example:* 1. Sales commission  
2. Agents commission  
3. Carriage outward expenses.

The sales overhead budget is the statement of estimates of the various sales promotional expenses not only based on the early/yester period sales promotional expenses but also on the sales of previous years.



*Example:* The following expenses were extracted from the books of M/s Sudhir & Sons, to prepare the sales overhead budget for the year 2006.

**Solution:**

The most important step is to find out the variable portion of the sales overhead of M/s Sudhir & Sons.

1. The calculation of salesmen's commission is on the basis of the sales volume generated by the salesmen force. The total sales volume consists of two different parts viz. Sales contributed by the sales force and another one is contribution of the agents. To find out the sales volume of the sales man, the portion of the agents' sales volume should be deducted from the total sales volume.

$$\text{Sales Force's/Men's Volume} = \text{Total Sales Volume} - \text{Agent's Sales Volume}$$

Similarly, the agents' sales volume can be computed.

2. From the early step, the amount of commission is to be computed from the volume of sales.
3. Carriage outward should be computed on the volume of sales.

## 7.2.5 Cash Budget

Notes

Cash budget is nothing but an estimation of cash receipts and cash payments for specified period. It is prepared by the head of the accounts department i.e. chief accounts officer.

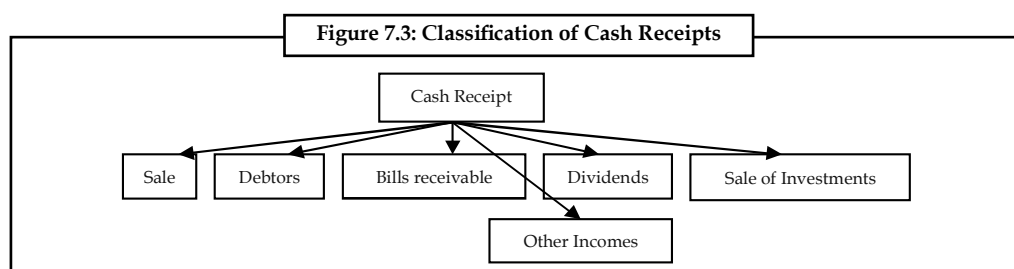
The utility of the cash budget is as follows:

1. To meet the revenue and capital expenditures with adequate funds.
2. It should highlight the additional requirement cash whenever the need arises.
3. Keeping of excessive funds available in the business firm would not fetch any return to the enterprise but this estimate of future cash needs and resources will guide the firm to plan for an effective investment out of the surplus funds estimated; enhances the wealth of the investors through proper investment planning out of the future funds available

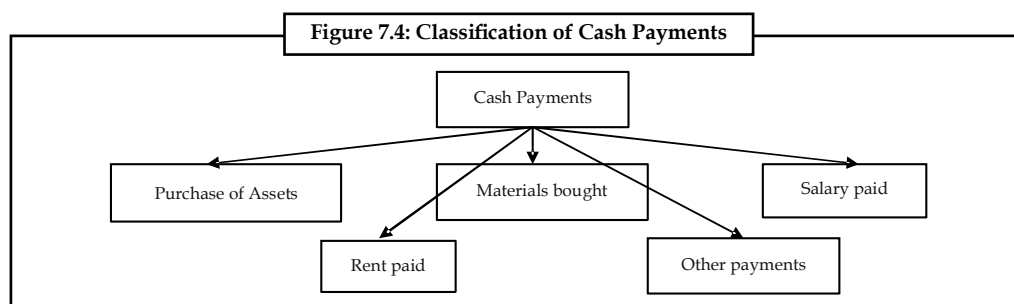
Cash budget can be prepared in three different ways:

1. Receipts and payments method
2. Adjusted profit and loss account
3. Balance Sheet Method

Cash receipts can be classified into various categories:

The payments whatever are expected to make after June is not relevant as far as the budget preparation concerned.
2. Delay in the payment of wages and office expenses is only one month. It means wages and office expenses of Feb. month are paid in the next month, March.

Selling expenses from the above coloured boxes, it is obviously understood that during the months of April, May and June; the following will be stream of payment of selling expenses.

April = ₹ 2,000 of Mar. (Previous Month) and ₹ 2,200 of April (Current month) = ₹ 4,200

May = ₹ 2,200 of April (Previous Month) and ₹ 2,100 of May (Current month) = ₹ 4,300

June = ₹ 2,100 of May (Previous Month) and ₹ 1,900 of June (Current month) = ₹ 4,000

3. Selling expenses is having the delay of ½ month, which means 50% of the selling expenses is paid only in the current month and the remaining 50% is paid in the next

## 7.3 Classification of the Budget in Accordance with the Flexibility

### 7.3.1 Fixed Budget

It is a budget known as constant budget, never registers the changes in the preparation of a budget, being prepared for irrespective level of output or production. This budget is mainly meant for the fixed overheads of the firm which are constant in volume irrespective level of production. The ultimate utility of the budget is to control the cost as a cost controlling measure, but the fixed budget is meaningless in having comparison with the actual performance.

### 7.3.2 Flexible Budget

Flexible budget is prepared for any level of production as an estimate of statement of all expenses i.e. the expenses are classified into three categories viz. variable, semi-variable and fixed expenses. The structure of the budget for any output is only to the tune of the actual performance achieved. This is the budget facilitates not only to have comparison in between various levels of production but also to identify the level of lowest production cost.

Notes



Notes Utilities of the flexible budget:

1. This budget is most useful tool of analysis in studying the sales at when the circumstances are not warranting to predict.
2. It is mostly suited to the seasonal business, where the sales volume is getting differed from one period to another due to changes taken place in the taste and preferences of the buyers.
3. The production is being done on the basis of demand of the products in the market. The demand of the products is studied only through demand forecasting. The flexible budget is more applicable in the case of products, which are greatly finding difficult to forecast the demand.
4. The budget is prepared only during the time of acute shortage of resources of production viz. Men, Material and so on.

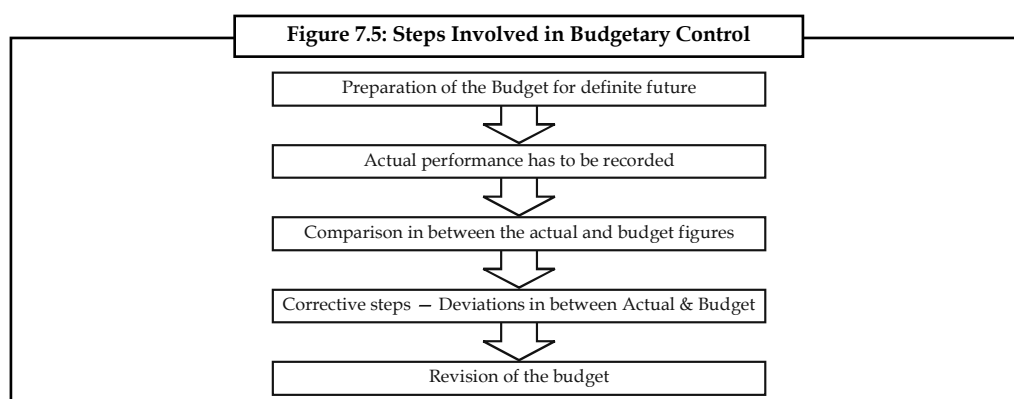

### 7.4 Budgetary Control System

Budgetary control contains two different processes one is the preparation of the budget and another one is the control of the prepared budget.

According to J. Batty, "Budgetary control is a system which uses budgets as a means of planning and controlling all aspects of producing and/or selling commodities and services."

According to ICMA, England, a budgetary control is, "the establishment of budgets relating to the responsibilities of executives to the requirements of a policy and the continuous comparison of actual with budgeted results, either to secure by individual action the objectives of that policy or to provide a basis for its revision".

**7.5 Features of Budgetary Control System**

The following are the essentials or pre-requisites for the successful implementation of a sound system of budgetary control:

- (i) The business objectives, plans and policies should be clearly defined.
- (ii) The organisational chart should be clear with responsibility and authority.
- (iii) The budgeted output should be stated in clear terms.
- (iv) Budget committee should be setup for the establishment and efficient execution of the plan.
- (v) Budget centres should be established for cost control and all budgets should be related to cost centres.
- (vi) The budgetary control system should have full support of top management of the organisation.
- (vii) The accounting system should provide accurate and timely information.
- (viii) Staff of the organisation should be strongly and properly motivated towards the system.
- (ix) The budget should lay down the targets which are realistic and attainable, and
- (x) The budgets should be flexible nature for permit the adjustments in the light of changed operational circumstances.

**7.6 Objectives of Budgetary Control**

The following are the key objectives of budgetary control:

1. To use different levels of management in a co-operative endeavour for achievement of the objectives of the firm.
2. To facilitate centralised control with delegated authority and responsibility.
3. To achieve maximum profitability by planning income and expenditure through optimum use of the available resources.
4. To ensure adequate working capital in other resources for efficient operation of business.
5. To reduce losses and wastes to the minimum.
6. To bring out clearly where effort is needed to remedy the situation.
7. To see that the firm is not deflected from marching towards its long-term objectives without being overwhelmed by emergencies.
8. Various activities like production, sales, purchase of materials, etc., are coordinated with the help of budgetary control.
9. To define the goal of the enterprise.

## 7.7 Zero-base Budgeting (ZBB)

Zero-base budgeting is one of the renowned managerial tools, developed in the year 1962 in America by the Former President Jimmy Carter. The name suggests, it is commencing from the scratch, which never incorporates the methodology of the other types of budgeting in determining the estimates. The Zero base budgeting considers the current year as a new year for the preparation of the budget but the yester period is not considered for consideration. The future activities are forecasted through the zero base budgeting in accordance with the future activities.

Peter A Pyher "A planning and budgeting process which requires each manager to justify his entire budget request in detail from scratch (Hence zero base) and shifts the burden of proof to each manger to justify why he should spend money at all. The approach requires that all activities be analysed in "decision packages" which are evaluated by systematic analysis and ranked in order of importance."

This type of budgeting requires the manager to reason out the aim of spending, but in the case of traditional budgeting is unlike, which are never emphasize the reasons of spending in terms of expenses.

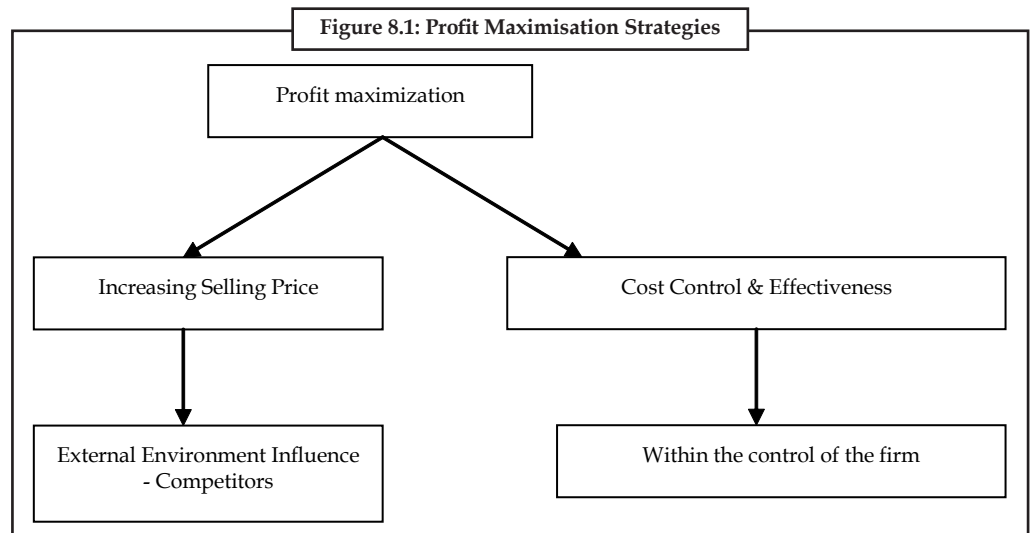

### Introduction

Standard costing is a tool, which replaces the bottleneck of the historical costing. Historical costing is one of the tools, which fulfills the one of the objectives of costing i.e. ascertainment of costs. The cost of a product can be ascertained only after the production of a product; which is meant as "Historical costing". Historical costing facilitates to ascertain the cost of a product which is connected with yester operations or with past. The ultimate aim of studying this unit is to control the cost of a product as one among the objectives of cost effectiveness strategy of the business enterprise.

The profit maximization can be had by way of implementing the following two different strategies:

Notes



From the following equation, the profit can be maximized

$$\text{Selling Price} - \text{Cost} = \text{Profit}$$



*Caution* There are two possible ways to maximize the profit:

1. Increasing the selling price and keeping the cost remains the same.
2. Reducing the cost and retaining the selling price as it is.

### 8.1 Meaning and Definition of Standard Costing

Standard is nothing but an expected or anticipated performance in normal situations. The standards are quantitative in phenomenon which are in connection with one activity and differs from the another.



- Example:*
1. Kg of raw materials expected to produce one unit of product.
  2. Hours are expected/anticipated to consume for production of a single unit of product.

Standards are classified into two categories, viz. Revenue standards and Cost standards.

Standard cost is a predetermined cost, which is estimated from management's standard of efficient operation and the relevant necessary expenditure, according to ICWA (London).

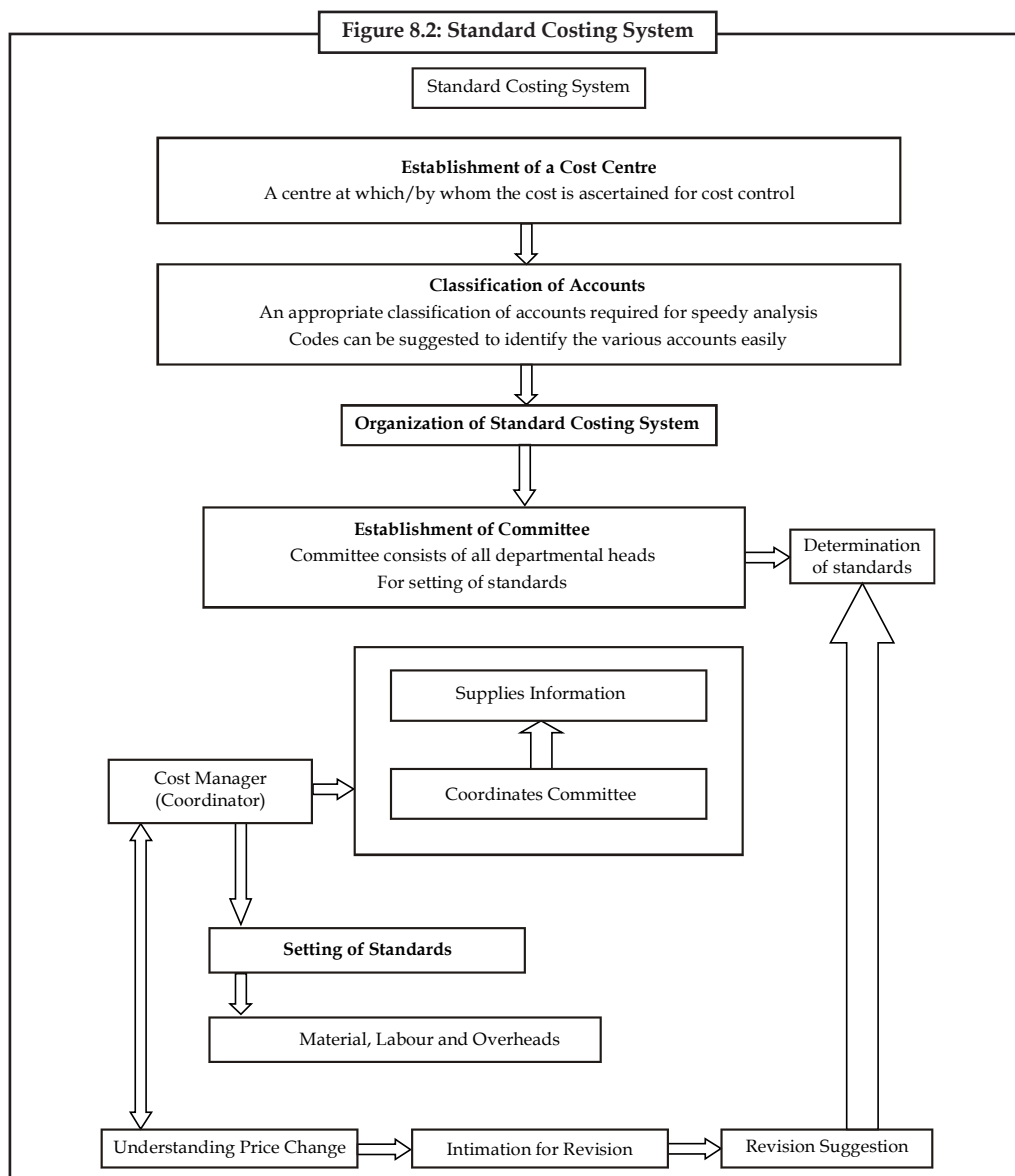


*Caution* The standard cost is related to variable portion of the cost of a product. The variable portion of cost of product depends on the following:

1. Material consumption
2. Hours taken/consumed
3. Incurring of miscellaneous expenditures - Overheads.

Standard costing is a system, which involves the various steps:

1. The first step in implementing the standard costing system is to develop the pre-determined standards, i.e., standard costs.
2. The second step is to record the actual costs through the ascertainment.
3. The third step involves with the comparison between the standards and actual costs; which is the origin of the variance analysis. Standard costing starts with the preparation of standards and ends with the comparison in between them. The preparation of standard costs is meaningful only through the completion of variance analysis.
4. The fourth step is the stage at which the reasons for variances are probed and analysed to incorporate the cost effectiveness not only to reduce cost but also to enhance the levels of profit.
5. The final step is the most important in the organization to take managerial decisions through an appropriate reporting. The figure 8.2 explains the standard costing system:

**Standard Costing in Jute Industry**

Jute industry offers scope for implementing standard costing, says Dhruba Kumar Dutt in Industrial Management in India from Purple Peacock ([www.bharatbooks.com](http://www.bharatbooks.com)). The author divides jute costing into three: Spun jute yarn, woven jute cloth, and finished jute cloth/bag. "To arrive at the cost of jute yarn, one has to start from the stage of batching," explains Dutt. Jute mills use a ready-reckoner type of table to blend jute of various kinds in fixed proportions; this is softened and converted into 'jute yarn of the required count.' Costing department receives daily reports that show 'the quantity of each kind of jute consumed in the batching process.' Standardised numbers are available of raw jute consumption for producing one tonne of spun yarn; also known are percentages of waste in each process stage from batching to spinning.

"Direct and indirect labour costs are carefully split up and charged to the processed material of each kind," be it hessian/sacking warp/weft. Winding section has piece-rate workers winding both cops and beams. "In the weaving stage, costs of warp and weft yarns (in beams and cops) for producing jute cloth of any particular kind is calculated by ascertaining the consumption of beams and cops." Move on then to the sewing department, where you can compute the cost of jute cloth and jute yarns required to manufacture a bag. Sack sewers work on piece rate. Successful standardisation hinges on minute observations and experiments, notes Dutt. "Thus standard costing should be viewed as part of industrial management," he argues.

**8.2 Budgetary Control and Standard Costing**

The systems of standard costing and budgetary control have the common objectives of controlling business operations by establishment of pre-determined targets, measuring the actual performances and comparing it with the targets, for the purpose of having better efficiency and of reducing costs. The two systems are said to be inter-related but they are not inter-dependent. Standard costing is introduced primarily to ascertain efficiency and effectiveness of cost performance. Budgetary control is introduced to state in figures an approved plan of action relating to a particular period. Both standard costing and budgetary control have the following common features:

- (i) Both have a common objective of improving managerial control.

**8.3 Estimated Costing**

Standard costs and estimated costs are predetermined costs, but their objectives are different. Important points of difference between the two are as follows:

**Table 8.2: Difference between Standard Cost and Estimated Cost**

**8.4 Standard Costing as a Management Tool**

Standard costing is a very useful managerial tool for cost control and cost reduction. The following are the main advantages of standard costing:

1. Standard costing is a valuable aid to management in formulating price and production policies and in performing managerial functions.
2. Human beings often work hard to achieve standards that are within their reach; therefore, setting up of such standards will almost automatically mean greater efficiency in operations. Further, almost everyone will think in terms of setting the targets and of achieving them. This will be specially so if the system of rewards and punishment is also geared to the results.

3. Even for valuation of inventory, standard cost should be the proper basis. If actual costs are high only because there has been a wastage of resources, it is not proper to capitalise those losses by including them in the value of inventory. Nothing becomes more valuable simply because of wastage and, therefore, inventory values should better be determined on the basis of standard costs.
4. In short, one can say that if a firm practices standard costing on proper lines, i.e., standards are themselves determined in a way that will not impose too great a burden on the worker or other employees or the firm, it may infuse in the minds of the staff a desire to achieve the standards and thus show greater efficiency.
5. At every stage of setting the standards, simplification and standardisation of productions, methods and operations are effected and waste of time and material is eliminated. This assists in managerial planning for efficient operation and benefits all the divisions of the concern.
6. Costing procedure is simplified. There is a reduction in paperwork in accounting and less number of forms and records are required. There is considerable saving in clerical time and expenditure, leading to reduction in the cost of the costing system.
7. This system facilitates delegation of authority and fixation of responsibility for each department or individual.
8. Where constantly reviewed, the standards provides means for achieving cost reduction. This is attained through improved quality of products, better materials and men, effective selection and use of capital resources, etc.
9. Standard costs assist in performance analysis by providing ready means for preparation and interpretation of information.
10. This facilitates the integration of accounts so that reconciliation between cost accounts and financial accounts may be eliminated.
11. Standards serve as yardsticks against which actual costs are compared. Whenever variances occur, reasons are studied and immediate corrective measures are undertaken. Thus, it facilitates effective cost control and provides necessary information for cost reduction.
12. It creates an atmosphere of cost consciousness among executives, foremen and workers. It also provides incentives to employees for efficient work.
13. Standard costing facilitates management by exception. It helps the management in concentrating its attention on cases which are below the standards set.
14. Standard costing helps in effective delegation of authority and responsibility. As a result, the management can control the affairs of various departments effectively.
15. Setting of standard involves effective utilisation of men, material and machines. It leads to economy and increased productivity in all business activities.
16. It simplifies costing procedures and reporting. It reduces clerical work since standard rates are fixed for material pricing, overhead allocation apportionment, etc.
17. It makes the work of valuation of inventory easier. This is because inventory is valued at predetermined costs.

### **8.5 Limitations of Standard Costing**

Standard costing has certain limitations. These are the following:

1. Establishment of standard costs is difficult in practice. Even if the particular type of standard to be used has been properly defined, there is no guarantee that the standard established will have the same tightness or looseness as envisaged throughout the organisation.
2. In course of time, the standards become rigid, it is not always possible to change standards to keep pace with frequent changes in the manufacturing conditions. Frequent revision of standards is costly and creates problems.
3. Standard costing is an expensive technique for a small concern.
4. It is difficult to set accurate standard costs. Improperly set standards may do more harm than good.
5. It is not easy to distinguish variances as controllable or uncontrollable.
6. Since business conditions are changing, the standards are to be revised frequently. Revision of standards is a tedious and costly process.
7. Standard costing cannot be applied fully to job order industries dealing in non-standardised products. It may be applied partially but it would not be effective.
8. If standards are too high or rigid, they will be unattainable. It will adversely affect the morale and motivation of employees and lead to resistance.

### **8.6 Determination of Standard Cost**

As 'standard' is a relative expression; one has to determine for oneself what one deems appropriate as a 'standard'. However, one should not lose sight of the objective, which normally should be avoidance of all losses and wastages as far as possible. The management may certainly fix standards on the basis of maximum possible efficiency, possibly with an assumption of no wastage, no idle time, etc. However, this is not realistic; the standard will be the 'Ideal Standard' but impracticable-no one will even make an attempt to achieve it.

Alternatively, an average of past few years' costs could be taken as basis but this will mean perpetuating past inefficiencies, by making them the target. This will defeat the very purpose of standard costing.

A target should be such that it will induce the worker to give out his best. In order to make people believe in standards and to induce them towards achieving them, standards should better be such as can be achieved but with an effort; in other words, they should be somewhat idealistic.

1. **Basic Standard:** This is a 'standard' which is established for use, unaltered over a long period of time. Standards are fixed scientifically and hence it is more of a technical job. These standards are supposed to remain unchanged so long as quality requirements are constant. Moreover, if forward contracts are entered into regarding materials and labour pact signed for a certain period, the costs can be planned accordingly. Such costs, i.e., basic standards may, however, have to be adjusted for changes in circumstances in a period.
2. **Current Standard:** In practice, standards are fixed on the basis of scientific studies but adjusted for current subjective factors. A standard, therefore, is made realistic to reflect the anticipated conditions affecting operations; it is not too idealistic. Such a standard would bring to sharp focus the avoidable causes for variances, leading to control action. A current standard is a standard for a certain period, for certain conditions and for certain circumstances. Basic standards are more idealistic whereas current standards are more realistic. Most companies use current and not basic standards.
3. **Expected or Attainable Standard:** A standard though idealistic, should also be realistic. If targets are fixed for a certain budgeted period, taking into account the expected conditions, it can be known as "expected standard" or "attainable standard". It is defined by CIMA, London as, "A standard which can be attained if a standard unit of work is carried out efficiently, a machine properly operated or a material properly used. Allowances are made for normal losses, waste and machine downtime."
4. **Normal Standard:** Yet another target is one that is intended to cover a longer period of time— a period long enough to cover one trade cycle, i.e., roughly 7 to 10 years. This is defined as "the average standard which it is anticipated can be attained over a future period of time, preferably, long enough to cover one trade cycle".
5. **Ideal Standard:** This standard refers to the target that can be attained under most ideal conditions. Hence, it is more idealistic and less realistic. It is defined by the terminology as: "The standard which can be attained under the most favourable conditions, with no allowance for normal losses waste and machine down time".



#### Did u know? How to Prepare Standard Cost Sheet?

When all the standard costs have been determined, a Standard Cost Sheet is prepared for each product or service. The process of setting standards for materials, labour and overheads results in the establishment of the standard cost for the product. Such a cost sheet shows for a specified unit of production, quantity, quality and price of each type of materials to be used, the time and the rate of pay of each type of labour, the various operations the product would pass through, the recovery of overhead and the total cost. The build-up of the standard cost of each item is recorded in standard cost sheet. These details serve as a basis to measure the efficiency against which actual quantities and costs are compared. The type of standard cost sheet varies with the requirements of individual firm hence no uniform format can be prescribed.

### Introduction

In standard costing, variance means the difference between the standard cost and the actual cost. Variances of different cost items provide the key to cost control. They indicate whether and to what extent standards set have been achieved. This enables management to correct adverse tendencies.

The terminology of ICMA London, defines variance as, "Difference between a standard cost and the comparable actual cost incurred during a period." Variance for each element of cost should be ascertained regularly. If the actual cost is less than the standard cost, it is termed as 'favourable variance'. On the other hand, if the actual cost is more than the standard cost, it is known as 'adverse' or 'unfavourable variance.'

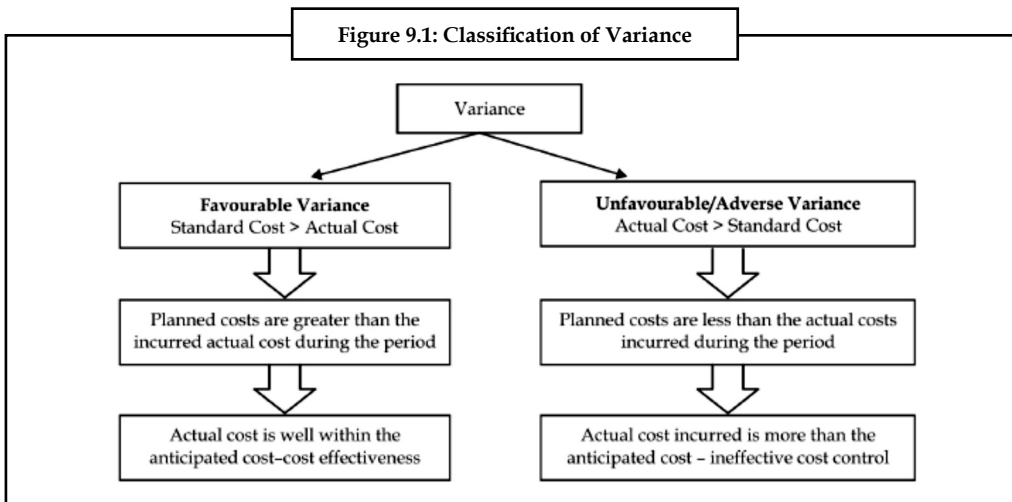
- (a) Computation of individual variances, and

### 9.1 Meaning and Importance of Variance Analysis

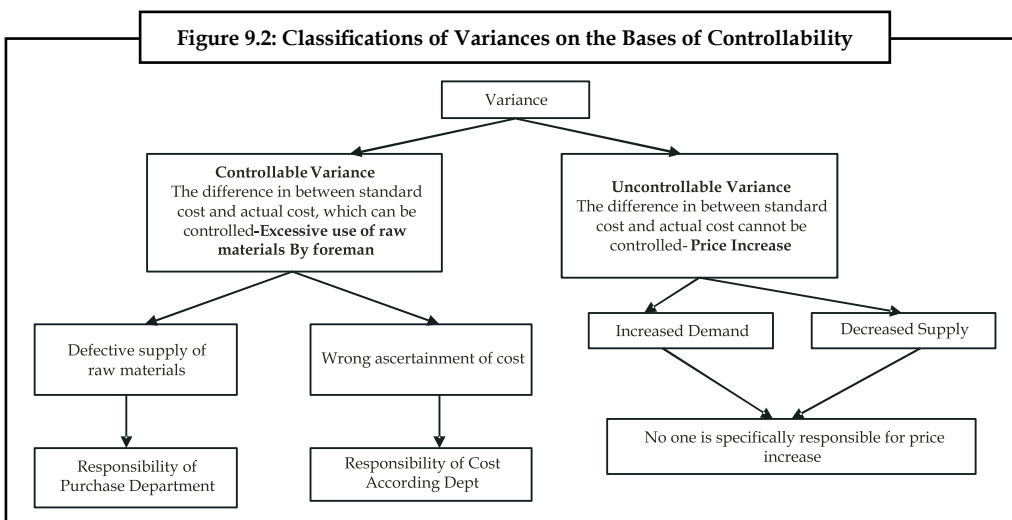
The term "Variance" means deviation, difference and so on. The variance in accordance with standard costing is meant as the difference/deviation in between two different costs viz standard cost and actual cost. According to ICWA, London defines the variance as "deviation in between the standard cost and comparable actual cost incurred during the period." The variance of the specific element of cost should be periodically checked. The variance is classified into two categories.

The variance can be classified into two categories, based on controllability *viz.* controllable and uncontrollable variance.



The purpose of standard costing is to correct the variance, which is in between standard cost and actual cost.

## 9.2 Kinds of Variances

There are two types of variances *viz.* cost variance and revenue variance.

**Cost Variance:** Cost variance can be further classified into three categories:

1. Material Cost Variance
2. Labour Cost Variance
3. Overhead Variance

**Revenue Variance:**

1. Sales Variance

Apart from the above classified types, there is a general way of studying variances. Let us discuss every variance in detail in the remaining unit.

### 9.2.1 Material Variances

#### Material Cost Variance (MCV)

The name of the variance is self-explanatory, means that the difference in between the standard cost of materials and Actual cost of materials. The material cost variance is in between the standard material cost for actual production in units and actual cost.

Material cost variance can be computed into two different ways:

1. **Direct Method:** It is a method simply studies the deviation in between the two different cost of materials without giving any emphasis for other factors of influence *viz.* the quantity of materials and price of a material. Under the direct method, the comparison is in between the standard cost of materials which is the planned cost of materials before commencement, scientifically developed by considering the all other factors of influence and the actual cost of materials, which is actually incurred during the production.



*Did u know? Why standard cost is to be tuned to the level of actual cost?*

The main aim of computing the standard cost for actual output is that the standard cost developed is not to the tune of actual production in units, instead it is available in terms of per unit of a product/for overall production, e.g. for a year. To have leveled comparison in between the standard cost has to be designed to the tune of Actual cost.

$$\begin{aligned} \text{Material cost variance} &= \text{Standard cost of materials for actual output} - \text{Actual cost of} \\ &\quad \text{raw materials} \\ &= (\text{SQAQO} \times \text{SP}) - (\text{AQ} \times \text{AP}) \end{aligned}$$

2. **Indirect Method:** It is a method which computes the material cost variance by considering two important variances *viz.* material price variance and material usage variance. Under this method material cost variance is calculated through the summation of the variances *viz.* price and usage of materials.

$$\text{Material Cost Variance} = \text{Material Price Variance (MPV)} + \text{Material Usage Variance}$$



*Example:* To manufacture one unit of product, the requirement is 2 Kgs of material @₹ 2 per Kg. Actual output is 400 units Actual quantity of materials used is 850 kgs ₹ 1.80 find out the material cost variance.

**Solution:****Notes**

First step is to find out the standard quantity for actual output

Standard quantity of raw materials = 2Kg

Actual Production = 400 units

To have leveled comparison, the Standard quantity of materials for actual output to computed; then only the variance intend to encircle will be meaningful or vice versa.

The computation of SQAQO should be computed at first:

For the production of one unit of product 2 Kg of raw material was planned and finalized prior to the commencement of production process. The actual production of the firm during the cycle is 400 units. What would be the requirement of the firm in manufacturing 400 units to the tune of planned quantity of materials per unit 2 Kg? This is the standard quantity of materials for actual output computed for an effective comparison with the actual quantity of materials consumed by the firm in manufacturing the 400 units.

$$\text{SQAQO} = 400 \times 2\text{Kg} = 800 \text{ Kg}$$

$$\text{SP} = \text{Standard Price} = ₹ 2 \text{ per Kg}$$

$$\text{AQ} = \text{Actual Quantity} = 850 \text{ Kgs}$$

$$\text{AP} = \text{Actual Price} = ₹ 1.80$$

$$\begin{aligned} \text{Material cost variance} &= (\text{SQAQO} \times \text{SP}) - (\text{AQ} \times \text{AP}) \\ &= (800 \text{ Kg} \times ₹ 2) - (850 \text{ Kg} \times ₹ 1.8) \\ &= ₹ 1600 - ₹ 1530 \\ &= ₹ 70 \text{ (F)} \end{aligned}$$

The material cost variance of the above problem is favourable due to lesser actual cost over the standard cost of materials.

**Material Price Variance**

It is very simple to understand that the name of the variance is self-explanatory in explaining the meaning of the variance. It is a variance in between two different prices *viz.* the standard price and actual price of raw materials. The difference should be expressed only in terms of the actual usage of materials. The ultimate of aim of expressing this variance in the lights of actual usage of materials is to identify the deviation of the price changes in line with the purchase of raw materials.

$$\text{Material Price Variance} = (\text{SP} - \text{AP}) \text{ AQ}$$

From the earlier illustration, the material price variance is as follows

$$\text{Standard price} = ₹ 2 \text{ per unit}$$

$$\text{Actual price} = ₹ 1.80 \text{ per unit}$$

$$\text{Actual quantity of materials consumed} = 850 \text{ Kg}$$

$$\begin{aligned} \text{Material price variance} &= 850 \text{ Kg} (2.00 - 1.80) \\ &= ₹ 170 \text{ (F)} \end{aligned}$$

**Decision Criterion:** If the resultant is positive, it means that the planned price which was scientifically developed is more than the actual price. In precise terms, the price fluctuations in the market are well with in the planned price. If it is within the standard, quantified as favourable

**Notes**

for a firm. If not, otherwise, the excessive/exorbitant cost of purchase of raw material more than the standard is unfavourable/adverse for the firm, the reason is the firm has paid more on the cost towards the purchase of materials than the planned one.

**Material Usage or Quantity Variance**

The variance/ deviation is in between the standard quantity of materials and the actual quantity of materials consumed. The found variance in Kg of raw materials should be expressed in monetary values i.e in terms of Rupees, through the multiplication with the standard price. The ultimate aim of expressing the variance in terms of standard price is the price, which is totally free from market fluctuations, i.e. supply and demand factors of the market.

$$\text{Materials Usage Variance} = \text{Standard Price} \times (\text{Standard quantity of materials for actual output} - \text{Actual quantity of materials used})$$



*Example:* (Output more than one unit)

Standard quantity of raw materials required to produce one unit of X was 10 kgs @ ₹ 6 per Kg.

Actual units produced during that period were 500 units. Actual quantity of materials was 5500 Kgs @ ₹ 5.5 Kg.

Calculate the material cost, price and usage variance.

**Solution:**

From the above problem, it came to understand that the actual production of a firm is more than a unit, i.e. 500 units.

Standard quantity of raw materials for actual output has to be computed to the tune of actual production 500 units.

$$\text{Standard quantity of raw materials for actual output} = \text{Standard Quantity of Materials} \times \text{Actual Production}$$

For One unit of out put the standard quantity of raw material is 10 Kg

For 500 units of actual production, how much would be the standard quantity of raw materials?

$$\text{SQAQ} = 10 \text{ Kg} \times 500 \text{ Units} = 5000 \text{ Kg,}$$

$$\text{Standard Price} = ₹ 6 \text{ Kg}$$

$$\text{AQ} = 5500 \text{ Kgs,}$$

$$\text{Actual Price} = ₹ 5.5 \text{ Kg}$$

$$\begin{aligned} \text{Material Cost Variance} &= \text{SQAQ} \times \text{SP} - \text{AQ} \times \text{AP} \\ &= (5000 \text{ Kg} \times ₹ 6) - (5500 \text{ Kg} \times ₹ 5.5) \\ &= (₹ 30000) - (₹ 30250) = (₹ 250)(A) \end{aligned}$$

$$\begin{aligned} \text{Material Price Variance} &= (\text{SP} - \text{AP}) \times \text{AQ} \\ &= (₹ 6 - ₹ 5.5) \times 5500 = ₹ 2750(F) \end{aligned}$$

$$\begin{aligned} \text{Material Usage Variance} &= (\text{SQAQ} - \text{AQ}) \times \text{SP} \\ &= (5000 - 5500) \times ₹ 6 = ₹ 3000 (A) \end{aligned}$$

**Verification:** The indirect method of computing the material cost variance facilitates to verify the answer computed under the material variances.

$$\text{MCV} = \text{MPV} + \text{MUV}$$

$$₹ 250 (A) = ₹ 2750 (F) + ₹ 3000 (A)$$

$$\text{L.H.S} = \text{R.H.S}$$



**Task** If the closing stock of raw materials is given, how the material variance can be computed?

Standard quantity of materials = 5000 Kgs @ ₹ 5 per Kg

Actual quantity of materials purchased = 5500 Kgs @ ₹ 6 per Kg

Closing stock of raw materials = 300 Kgs

### Material Mix Variance

This kind of variance arises only due to the mixture of various raw materials to produce and to get an output. Normally the process of production involves more than two materials to get the output. For example the firm mixes the raw materials of A & B at the ratio of 3:2. The mixture is called Material Mix.

The above mentioned ratio is being changed by the firm for actual production in producing a unit of product as 4:1.

The change in the material mix due to various reasons, those are following:

1. Inadequate supply of raw materials
2. Price factor of a material
3. Introduction of a new system of production due to expansion
4. Substitution of a material due to better quality and cheaper price than the existing material in current system of procurement.

This material mix variance is highly applicable in the following industries that chemicals, fertilizers, pharmaceuticals, consumables, etc.

The variance should be computed in between two different materials *viz.* Standard quantity of materials and Actual quantity of materials.

Actual quantity of materials is the volume of materials registered the change in the usage of raw materials mixture but the standard quantity of raw materials is totally free from the change of mixture in the raw materials.

While studying the variance, the factors of comparison should be weighed equally with each other. For instance, the standard quantity of material should not be a rational factor of comparison with actual.



**Caution** *Why must the standard quantity of raw material be revised?*

In order to have an appropriate comparison, the standard has to be revised. The early estimated standard is the measure not considered the reality during the production process due to changes occurred in the procurement of raw materials. While comparing the standard with actual, the earlier is not at par with later in terms of realities. To incorporate the realities, the standards are tuned towards the actual; makes the comparison meaningful in studying the variance among the both.

Notes

**When the total standard quantity of materials is equivalent to Actual quantity of materials:** From the below example, the ultimate aim of revising the standard is explained as follows:



*Example:* Before the commencement of production process, the standard mix of materials for the production of one unit of output included two different mixture of quantities of material viz. A&B amounted 70 tons and 30 tons respectively; which formed the 70% and 30% in the production of a unit of out put with the current system of material procurement.

Due to shortage of material A, the firm is required to redesign the material procurement system to have an uninterrupted flow of production of one unit of product. In order to meet out the shortage of raw material A, the firm should replace the shortage only against the adequate supply of material B from the market. The firm should restructure the procurement system of material as follows i.e. 60% of material A and 40% material B. The restructurisation is done only on the actual but not on the standard. While studying the variance analysis in between the quantity of materials, standard of 70% of A and 30% of B should be tuned towards the actual 60% of A and 40% of B procured during the process.

Standard Quantity of Materials		Actual Quantity of Materials	
Material A	70 tons	Material A	60 tons
Material B	30 tons	Material B	40 tons

Revised standard quantity of material

$$\text{Actual Material} = \frac{\text{Standard quantity of Material A/B} \times \text{Total Quantity}}{\text{Total Quantity of Standard Material}}$$

$$\text{For A} = \frac{70}{100} \times 100 = 70 \text{ tons}$$

$$\text{For B} = \frac{30}{100} \times 100 = 30 \text{ tons}$$

Revised Quantity of Material
Revised quantity of Material A = 70 Tons
Revised quantity of Material B = 30 Tons

From the above, if the total quantity of standard materials is equivalent to actual quantity of materials, the revised quantity of materials will be as same as the standard quantity of materials.

**When the total standard quantity of materials is not equivalent to total actual quantity of materials consumed:** If the Standard quantity of materials of X and Y are 60 tons and 40 tons respectively. The actual quantity of materials 90 tons and 60 tons. The total standard quantity of materials and actual quantity of materials amounted 100 tons and 150 tons respectively.

The revised standard mix of materials of X and Y are as follows:

$$X = \frac{60}{100} \times 150 = 90 \text{ tons}$$

$$Y = \frac{40}{100} \times 150 = 60 \text{ tons}$$

$$\text{Material Mix Variance} = \text{Standard Price} (\text{Revised Standard Quantity} - \text{Actual Quantity})$$

From the early discussions, it is clearly understood that the revised standard mix of materials will be the same only during the moment at which the total actual and standard quantity of materials are equivalent to each other and vice versa.



*Example:* From the following information, calculate the materials mix variance.

Materials	Standard	Actuals
A	200 Units @ ₹ 12	160 Units @ ₹ 13
B	100 Units @ ₹ 10	140 Units @ ₹ 10

Due to shortage of material, it was decided to reduce the consumption of A by 15% and increase that of material B by 30%.

The above problem does not have any difference in between the total actual quantity and standard quantity of materials. In both the cases the total quantity of materials are equivalent to 300 units. If both are equivalent to each other, the standard mix would be the revised standard mix of the materials.

**Solution:**

Revised Standard Mix:

$$\text{Material A} = \frac{200}{300} \times 300 \text{ Units} = 200 \text{ units}$$

$$\text{Material B} = \frac{100}{300} \times 300 \text{ Units} = 100 \text{ units}$$

After finding out the revised standard mix of the materials, the changes on the consumption should be incorporated due to the shortage of materials to the tune of actual quantity of materials.

For material A, there is reduction in the actual consumption in the quantity of materials amounted 15%.

For material B, there is spurt increase in the consumption of material B due to fill up the shortage of material A i.e 30% increase on material B.

Final Revised standard Mix of Material A: 200 units - 15% of 200 units = 170 units

B: 100 units + 30% of 100 units = 130 units

Material Mix Variance:

Material Mix Variance = Standard Price (Revised Standard Quantity - Actual Quantity)

MMV Material A = ₹ 12 (170 units - 160 units) = ₹ 120 Favourable

MMV Material B = ₹ 10 (130 units - 140 units) = ₹ 100 Adverse

Total Material Mix Variance = ₹ 20 Favourable.



*Note* The material mix variance is one of the components of material usage variance.

### Material Sub-usage Variance

This is the variance in between standard quantity and revised standard quantity of materials denominated in terms of standard price. The purpose of studying the difference in between these two is to analyse the amount of deviation of the standard against the revised standard in line with the actual fluctuation in the quantity of materials consumption during the production

**Notes**

process. It is the only variance highlights the difference in between the early set standard and the redesigned standard in terms of actual quantity of materials for meaningful comparison.

$$\text{Material Sub-usage Variance} = \text{Standard Cost per unit (Standard Quantity - Revised Standard Quantity)}.$$

If the total actual quantity of materials consumption in units is equivalent to the total standard quantity of materials, nullifies the material sub-usage variance in between the standard quantity of materials and revised standard quantity of materials. It means that the standard quantity of materials of the mix will be the revised standard quantity of materials. If both are equivalent to each other, the variance is equivalent to zero in terms of standard price/cost per unit.



*Example:* Find out the material sub-usage variance from the following:

Materials	Standard	Materials	Actuals
A	60 Kgs @ ₹ 10	A	70Kgs @ ₹ 10
B	40 Kgs @ ₹ 12	B	50Kgs @ ₹ 14

**Solution:**

Revised Standard quantity of Materials:

$$A: \frac{60\text{kgs}}{100\text{kgs}} \times 120 \text{ Kgs} = 72 \text{ Kgs}$$

$$B: \frac{40\text{kgs}}{100\text{kgs}} \times 120 \text{ Kgs} = 48 \text{ Kgs}$$

Material Sub-usage Variance = Standard Price/Cost per unit (Standard Production for Actual Output - Revised Standard Quantity)

$$\text{Material A} = ₹ 10 (60 \text{ Kgs} - 72 \text{ Kgs}) = ₹ 120 \text{ (Adverse)}$$

$$\text{Material B} = ₹ 12 (40 \text{ Kgs} - 48 \text{ Kgs}) = ₹ 96 \text{ (Adverse)}$$

$$\text{Material Sub-usage Variance} = ₹ 216 \text{ (Adverse)}$$

From the above example, it is obviously understood that the early set standard is less than the revised standard quantity of materials due to change in the materials mix consumption, i.e unexpectedly to replace one material with the another due to shortage any one of the materials in the mix. The greater the revised standard quantity of materials means that greater the volatility in the actual consumption of materials. If the variance is adverse, means that the standard which was initially set for comparison has not incorporated the fluctuations in the actual; being less than the revised standard which is an index of actual.

This material sub-usage variance is one of the components of the materials usage variance.

$$\text{Material Usage Variance} = \text{Material Sub-usage Variance} + \text{Material Mix Variance}$$

**Material Yield Variance**

It is one of the components of the material usage variance which arises only due to the deviation in between the standard yield determined and the actual yield accrued. This variance highlights either the abnormal loss of materials or saving of materials. This variance plays most important role in the process industries, to assess the loss/wastage of materials. If the actual loss of materials is different from the standard loss of materials will result the variance in two different situations.



**When the standard and actual do not differ from each other:**

In this case, the yield variance is calculated as follows:

$$\text{Yield Variance} = \text{Standard Rate/Cost per unit (Actual Yield - Standard Yield)}$$

Standard Rate has to be calculated from the following:

$$\text{Standard Rate} = \frac{\text{Standard cost of Standard Mix}}{\text{Net Standard Output (Gross Standard Output - Standard Loss)}}$$

**When the actual mix differs from the standard mix:** In the second case, standard mix has to be tuned to the requirement of actual mix, which is revised standard mix, realistic in sense for meaningful comparison, to highlight the deviation in between two different yields viz. actual yield and revised standard yield. The standard rate has to be calculated only for the revised standard mix of materials.

$$\text{Standard Rate} = \frac{\text{Standard Cost of Revised Standard Mix}}{\text{Net Standard Mix/Output (Gross Standard Output - Standard Loss)}}$$

**Calculate Material Yield Variance**

*Example:* The total standard mix is equivalent to total actual mix

Particulars	Standard		Actual	
	Qty in Kg	Price	Qty in Kg	Price
Material A	90	6	60	5
Material B	60	8	90	9
	150		150	

Normal loss is allowed 10% Actual output 130 units

Revised standard output has to be computed. In this problem, the total mixes are equivalent to each other, but, the normal loss is a loss 10% expected on the normal output. Though, this problem does not have the difference between the mixes, the revised standard mix should have to be computed to register the expected loss (normal loss) on the standard output.

$$\begin{aligned} \text{Revised standard mix} &= \text{Standard Mix} - \text{Normal Loss (Expected Loss)} \\ &= 150 \text{ Kgs} - 10\% \text{ on } 150 \text{ Kgs} = 135 \text{ Kgs} \end{aligned}$$

The next step is to find out the standard rate/price

$$\text{Standard price per unit} = \frac{\text{Standard Cost/Price of Standard Mix}}{\text{Net Standard Mix/Output (Gross Standard Output - Standard Loss)}}$$

$$\frac{(90 \text{ kgs} \times ₹6) + (60 \text{ kgs} \times ₹8)}{135} = \frac{₹540 + ₹480}{135} = \frac{1020}{135} = ₹7.55/-$$

$$\begin{aligned} \text{Material Yield Variance} &= \text{Standard Price (Actual Yield - Revised Standard Yield)} \\ &= ₹7.55 (130 \text{ Units} - 135 \text{ Units}) = ₹7.55 (-5 \text{ Units}) \\ &= ₹37.55 \text{ (Adverse)} \end{aligned}$$

## 9.2.2 Labour Variances

Labour Variance is known in other words as Labour Cost Variance. The cost of the labour is usually denominated by the wages paid/incurred during the production. Labour Variance Analysis, is studying the deviation in between the actual cost of the labour incurred and standard/budgeted cost of the labour. This is another most important cost variance, next to material cost variance,

**Notes**

which considers the rate of the wage per hour for the computation of the total standard cost of labour and actual cost of labour like price of the materials per kg.

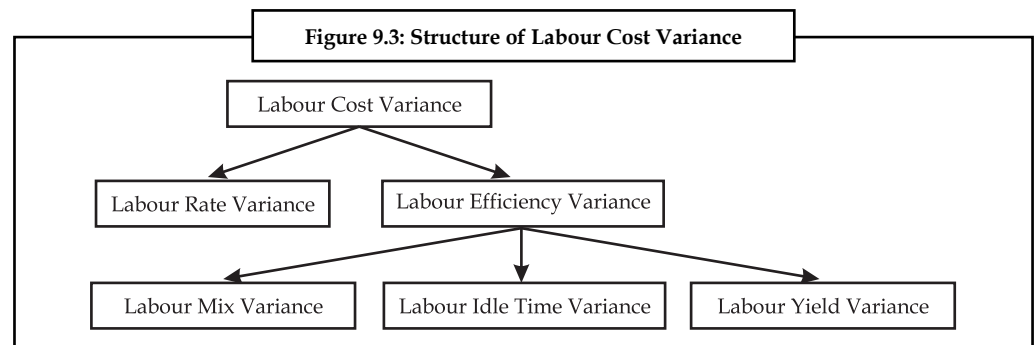
**Labour Cost Variance**

Labour cost variance is the tool studies the deviation in between the total standard cost of the labour and actual cost of labour. The actual labour cost may vary due to many reasons from the planned, i.e standard.

Causes for the variance:

1. The hourly rate of the labour may vary due to demand and supply of the labour force.
2. The hourly rate of the labour may vary due to nature of the labour required, i.e. Skilled/ Semi-Skilled/Unskilled. The rate differs from one category to another due to efficiency of the labours.
3. The Labour cost variance is in relevance with the time component of the job. The time required to complete the job may vary due to too many reasons; more specifically time wastage results in the production.

The following is the structure of the labour cost variance, which will illustrate the various components of the labour variance.



$$\text{Labour Cost Variance} = \text{Standard Cost of the Labour}^* - \text{Actual Cost of Labour}^{**}$$

\* Standard Cost of the Labour = Standard Hours for Actual Output × Standard Hour Wage Rate

\*\* Actual Cost of the Labour = Actual Hours taken for production × Actual Hour Wage Rate



*Example:* The standard time and rate for unit component are given below:

Standard hours 20

Standard rate ₹ 5 per hour

Actual data and related information are as under:

Actual production 1000 units: Actual hours 20,500 hours

Actual rate per hour = ₹ 4.80

Calculate Labour cost variance.

**Solution:**

$$\begin{aligned} \text{Labour Cost Variance} &= \text{Standard Cost of the Labour} - \text{Actual Cost of Labour} \\ &= (\text{SH} \times \text{SR}) - (\text{A.H} \times \text{AR}) \end{aligned}$$

Standard hours for actual production =  $20 \times 1000 \text{ u} = 20,000$

$$\begin{aligned}\text{Labour Cost Variance} &= (20,000 \times 5) - (20,500 \times 4.80) \\ &= 1,00,000 - 98,400 = ₹ 1,600 \text{ (F)}\end{aligned}$$

### Labour Rate or Wage Pay Variance

This is the variance, resultant, due to the change in the wage rate. The Labour rate variance is the difference between standard wage rate, which already determined and the actual wage rate incurred during the production. The variance should be denominated in terms of the actual hours of production.



*Did u know?* Why is the expression in terms of the actual hours?

The actual hours taken is into consideration only for reality, that is the time moments consumed by the production process. This expression facilitates to understand the excessive/lesser amount spent on the labour, which depicts, how much was over/under spent by the firm for the payment of wages than the planned during the production.

The causes of labour wage rate or pay variance:

1. It is due to changes occurred in the structure of basic wages.
2. The ratio of the labour mix is varied due to the nature of the order. Undertaken by the firm to meet the needs of the consumers. The special order from the buyer may require the goldsmith to take more special care in the design of an ornament than the regular or routine design. This leads to involvement of more amount of skilled labour, which finally escalates/increases the cost of the labour.
3. To fulfill the immediate and excessive orders of the consumers which are to be supplied to their requirements leads to greater payment of wages through over time charges; which is normally greater than the regular wage rate.
4. This variance mainly occurs in the industry, which is connected with seasonal business. This variance mainly plays pivotal role in the industries of soft drinks, fans, refrigerator, fertilizer, crackers and so on.

The Labour Rate Variance (LRV) = Actual hours taken (Standard Rate - Actual Rate)



*Example:* The standard time and rate for unit component are given below:

Standard hours 20

Standard rate ₹ 5 per hour

Actual data and related information are as under:

Actual production 1000 units: Actual hours 20,500 hours

Actual rate per hour = ₹ 4.80

Calculate Labour rate variance.

**Solution:**

$$\begin{aligned}\text{Labour Rate Variance} &= \text{Actual hours taken (Standard Rate - Actual Rate)} \\ &= (\text{SR} - \text{AR}) \text{ AH} \\ &= (5 - 4.80) 20,500 \\ &= ₹ 4,100 \text{ (F)}\end{aligned}$$

Notes

**Labour Efficiency Variance**

The efficiency of the labour is denominated only in actual hours for actual output, which should be less than the standard hours expected to perform during the job. The labour efficiency variance is the deviation in between two standard hours for actual output and actual hours taken for actual output. The expression of variance in terms of hours should be expressed in terms of wage rate, i.e. standard wage rate.

*Why the expression should be in the standard wage rate?*

The aim of expressing Efficiency variance in terms of standard wage is to express them in monetary units and should be free from the demand and supply forces of the labour force which directly has an impact on the basic labour wage rate.

$$\text{Labour Efficiency Variance} = \text{Standard Rate (Standard Hours for Actual Output - Actual Hours for Actual Output)}$$

*What are causes of this variance?*

1. Due to poor working conditions, the efficiency of the working force to complete the job is coming down.
2. Quality of maintenance of the machinery is facilitating the working force to maintain the efficiency.
3. Frequent change in the quality of materials may lead change in the hours required to complete the work.
4. Poor personnel relations of the workers.



*Example:* The standard time and rate for unit component are given below:

Standard hours 20

Standard rate ₹ 5 per hour

Actual data and related information are as under:

Actual production 1000 units: Actual hours 20,500 hours

Actual rate per hour = ₹ 4.80

Calculate Labour efficiency variance.

**Solution:**

$$\begin{aligned} \text{Labour Efficiency Variance} &= \text{Standard Rate (Standard Hours for Actual Output - Actual Hours for Actual Output)} \\ &= (\text{SH} - \text{AH}) \text{SR} \\ &= (20,000 - 20,500) 5 = 2,500 \text{ (A)} \end{aligned}$$

**Idle Time Variance**

The wages which are paid for unproductive hours to the labourers are known as idle time.

The idle time may be classified into two categories:

1. Normal idle time
2. Abnormal idle time

**What is normal idle time?****Notes**

This idle time is known as authorised idle time, which can be understood in other words as unavoidable idle time. Normally, the worker is paid for that time during which he does not produce anything.

Time taken by the employees to change the dress.

Time take by the employees to ease themselves during the hours of production i.e going to the toilet for easing and for refreshment going to the canteen.

The employees are paid during the above-enlisted occasions at when they do not produce anything

In between two different shifts, the production of finished goods do not normally take place due to change over the control from one employee to another.

**What is meant by abnormal idle time?**

This is known as avoidable idle time; during which the workers are paid for nil production. This type of idle time could be slashed down or downsized through an effective planning. This idle time is the resultant of too many ineffective schedules, e.g. inadequate supply of raw materials, power shortage/failure, breakdown of machinery and so on. The aforementioned could be easily sorted out through proper planning and scheduling; which will automatically reduce the unproductive time of labour force. Whatever the payment of wages to the working force during the idle time are to be considered as adverse. It means that the firm makes the payment of wages to the labourers/working force without any production/productivity.

$$\text{Idle Time Variance} = \text{Idle hours} \times \text{Standard Rate (Always "A")}$$



*Example:* A group of workers normally consists of 30 men, 15 women and 10 boys. They are paid at standard hourly rates as under:

Men	₹ .80
Women	₹ .60
Boys	₹ .40

In a normal working week of 40 hours, the group is expected to produce 2,000 units of output. During the week ended 31st December 2007, the group consisted of 40 men, 10 women and 5 boys. The actual wages paid were @₹ 70, ₹ 65 and ₹ 30 respectively. 4 hours were lost due to abnormal idle time and 1,600 units were produced.

Calculate labour idle time variance.

**Solution:**

$$\text{Idle time variance} = \text{Idle Hours} \times \text{Standard Rate}$$

First total idle hours of each category should be separately found out, then the obtained idle hours should be multiplied with the standard rate of labour.

Men	= 40 Men × 4 Hours	= 160 Man Hours × .80	= ₹ 128 (Adverse)
Women	= 10 Women × 4 Hours	= 40Man Hours × .60	= ₹ 24(Adverse)
Boys	= 5 Boys × 4 Hours	= 20 Man Hours × .40	= ₹ 8(Adverse)
Total idle time variance		= ₹ 160(Adverse)	

$$\text{Total idle time variance} = 160(\text{Adverse})$$

Notes

**Labour Mix Variance**

This variance arises due to deviations in between the actual mixture of labour force for the job and standard mixture of labour force planned to complete the job. The mixture of work force is considered to be most important for completion. Normally, the mixture is in tri colours viz. Skilled, Semi-Skilled and Unskilled. The standards are prepared by considering the requirements of the job to be completed. For completing the job, 5 skilled, 3 semi-skilled and 2 unskilled employees are required. Due to non-availability of skilled labour force, the firm is required to carry out the operations without any lacuna through the induction of more semi-skilled labour force. The actual composition of the labour force is 2 skilled, 6 semi-skilled and 2 unskilled which finally led to labour mix variance.

Reasons for the labour mix variance:

1. Absenteeism
2. Labour turnover
3. Non-availability of required labour force from the business environment.

The above critical factors directly influence the efficiency of the labour force.

$$\text{Labour Mix Variance} = \text{Standard Rate} (\text{Revised Standard Hours} - \text{Actual Hours})$$

Standard hours for the job were determined for the Standard mixture of labour force but these hours are not denominated to the tune of actual hours taken by the actual mixture of labours force. To study the variance in between them, the standard hours should be in line with the actual. The standard hours which are converted to the tune of actual hours is known as Revised standard hours considered to be level platform for an effective comparison.

$$\text{Labour Mix Variance} = \text{Standard Rate} (\text{Revised Standard Hours} - \text{Actual Hours})$$



*Example:* From the following data, calculate labour mix variance:

	Standard		Actual	
	Hours	Rate	Hours	Rate
Skilled labour	10	3.00	9,000	4.00
Semi-skilled	8	1.50	8,400	1.50
Unskilled	16	1.00	20,000	0.90

The actual production was 1000 articles.

$$\text{Labour Mix Variance} = \text{Standard Rate} (\text{Revised Standard Hours} - \text{Actual Hours})$$

$$\text{Revised Standard Hours (RSH)} = \frac{\text{Standard Hours}}{\text{Total Standard Hours}} \times \text{Total Actual Hours}$$

$$\text{Total standard hours} = 10,000 + 8000 + 16,000 = 34,000$$

$$\text{Total actual hours} = 9000 + 8,400 + 20,000 = 37,400$$

$$\text{RSH: Skilled} = \frac{10,000}{34,000} \times 37,400 = 11,000 \text{ hrs}$$

$$\text{Semi-Skilled} = \frac{8,000}{34,000} \times 37,400 = 8,800 \text{ hrs}$$



$$\text{Unskilled} = \frac{16,000}{34,000} \times 37,400 = 17,600 \text{ hrs}$$

Labour Mix Variance =

$$\text{Skilled} = (11,000 - 9,000) 3 = 6000 \text{ (F)}$$

$$\text{Semi-skilled} = (8,800 - 8,400) 1.50 = 600 \text{ (F)}$$

$$\text{Unskilled} = (17,600 - 20,000) 1 = 2,400 \text{ (F)}$$

$$\text{Total Labour Mix Variance } 4,200 \text{ (F)}$$

### Labour Sub-efficiency Variance

It is one of the components of the labour efficiency variance.

Labour Sub-efficiency Variance = Standard Rate (Standard Hours for Actual Output - Revised Standard Hours)



*Example:* Using the data of above example, calculate the labour sub-efficiency variance:

**Solution:**

Labour Sub-efficiency Variance = Standard Rate (Standard Hours for Actual Output - Revised Standard Hours)

$$= (\text{SH} - \text{RSH}) \text{SR}$$

$$\text{Skilled} = (10,000 - 11,000) 3 = 3,000 \text{ (A)}$$

$$\text{Semi-skilled} = (8,000 - 8,800) 1.50 = 1,200 \text{ (A)}$$

$$\text{Unskilled} = (16,000 - 17,600) 1 = 1,600 \text{ (A)}$$

$$\text{Total Labour Sub-Efficiency Variance } 5,800 \text{ (A)}$$

### Labour Yield Variance

It is considered to be as one of the components of labour efficiency variance. This is a variance in between two different outputs of the enterprise *viz.* standard output for actual hours and actual output.

This is a variance facilitates to study the deviation in between two different levels i.e. how many number of outputs would be produced during the actual hours and how many number of actual outputs were produced during the actual hours.

Labour Yield Variance = Standard Cost per unit (Actual Output - Standard Output in Actual Hours)

OR

= Standard Cost per unit (Actual Yield in Units - Standard Yield in Actual Hours)

If Actual output or Actual yield in units is greater than the standard yield in actual hours, it means that the firm's actual production in units is greater than the standard estimates nothing but favourable to the business enterprise.



*Example:* A group of workers normally consists of 30 men, 15 women and 10 boys. They are paid at standard hourly rates as under:

Notes	Men	₹ .80
	Women	₹ .60
	Boys	₹ .40

In a normal working week of 40 hours, the group is expected to produce 2,000 units of output. During the week ended 31<sup>st</sup> December 2007, the group consisted of 40 men, 10 women and 5 boys. The actual wages paid were @₹ 70, ₹ 65 and ₹ 30 respectively. 4 hours were lost due to abnormal idle time and 1,600 units were produced.

Calculate labour yield variance.

**Solution:**

Labour yield variance = Standard cost per unit (Actual output – Standard output for Actual Hours)

Standard cost per unit should be found out initially, which is as follows:

$$= \frac{\text{Standard cost of the units}}{\text{Standard output}} = \frac{\text{₹1,480}}{2,000 \text{ units}} = .74$$

Standard output for actual hours =  $\frac{\text{Standard output}}{\text{Standard Hours}} \times \text{Actual Effective hours}$

$$= \frac{2,000 \text{ Units}}{2,200 \text{ Hrs}} \times 1,980 \text{ Hrs} = 1,800 \text{ units}$$

$$= .74 (1,600 \text{ units} - 1,800 \text{ units}) = 148 \text{ (Adverse)}$$

The actual yield in units is less than the standard means that it is not favourable for the firm.



*Example:* The standard and actual data of a manufacturing concern are given:

Standard time	2,000 Hrs
Standard rate per hour	₹ 2
Actual time taken	1,900 Hrs
Actual wages paid per hour	₹ 2.50

Calculate labour variances.

**Solution:**

First step is to compute the labour cost variance

$$= (\text{Standard Hrs for Actual Output} \times \text{Standard Rate}) - (\text{Actual Hours} \times \text{Actual Rate})$$

$$= (2,000 \text{ Hrs} \times ₹ 2) - (1,900 \text{ Hrs} \times ₹ 2.50)$$

$$= ₹ 4,000 - ₹ 4,750$$

$$= ₹ 750 \text{ (Adverse)}$$

The next step is to find out the labour rate variance

$$= \text{Actual Hours (Standard Rate - Actual Rate)}$$

$$= 1,900 \text{ Hours (2 - 2.50)} = ₹ 950 \text{ (Adverse)}$$

The next variance is to be found out the labour efficiency variance

$$= \text{Standard Rate (Standard Hours for Actual Output - Actual Hours)}$$

$$= ₹ 2.00 (2,000 - 1,900) = ₹ 200 \text{ (Favourable)}$$

The standard man days in a month are calculated only for the standard output in units, which amounted ₹ 2,500. The calculated figure should be converted into actual units of production i.e. 2400, in order to have meaningful comparison, between standard and actual.

In a nutshell, standard man days in a month for actual output should be computed.

$$= \frac{2000}{2,500} \times 2,400 = 1,920$$

Actual man days in a month = Actual number of men employed × actual number of working days in a month

$$= 90 \times 18 \text{ days in a month} = 1,620 \text{ mandays in a month}$$

First Variance to be Computed is Labour Cost Variance

$$\begin{aligned}&= (\text{Standard Days for Actual output} \times \text{Standard Rate}) - (\text{Actual Days} \times \text{Actual Rate}) \\ &= (1,920 \text{ days} \times \text{₹} 10 \text{ per day}) - (1,620 \text{ days} \times \text{₹} 11 \text{ per day}) \\ &= \text{₹} 19,200 - \text{₹} 17,820 = \text{₹} 1,380 \text{ (Favourable)}\end{aligned}$$

The next step is to find out the labour rate variance

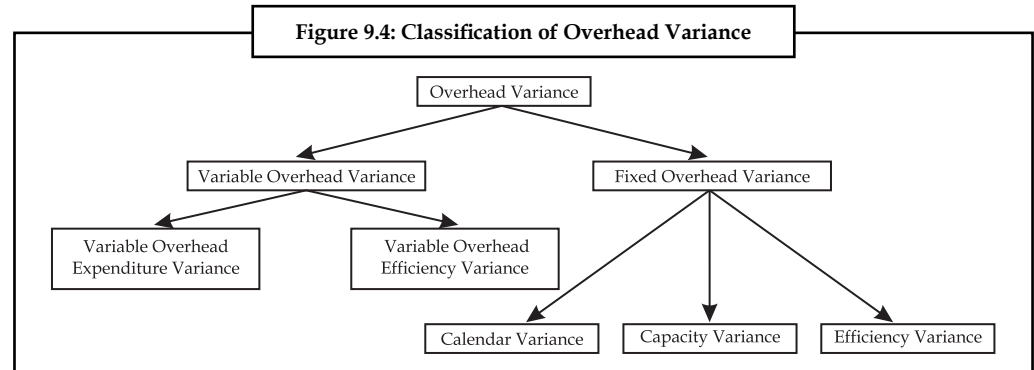

### 9.2.3 Overhead Variances

The following figure explains the classification of overhead variance:



In general, the overhead variance is defined as the variance in between standard cost of overhead estimated for the actual output and actual cost of overhead really incurred.

With reference to absorption overheads, the variance occurs only during either over or under absorption of overheads.

Under absorption of overheads means that the standard cost of the overhead is more than that of the incurred actual overhead. In brief, it is a favourable situation as far as the firm concerned and vice versa in the case of over absorption of overheads.

1. **Variable overhead cost variance:** It is the variance or deviation in between the standard variable overhead for actual production of units and Actual overhead incurred  
 = Standard variable overhead rate per unit × Actual output – Actual variable overheads incurred
2. **Variable overhead expenditure variance:** This is the variance in between the two different rates of variable overheads viz. standard rate and actual rate; denominated in terms of Actual hours taken consumed by the firm.  
 = Actual Hours (Standard Rate – Actual Rate)
3. **Variable overhead efficiency variance:** It is another variance which is in between the standard hours for actual output and actual hours consumed during the production; denominated in terms of standard rate.  
 = Standard Rate (Standard Hours for Actual Output – Actual Hours)
4. **Fixed overhead cost variance:** The most important variance is overhead cost variance  
 = Standard Overhead Cost for Actual Output – Actual Overheads

The second important variance is Budgeted or Expenditure variance

$$= \text{Budgeted Overheads} - \text{Actual Overheads}$$

What is the difference in between the budgeted figures and standards?

Budgeted figures are not adjusted to the actual but the standards could be adjusted or tuned towards the actual.

The next important variance is overhead volume variance

- (a) If the standard overhead rate per unit is given

$$= \text{Standard Rate per Unit (Actual Production – Budgeted Production)}$$

(b) If the standard overhead rate per hour is given

$$= \text{Standard Rate per Hour (Standard Hours for Actual Production - Budgeted Production)}$$

Notes

The next important variance is overhead efficiency variance

(a) If the standard rate per unit is given

$$= \text{Standard Overhead Rate per Unit (Actual Production - Standard Production in Actual Hours)}$$

(b) If the standard rate per hour is given

$$= \text{Standard Overhead Rate per Hour (Actual Hours - Standard Hours for Actual Production)}$$

The last as well as most important variance

(a) If the standard rate per unit is given

$$= \text{Standard Rate per Unit (Standard Production - Actual Production)}$$

(b) When standard rate per hour is given

$$= \text{Standard Rate per Unit (Actual Hours - Budgeted Hours of Production)}$$

Actual hours taken = 640 hours

The overhead efficiency variance could be calculated in two different ways.

The efficiency is expressed in terms of hours and units. If the firm is able to produce the goods or articles in lesser hours of duration, known as more efficient in time management than the standard.



Likewise, the efficiency could be denominated in terms of units of production. If the actual production is more than that of the standard production in units, the firm is favourable in position in producing the articles than the standard.

### Overhead Capacity Variance

The overhead capacity variance mainly depends upon the differences prevailing in between the number of days of actual and budgeted.

If there is any difference in between the number of days of actual and budgeted, the calendar variance will arise.

$$\text{Calendar variance} = (\text{Revised budgeted production} - \text{Budgeted production}) \times \text{Standard rate}$$

$$\text{Capacity variance} = (\text{Standard production} - \text{Revised budgeted production}) \times \text{Standard rate}$$

If there is no difference between the actual and standard calendar variance will not arise; but the capacity variance will prevail.

$$\text{Capacity variance} = (\text{Standard production} - \text{Budgeted production}) \times \text{Standard rate}$$

According to this problem, calendar variance is prevailing.

$$\text{Capacity variance} = (\text{Standard production} - \text{Revised budgeted production}) \times \text{Standard rate}$$

### What is revised budgeted production?

Revised budgeted production is nothing but the budgeted production tuned to the actual production.

$$\text{For 1 day} = 1 \times 8000 \text{ mandays} = 8,000 \text{ units}$$

$$\text{For 20 working days} = 8,000 \text{ units} \times 20 \text{ days} = 1,60,000 \text{ units}$$

Revised budgeted production changes the budgeted production in terms of actual production.

$$\text{For 20 days} = 1,60,000 \text{ units}$$

$$\text{For 22 actual days} = \frac{1,60,000}{20 \text{ days}} \times 22 \text{ days} = 1,76,000 \text{ units}$$

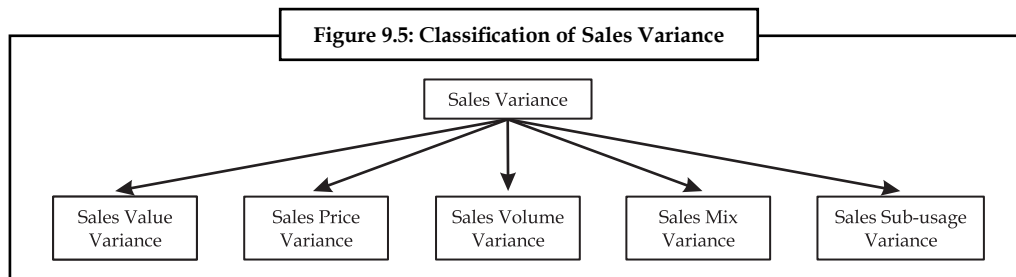

### 9.2.4 Sales Variances

Sales variance is the only component accompanied the profit volume variance of the business transaction. The sales variances are computed and analysed in order to study the effect of sales value and facilitates the sales manager to easily understand the various sales efforts taken by the team.

The sales variance can be classified into various categories. They are as follows:



### Sales Values Variance

The name of the variance is self explanatory in explaining the meaning of the variance, that is difference in between the actual value of sales and standard value of sales.

The causes/influences of sales value variance are many more and some of them highlighted for easy understanding about overall picture.

1. The fluctuation in the selling price may lead to variance with the standard selling price – Selling Price Variance.
2. The fluctuation in the actual volume of sales may be due to various factors, mainly the preference of the buyers over the standard/budgeted volume of sales – Sales Volume Variance.
3. Actual mix of various varieties may differ from the standard mix, which leads – Sales mix variance.
4. Revised standard sales quantity may be varied from the budgeted sales quantity – Sales quantity/Sub-usage variance

$$\text{Sales Value Variance} = \text{Actual Value of Sales} - \text{Standard Value of Sales}$$

The decision criterion is that more the actual sales volume leads to greater and better the position of the firm than the budgeted sales volume, which leads to favourable position for the firm and vice versa.

### Sales Price Variance

It is one of the components as well as influences of the sales variances. It is the variance in between two different prices *viz.* actual price and standard price of the products.

The variance can be computed as follows:

$$\text{Sales Price Variance} = \text{Actual Quantity sold} (\text{Actual Price} - \text{Standard Price})$$

The price variance should be finally expressed in terms of the actual number of goods sold. The main aim of expressing them in actual quantity of goods sold is to express the variance in terms of actual performance in units.

The price variation may be due to many reasons

1. The price variance may be due to changes taken place in the structure of competition. The nature of competition changes due to market potential for example monopoly to duopoly; duopoly to perfect competition and so on; leads to change in the structure of pricing in order to retain the consumer base in line with the business.

**Notes**

2. The price variance may be due to two courses of action, which are as follows:
  - (a) Cost effectiveness strategy and
  - (b) Distinctiveness Strategy.

**Sales Volume Variance**

It is one of the elements of sales variance, which is in between the actual sales quantity and budgeted sales quantity. The variance is normally expressed in terms of price, i.e. standard price. The purpose of expressing the variance in terms of standard price is that price which is free from market forces.

$$\text{Sales Volume Variance} = \text{Standard Price (Actual Quantity of Sale - Standard Quantity of Sales)}$$

The sales volume variance can be divided into two different streams that sales mix variance and sales quantity variance/sub-usage variance.

1. **Sales Mix Variance:** It is the difference in between the actual sales and standard sales mix. This variance will arise only due to change in the proportion of goods sold. This is a most important variance usually computed/calculated, at the moment, the firm which deals more than one commodity.

If both, the standard and actual mixes are equivalent to each other, there will not be any mix variance in between the above mentioned.

If the mixes are totally different from each other, the sales mix variance is to be computed, through the development of revised standard mix of quantities with reference to actual quantities sold, then only the comparison will be meaningful to study the variances occurred in between above mentioned. The sales mix variance is expressed in between two different quantities and finally should be denominated in terms of standard price. The reason for the expression in terms of standard price is the price which is totally free from the demand and supply forces of the market.

$$\text{Sales Mix Variance} = \text{Standard Price (Actual Quantity - Revised Standard Quantity)}$$

2. **Sale Sub-usage Variance:** It is another component of usage variance, which expresses the deviation in between the revised standard quantity to the tune of actual quantities sold and the early set standard quantities expected to sell.

This variance also elucidates the differences of the above mentioned only in terms of standard price, which is the ideal indicator free from the market forces i.e free from fluctuation.

$$\text{Sales Sub-usage Variance} = \text{Standard Price (Revised Standard Quantity - Standard Quantity)}.$$

First step in the process of computing the sales mix variance is the revised standard quantity.

As far as this problem concerned, sales mix variance would not arise due to equivalent mixes dealt in the problem *viz.* standard (budgeted) mix and actual mix amounted 600 each.

Though it is having equal volumes, revised standard quantity can be computed.

$$\text{Revised Standard Quantity} = \frac{\text{Standard Quantity}}{\text{Total Standard Quantity}} \times \text{Total Actual Quantity}$$

$$\text{RSQ for A} = \frac{400}{600} \times 600 = 400$$

$$\text{RSQ for B} = \frac{200}{600} \times 600 = 200$$

### 9.3 Summary

- Material price variance is a variance in between two different prices viz. the standard price and actual price of raw materials.
- Materials Usage Variance = Standard Price × (Standard quantity of materials for actual output - Actual quantity of materials used)
- Material Sub-usage Variance = Standard Cost per unit (Standard Quantity - Revised Standard Quantity).

- Material yield variance is one of the components of the material usage variance which arises only due to the deviation in between the standard yield determined and the actual yield accrued.
- Labour Variance Analysis, is studying the deviation in between the actual cost of the labour incurred and standard/budgeted cost of the labour.
- The overhead variance is defined is as the variance in between standard cost of overhead estimated for the actual output and actual cost of overhead really incurred.
- Sales variances is the only component accompanied the profit volume variance of the business transaction. The sales variances are computed and analysed in order to study the effect of sales value and facilitates the sales manager to easily understand the various sales efforts taken by the team.

### 9.4 Keywords

### **Introduction**

Responsibility accounting is an underlying concept of accounting performance measurement systems. The basic idea is that large diversified organizations are difficult, if not impossible to manage as a single segment, thus they must be decentralized or separated into manageable parts. These parts, or segments are referred to as responsibility centers that include:

1. Revenue centers,
2. Cost centers,
3. Profit centers, and
4. Investment centers

Responsibility accounting is appropriate where top management has delegated authority to make decisions. The idea behind responsibility accounting is that each manager's performance should be judged by how well he or she manages those items under his or her control. This approach allows responsibility to be assigned to the segment managers that have the greatest amount of influence over the key elements to be managed. These elements include revenue for a revenue center (a segment that mainly generates revenue with relatively little costs), costs for a cost center (a segment that generates costs, but no revenue), a measure of profitability for a profit center (a segment that generates both revenue and costs) and return on investment (ROI) for an investment center (a segment such as a division of a company where the manager controls the acquisition and utilization of assets, as well as revenue and costs).

## **10.1 Responsibility Centers**

The concept of responsibility accounting has emerged to accommodate the need for management information at a more specific level of detail than can be provided by financial accounting procedures. Responsibility accounting attempts to report results (actual performance) in such a way that:

1. significant variances from planned performance can be identified,
2. reasons for variances can be determined,
3. responsibility can be fixed, and
4. timely action can be taken to correct problems.

Under this approach, pertinent costs and revenues are assigned to various organizational units – departments, bureaus, and programs – designated as responsibility centers. A decentralized environment results in highly dispersed decision making. As a result, it is imperative to monitor and judge the effectiveness of each manager. This is easier said than done. Not all units are capable of being evaluated on the same basis. Some units do not generate any revenue; they only incur costs in support of some necessary function. Other units that deliver goods and services have the potential to be assessed on the basis of profit generation.

As a generalization, the part of an organization under the control of a manager is termed a "responsibility center." To aid performance evaluation it is first necessary to consider the specific character of each responsibility center. Some responsibility centers are cost centers and others are profit centers. On a broader scale, some are considered to be investment centers. The logical method of assessment will differ based on the core nature of the responsibility center.

### **10.1.1 Cost Center**

A cost center is the smallest segment of activity or area of responsibility for which costs are accumulated. Obviously most business units incur costs, so this alone does not define a cost center. A cost center is perhaps better defined by what is lacking; the absence of revenue, or at least the absence of control over revenue generation.

Human resources, accounting, legal, and other administrative departments are expensive to support and do not directly contribute to revenue generation. Cost centers are also present on the factory floor. Maintenance and engineering fall into this category. Many businesses also consider the actual manufacturing process to be a cost center even though a saleable product is produced (the sales "responsibility" is shouldered by other units).

It stands to reason that assessments of cost control are key in evaluating the performance of cost centers. This unit will show how standard costs and variance analysis can be used to pinpoint areas where performance is above or below expectation. Cost control should not be confused with cost minimization. It is easy to reduce costs to the point of destroying enterprise effectiveness.

**Notes**

The goal is to control costs while maintaining enterprise effectiveness.

Non-financial metrics are also useful in monitoring cost centers: documents processed, error rates, customer satisfaction surveys, and other similar measures can be used.



- Example:* 1. The manager for purchasing department.  
2. The manager for maintenance department.

### 10.1.2 Revenue Center

Revenue center can be defined as a distinctly identifiable department, division, or unit of a firm that generates revenue through sale of goods and/or services.



*Example:* Rooms department and food and beverages department of a hotel.

### 10.1.3 Profit Center

Some business units have control over both costs and revenues and are therefore evaluated on their profit outcomes. For such profit centers, “cost overruns” are expected if they are coupled with commensurate gains in revenue and profitability.



*Example:* A restaurant chain may evaluate each store as a separate profit center. The store manager is responsible for the store’s revenues and expenses. A store with more revenue would obviously generate more food costs; an assessment of food cost alone would be foolhardy without giving consideration to the store’s revenues.

Thus profit center is a segment of a business, often called a division that is responsible for both revenue and expenses. The reason been Revenue minus Cost is the Profit.

The manager is therefore overall responsible or accountable for making profit for the company.



*Example:* A company has many restaurants which are all profit centre. A manager is assigned to each restaurant to make sure it is a profit centre.

### 10.1.4 Investment Center

At higher levels within an organization, unit managers will be held accountable not only for cost control and profit outcomes, but also for the amount of investment capital that is deployed to achieve those outcomes. In other words, the manager is responsible for adopting strategies that generate solid returns on the capital they are entrusted to deploy. Evaluation models for investment centers become more complex and diverse. They usually revolve around various calculated rates of returns.

Thus an investment center, like a profit center, is responsible for both revenue and expenses, but also for related investments of capital.



*Example:* An example of an investment centre is a Corporate division responsible for project investments.

Here, the manager is responsible for the investments which includes all the revenue, costs and investments (invested capital or assets).

Outside of relatively large corporations, the cost center is the most common building block for responsibility accounting. In fact, the terms cost center and responsibility center are often used interchangeably.

## 10.2 Controllability Concept

An underlying concept of responsibility accounting is referred to as controllability. Conceptually, a manager should only be held responsible for those aspects of performance that he or she can control. In my view, this concept is rarely, if ever, applied successfully in practice because of the system variation present in all systems. Attempts to apply the controllability concept produce responsibility reports where each layer of management is held responsible for all subordinate management layers. The managers thus, should take care of certain essential elements to ensure adequate responsibility accounting.

### Relevance

The convention of relevance emphasizes the fact that only such information should be made available by accounting as is relevant and useful for achieving its objectives.



*Example:* Business is interested in knowing as to what has been total labor cost? It is not interested in knowing how much employees spend and what they save.

### Objectivity

The convention of objectivity emphasizes that accounting information should be measured and expressed by the standards which are commonly acceptable.



*Example:* Stock of goods lying unsold at the end of the year should be valued as its cost price not at a higher price even if it is likely to be sold at higher price in future. Reason is that no one can be sure about the price which will prevail in future.

**Feasibility**

The convention of feasibility emphasizes that the time, labour and cost of analyzing accounting information should be compared vis-à-vis benefit arising out of it.



*Example:* The cost of 'oiling and greasing' the machinery is so small that its break-up per unit produced will be meaningless and will amount to wastage of labor and time of the accounting staff.

**10.3 Accounting Concepts**

Responsibility accounting is based on certain concepts. They are utmost important to be followed while accounting the responsibility. A detailed discussion on each of them follows.

**Materiality**

It refers to the relative importance of an item or event. Those who make accounting decisions continually confront the need to make judgments regarding materiality. Is this item large enough for users of the information to be influenced by it?

The essence of the materiality concept is the omission or misstatement of an item is material if, in the light of surrounding circumstances, the magnitude of the item is such that it is probable that the judgment of a reasonable person relying on the report would have been changed or influenced by the inclusion or correction of the item.

**Accounting Period**

Though accounting practice believes in continuing entity concept i.e. life of the business is perpetual but still it has to report the 'results of the activity undertaken in specific period (normally one year). Thus, accounting attempts to present the gains earned or losses suffered by the business during the period under review. Normally, it is the calendar year (1st January to 31st December) but in other cases it may be financial year (1st April to 31st March) or any other period depending upon the convenience of the business or as per the business practices in country concerned.

Due to this concept it is necessary to take into account during the accounting period, all items of revenue and expenses accruing on the date of the accounting year. The problem confronting this concept is that proper allocation should be made between capital and revenue expenditure. Otherwise the results disclosed by the financial statements will be affected.

**Realization**

This concept emphasizes that profit should be considered only when realized. The question is at what stage profit should be deemed to have accrued? Whether at the time of receiving the order

or at the time of execution of the order or at the time of receiving the cash. For answering this question the accounting is in conformity with the law and recognizes the principle of law, i.e. the revenue is earned only when the goods are transferred. It means that profit is deemed to have accrued when 'property in goods passes to the buyer' viz. when sales are affected.

### Matching

Though the business is a continuous affair yet its continuity is artificially split into several accounting years for determining its periodic results. This profit is the measure of the economic performance of a concern and as such it increases proprietor's equity. Since profit is an excess of revenue over expenditure it becomes necessary to bring together all revenues and expenses relating to the period under review. The realization and accrual concepts are essentially derived from the need of matching expenses with revenues earned during the accounting period. The earnings and expenses shown in an income statement must both refer to the same goods transferred or services rendered during the accounting period. The matching concept requires that expenses should be matched to the revenues of the appropriate accounting period. So we must determine the revenue earned during a particular accounting period and the expenses incurred to earn these revenues.

### Entity

According to this concept, the task of measuring income and wealth is undertaken by accounting, for an identifiable Unit or Entity. The unit or entity so identified is treated different and distinct from its owners or contributors. In law the distinction between owners and the business is drawn only in the case of joint stock companies but in accounting this distinction is made in the case of sole proprietor and partnership firm as well.



*Example:* Goods used from the stock of the business for business purposes are treated as a business expenditure but similar goods used by the proprietor, i.e. owner for his personal use are treated as his drawings.

Such distinction between the owner and the business unit has helped accounting in reporting profitability more objectively and fairly. It has also led to the development of "responsibility accounting" which enables us to find out the profitability of even the different sub-units of the main business.

### Stable Monetary Unit

Accounting presumes that the purchasing power of monetary unit, say Rupee, remains the same throughout.

For example, the intrinsic worth of one Rupee is same and equal in the year 1900 and 2000 thus ignoring the effect of rising or falling purchasing power of monetary unit due to deflation or inflation. In spite of the fact that the assumption is unreal and the practice of ignoring changes in the value of money is now being extensively questioned, still the alternatives suggested incorporating the changing value of money in accounting statements viz., Current Purchasing Power method (CPP) and Current Cost Accounting method (CCA) are in evolutionary stage. Therefore, for the time-being we have to be content with the 'stable monetary unit' concept.

### Cost

This concept is closely related to the going concern concept. According to this, an asset is ordinarily recorded in the books at the price at which it was acquired, i.e. at its cost price. This 'cost' serves the basis for the accounting of this asset during the subsequent period. This 'cost' should not be confused with 'value'.

**Notes**

It must be remembered that as the real worth of the assets changes from time to time, it does not mean that the value of such an asset is wrongly recorded in the books. The book value of the assets as recorded does not reflect their real value. It does not signify that the values noted therein are the values for which they can be sold. Though the assets are recorded in the books at cost, in course of time, they become reduced in value on account of depreciation charges. In certain cases, only the assets like 'goodwill' when paid for will appear in the books at cost and when nothing is paid for, it will not appear even though this asset exists on name and fame created by a concern.

Therefore, the values attached to the assets in the balance sheet and the net income as shown in the Profit and Loss account cannot be said to reflect the correct measurement of the financial position of an undertaking, as they do not have any relation to the market value of the assets or their replacement values. This idea that the transactions should be recorded at cost rather than at a subjective or arbitrary value is known as Cost Concept. With the passage of time, the market value of fixed assets like land and buildings vary greatly from their cost.

These changes or variations in the value are generally ignored by the accountants and they continue to value them in the balance sheet at historical cost. The principle of valuing the fixed assets at their cost and not at market value is the underlying principle in cost concept. According to them, the current values alone will fairly represent the cost to the entity.

The cost principle is based on the principle of objectivity. The supporters of this method argue so long as the users of the financial statements have confidence in the statements, there is no necessity to change this method.

**Conservatism**

This concept emphasizes that profit should never be overstated or anticipated. Traditionally, accounting follows the rule "anticipate no profit and provide for all possible losses.



*Example:* The closing stock is valued at cost price or market price, whichever is lower.

The effect of the above is that in case market price has come down then provide for the 'anticipated loss' but if the market price has gone up then ignore the 'anticipated profits'.

Critics point out that conservation to an excess degree will result in the creation of secret reserve. This will be quite contrary to the doctrine of disclosure. However, conservatism to a reasonable degree may not come in for criticism.

**10.4 Advantages and Disadvantages of Responsibility Accounting**

Responsibility accounting has been an accepted part of traditional accounting control systems for many years because it provides an organization with a number of advantages. Perhaps the most compelling argument for the responsibility accounting approach is that it provides a way to manage an organization that would otherwise be unmanageable.

1. In addition, assigning responsibility to lower level managers allows higher level managers to pursue other activities such as long term planning and policy making.
2. It also provides a way to motivate lower level managers and workers.
3. Managers and workers in an individualistic system tend to be motivated by measurements that emphasize their individual performances.

However, this emphasis on the performance of individuals and individual segments creates what some critics refer to as the “stovepipe organization.” Others have used the term “functional silos” to describe the same idea.

1. Information flows vertically, rather than horizontally.
2. Individuals in the various segments and functional areas are separated and tend to ignore the interdependencies within the organization.
3. Segment managers and individual workers within segments tend to compete to optimize their own performance measurements rather than working together to optimize the performance of the system.

Thus it can be said that an implicit assumption of responsibility accounting is that separating a company into responsibility centers that are controlled in a top down manner is the way to optimize the system. However, this separation inevitably fails to consider many of the interdependencies within the organization. Ignoring the interdependencies prevents teamwork and creates the need for buffers such as additional inventory, workers, managers and capacity. Of course, a system that prevents teamwork and creates excess is inconsistent with the lean enterprise concepts of just-in-time and the theory of constraints. For this reason, critics of traditional accounting control systems advocate managing the system as a whole to eliminate the need for buffers and excess. They also argue that companies need to develop process oriented learning support systems, not financial results, fear oriented control systems. The information system needs to reveal the company’s problems and constraints in a timely manner and at a disaggregated level so that empowered users can identify how to correct problems, remove constraints and improve the process. According to these critics, accounting control information does not qualify in any of these categories because it is not timely, disaggregated, or user friendly.

This harsh criticism of accounting control information leads us to a very important controversial question. Can a company successfully implement just-in-time and other continuous improvement concepts while retaining a traditional responsibility accounting control system? Although the jury is still out on this question, a number of field research studies indicate that accounting based controls are playing a decreasing role in companies that adopt the lean enterprise concepts. In a recent study involving nine companies, each company answered this controversial question in a different way by using a different mix of process oriented versus results oriented learning and control information. Since each company is different, a generalized answer to this question for all firms in all situations cannot be provided.



Case Study

### Out to Lunch Cuisine Inc.

Out to Lunch was established in Vancouver, Canada, in 1985. It is a rapidly growing fast-food restaurant chain.

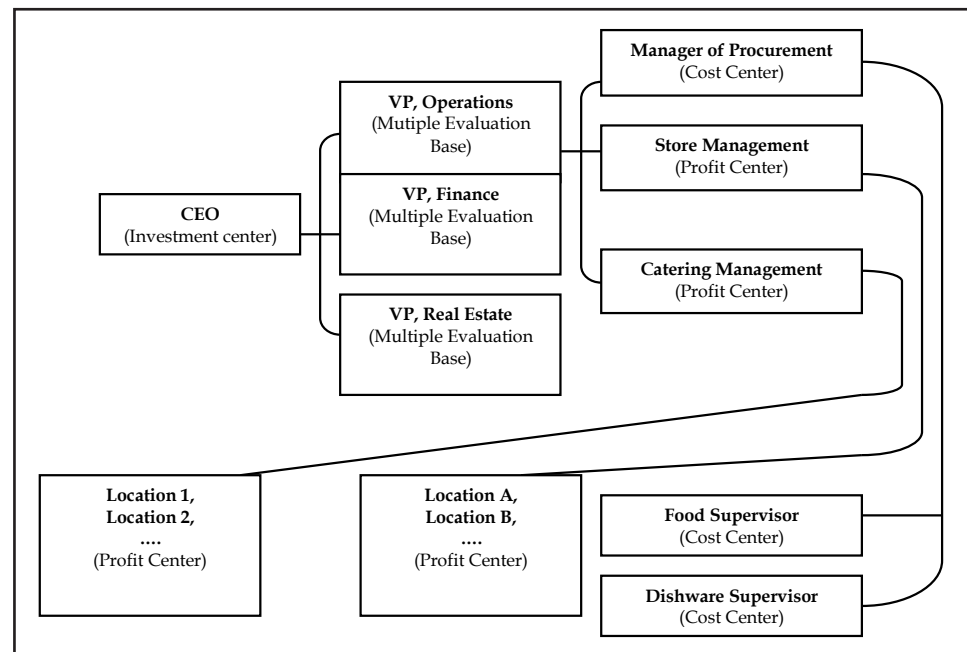
Their business model revolves around a uniquely flavored hamburger, and a very simple menu consisting of a hamburger, fries, and drinks. They provide simple “round number” pricing, few products, and rapid service. Out to Lunch also has a catering service for sporting events, corporate outings, and similar occasions.

Refer to the chart below to understand the working of OTL Cuisine Inc. The blocks in the organization chart indicate the character of performance/responsibility evaluation that is germane to each position. The Chief Executive Officer reports to the owners, and the owners are primarily interested in their return on investment. Three vice presidents report to the CEO:

1. The VP of operations is responsible for the overall investment in operations, which is driven heavily by the combined profits of each store. The VP of Operations oversees procurement, store management, and catering management.
  - (a) The Procurement Manager oversees purchasing of food and dishware.
    - (i) The Procurement activities are evaluated as cost centers, relying on budgets and standard costs to control activities.
  - (b) The Store and Catering managers oversee supervisors from each location.
    - (i) The Store and Catering Managers are responsible for producing profits, and are evaluated accordingly.
2. The VP of Finance is viewed and evaluated as a cost center.
3. The VP of Real Estate is responsible for site acquisition and construction. Although the activities are largely viewed in the context of a cost center, there is an expected rate of return for each new real estate investment. Therefore, the VP of Real Estate is evaluated for cost control and return on investments.



The accounting system of the company supports preparation of an accounting report for each responsibility center. This information is essential to monitor, control, and direct each business unit. Each individual store has a customized performance report. Often, the reports provide a comparison between budgeted and actual data, with the difference being reported as a variance from budget. These performance reports are consistent with the organizational structure of the firm. At successively higher levels within the organization, the reports tend to include less transaction specific detail and more combinations of business units.

Notice that Location A’s performance report is very detailed, and provides a basis for analysis of numerous facets of the business. Graphics are frequently used to facilitate understanding by those not accustomed to accounting reports. For example, each store supervisor knows that fries and drinks have the highest profit margins and they are encouraged to train employees to soft-sell these items by asking customers “what type of drink did you prefer?” rather than “did you want a drink with this order?” As a result, the report is “specialized” to show the product mix proportions. In addition, each manager gets a bonus if food costs are below 20% of sales; this incentive is designed to reduce food waste and encourage sales of high margin products. The report provides sufficient detail to show if the objectives are being met. Notice that unfavorable variances are highlighted in red. Summarizing the results for Location A, note that the budgeted goal for hamburger sales was not met. But, the profit objectives were nevertheless exceeded because the product mix of fries and drinks produced offsetting higher margins. In addition Location A managed to contain other variable costs.

The next step up in the organizational chart is the Senior Manager of Store Operations. This person is concerned with making sure that each unit is profitable. Underperforming stores are identified, problems are studied, and corrective measures are taken. Very little time is spent on locations that are meeting or exceeding corporate profit goals. Although this manager has access to the detailed reports for each store, the performance report of interest is a compilation of summary data for each location that quickly highlights the areas of needed improvement. Review the following performance report, noting the carry forward of Location A’s data into the report. Obviously, some stores are performing much better than others; the senior manager will certainly want to focus on store E immediately! Also notice that there is \$1,500,000 of fixed costs associated with store operations that are not traceable to any specific location; nevertheless, the senior manager of store operations must control this cost and it is subtracted in calculating the overall margin. Thus, the total fixed cost for all store operations is \$9,500,000 (\$8,000,000 + \$1,500,000).

Continuing up the organizational chart, the VP of Operations will focus on summary data from store management, catering management, and procurement. Notice that the “stores” column (below) is derived from information found in the “combined” column (above). Again, note the presence of fixed costs that are not traceable to any specific operating segment (\$1,300,000). Even though this cost is not assigned to a specific segment, it remains a cost for which the VP of Operations is responsible.

10.5 Transfer Pricing

Large business units are usually organised into different divisions for better control. In such a situation, if one division supplies its finished output as input to other division, there arises a very important issue. The issue being at which price should be transferring unit transfer its product or service. Such price is known as transfer price.

Transfer prices are the amounts charged by one segment of an organization for a product or service that it supplies to another segment of the same organization.



Transfer price in simple words is the price that one sub-unit (segment, department, division and so on) of an organization charges for a product or service supplied to another subunit of the same organization. It is different from the normal price in that both divisions are a part of the same organisation and therefore it is only an internal transfer and not sale. The pricing of these flows is likely to have an impact on the performance evaluation of the divisions. Setting of transfer pricing policies within the company is of great significance. The important issue now is at what price should such transfers be made.



*Did u know? Why do transfer-pricing systems exist?*

1. To communicate data that will lead to goal-congruent decisions.
2. To evaluate segment performance and thus motivate managers toward goal-congruent decisions.
3. Multinational companies use transfer pricing to minimize their worldwide taxes, duties, and tariffs. Ideally, the chosen transfer-pricing method should lead each subunit manager to make optimal decisions for the organization as a whole. The three specific criteria that can help in choosing a transfer-pricing method are:
  - (a) *Promotion of Goal Congruence:* Goal congruence exists when each divisional or sub-unit manager acting in his or her own best interest takes actions that automatically result in achieving the organisation goals established by top management.
  - (b) *Promotion of a Sustained High Level of Management Effort:* Effort is defined as exertion towards a goal, for example, sellers are motivated to hold down costs of supplying product or service, and buyers are motivated to acquire and use inputs efficiently. The environment in the organisation should be such that a sustained high level of management effort is promised.
  - (c) *Promotion of a High Level of Subunit Autonomy in Decision-making:* Autonomy is the degree of freedom a division manager can exercise in decisions making. If top management favours a high degree of decentralization, this criterion is of particular importance.

Transfer pricing is a critical issue in the organisation. This is because the transfer price decides:

4. The revenue of the supplying division thus influences divisional profit; and
5. The cost of the receiving division thus influences divisional profit.

### 10.5.1 Objectives of Transfer Pricing

Some of the more important objectives of transfer pricing are as follows:

1. **Evaluating Divisional Performance:** Prices can be set in order to arrive at a valid measure of divisional profit for performance evaluation purposes. This should be of value to central management in allocating resources between divisions.
2. **Improving the Quality of Decisions:** Transfer pricing may help divisional managers to take better decisions. Prices can be used to determine how much of a product or service a particular division is prepared to sell and how much a division is prepared to buy. This can help in the efficient use of resources within a division.
3. **Promoting Autonomy:** Transfer pricing can help in promoting the autonomy of division. Divisional managers can make independent decisions concerning whether or not they wish

to trade with other divisions based on the transfer prices which are quoted. This should help in supporting the policy of divisionalisation of the business.

4. **Allocation of Profit:** Transfer pricing can be used to allocate the profits of a multinational business to division operating in particular countries. The allocation process may be designed to minimise the liability of the business as a whole or to minimise taxation and duties. In addition, it is sometimes also used to avoid restrictions on the transfer of profit within a division that is situated in a country where taxes and duties are low and to report low levels of profit within a division where taxation and duties are high. This policy will enable the business, as a whole, to reduce its total liability to taxation (it should be noted that some taxation authorities will object to this practice if they believe this is simply a tax avoidance measure).

### 10.5.2 Transfer Pricing Methods

There are three general methods for determining transfer prices:

1. **Market-based Transfer Prices:** One of the most rational and practical basis of determining transfer price is the market price. A company may choose to use the price of a similar product or service publicly listed in, say a trade journal. Also, a company may select for its internal price the external price that a division charges to outside customers.

Under certain circumstances deviation from market oriented transfer price may be justified. Some instances are:

- ❖ Where the products involved are highly specialised and a ready market does not exist, market-price determination will be more difficult.
  - ❖ Where it is necessary to take advantage of economies of scale in the production of some goods or services.
  - ❖ When it is necessary to shift resources from low priority to high priority divisions.
  - ❖ Where considerations of taxation are applicable.
2. **Cost-based Transfer Prices:** The basis for transfer price can even be any price that is cost based. Examples of cost-based transfer prices include variable manufacturing costs, full manufacturing (absorption) costs, and full product costs. Full product costs include all production costs as well as costs from other business functions (R&D, design, marketing, distribution and customer service). This method of transfer pricing is normally used when a perfect market does not exist for the product. The division cost in this could be actual cost, standard cost, budgeted cost or marginal cost. The company has to decide which type of the above stated cost is to be taken into account for transfer pricing.
  3. **Negotiated Transfer Prices:** In some cases, the divisions of a company are free to negotiate the transfer price between themselves. In the process of negotiation, divisions may use information about costs and market prices. However, there is no requirement that the chosen transfer price to have any specific relationship to either cost or market price data. Negotiated transfer prices are often employed when market prices are volatile. The negotiated transfer price is the outcome of a bargaining process between the selling and the buying divisions. This price normally is based on manufacturing costs plus an extra percentage added to approximate it to market price.
  4. **Variable-Cost Pricing**
    - ❖ When market prices cannot be used, versions of "cost-plus-a-profit" are often used as a fair substitute.

- ❖ In situations where idle capacity exists, variable cost would generally be the better basis for transfer pricing and would lead to the optimum decision for the firm as a whole.

There is a large amount of documented sources on the transfer pricing policies used by companies all over the world. These studies have documented various aspects of transfer pricing policies such as:

- Its role as an overall component of reporting and control system in companies.
- The effect of transfer pricing on intra-corporate conflicts.
- Variations in transfer pricing policies across the world, and environmental constraints on use of transfer prices.

### Introduction

It is one of the premier tools of management not only to take decisions but also to fix an appropriate price and to assess the level of profitability of the products/services. This is a only costing tool demarcates the fixed cost from the variable cost of the product/service in order to guide the firm to know the minimal point of sales to equate the cost of production. It is a tool of analysis highlighting the relationship in between the cost, volume of sales and profitability of the firm.

**11.1 Absorption Costing**

Absorption costing technique is also known by other names as “Full costing” or “Traditional costing”. According to this technique, all costs are recognised or identified with the products manufactured. Both fixed and variable costs of each product manufactured are taken into account to ascertain the total cost.

According to author, the absorption costing tells as to how much fixed cost is absorbed besides the variable cost by each product manufactured. According to this technique, while the variable costs are directly charged to each unit of the goods produced, the fixed costs are distributed to each category of product manufactured by the same firm. In absorption costing, “Fixed cost” will also be taken into account in ascertaining the profit on sale.

This technique is called traditional costing, as this system of costing emerged from the beginning of the factory stage. In this technique, “fixed cost” refers to the closing stock of material held by the firm. These are charged against the sales later, as a part of the goods sold.

The traditional technique popularly known as total cost or absorption costing technique does not make any difference between fixed and variable cost in the calculation of profit.

**Limitations of Absorption Costing**

The following are the limitations of absorption costing:

1. In absorption costing, a portion of fixed cost is carried over to the subsequent accounting period as part of closing stock which is an unsound practice because costs pertaining to a period should not be allowed to be vitiated by the inclusion of costs pertaining to the previous period and vice-versa.

- Absorption costing is dependent on the levels of output which may vary from period to period, and consequently cost per unit changes due to the existence of fixed overhead. Unless fixed overhead rate is based on normal capacity, such changed costs are not helpful for the purposes of comparison and control.
- The cost to produce an extra unit is variable production cost. It is realistic to the value of closing stock items as this is a directly attributable cost. The size of total contribution varies directly with sales volume at a constant rate per unit. For the decision-making purpose of management, better information about expected profit is obtained from the use of variable costs and contribution approach in the accounting system.

### 11.2 Marginal Costing

According to ICMA, London, "Marginal cost is the amount at any given volume of output, by which aggregate costs are charged, if the volume of output is increased or decreased by one unit."

Marginal cost is the cost nothing but a change occurred in the total cost due to changes taken place on the level of production i.e either an increase/decrease by one unit of product.



*Example:* The firm XYZ Ltd. incurs ₹ 1000 for the production of 100 units at one level of operation. By increasing only one unit of product i.e. 101 units, the firm's total cost of production amounted ₹ 1010.

Total cost of production at first instance ( $C'$ ) = ₹1000

Total cost of production at second instance ( $C''$ ) = ₹1010

Total number of units during the first instance ( $U'$ ) = 100

Total number of units during the second instance ( $U''$ ) = 101

Increase in the level of production and Cost of production:

Change in the level of production in units =  $U'' - U' = \Delta U$

Change in the total cost of production =  $C'' - C' = \Delta C$

$$\text{Marginal Cost} = \frac{\text{Change (Increase) in the Total Cost of Production}}{\text{Change (Increase) in the Level of Production}} = \frac{\Delta C}{\Delta U} = \frac{\text{₹ } 10}{1} = \text{₹ } 10$$

If the same firm reduces the total volume from 100 units to 99 units, the total cost of production ₹ 990/-

Decrease in the level of production and cost of production:

$$\text{Marginal Cost} = \frac{\text{Change (Increase) in the Total Cost of Production}}{\text{Change (Increase) in the Level of Production}} = \frac{\Delta C}{\Delta U} = \frac{\text{₹ } 10}{1} = \text{₹ } 10$$

*Did u know? Why marginal cost is called as incremental cost?*

From the above example, it is obviously understood that marginal cost is nothing but a cost which incorporates the incremental changes in the cost of production due to either an increase or decrease in the level of production by one unit, meant as incremental cost.

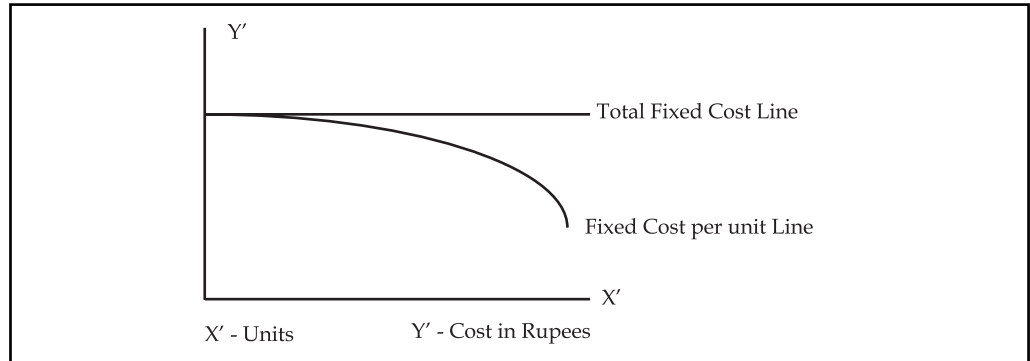

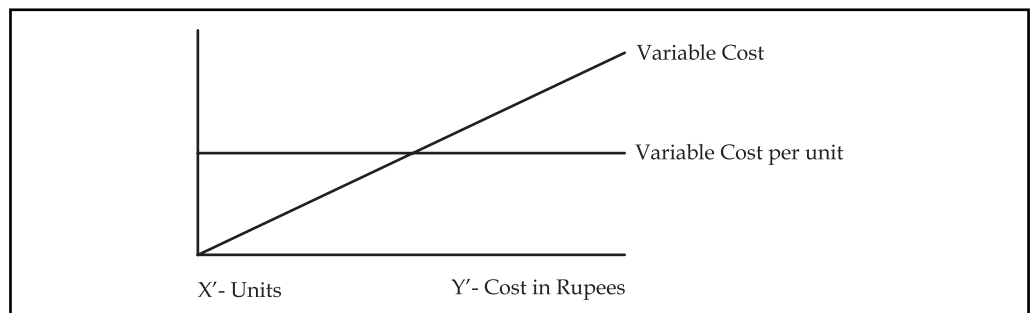
**Fixed Cost:** It is a cost remains constant or fixed irrespective level of production.



*Example:* Rent ₹ 500 is to be paid irrespective level of production. It remains constant/ fixed irrespective of changes taken place on the level of production.



**Variable cost:** It is a cost, which varies with level of production.





The following are the various components of variable cost:

1. **Direct Materials:** Materials cost consumed for the production of goods.
2. **Direct Labour:** Wages paid to the labourers who directly involved in the production of goods.
3. **Direct Expenses:** Other expenses directly involved in the production stream.
4. **Variable portion of Overheads:** Generally the overheads can be classified into two categories, viz. Variable overheads and Fixed overheads.

The variable overhead is the cost involved in the procurement of indirect materials, indirect labour and indirect expenses.

Indirect Material – Cost of fuel, oil and so on

Indirect Labour – Wages paid to workers for maintenance of the firm.

From the Table 11.1 the marginal cost is equivalent to the variable cost per unit of the various levels of production. The fixed cost of ₹ 500 is the cost remains the same at not only irrespective levels of production but also already absorbed at the initial level of production. The initial absorption of fixed overhead led the marginal cost to become as variable cost.

**Semi-variable cost:** Another major classification is semi variable/fixed cost which is a cost partly fixed/variable to the certain level of production or consumption, e.g. Electricity charges, telephone charges and so on.

It jointly discards the importance of the fixed cost and the semi- variable cost for analysis while ascertaining the marginal cost.

Marginal Costing is defined as “the ascertainment of marginal cost and of the effect on profit of changes in volume or type of output by differentiating between fixed and variable costs.”



**Caution** In marginal costing, the change in the level of cost of operation is equivalent to variable cost due to fixed cost component which is fixed irrespective level of outputs.



**Example:** The following figures are extracted from the books of KSBS Ltd. Find out profit by using marginal costing and absorption costing. Is there any variations in the results obtained under the two methods is given below?

### **11.3 Costs-Volume Profit Analysis**

The Cost-Volume-Profit (CVP) analysis helps management in finding out the relationship of costs and revenues to profit. The aim of an undertaking is to earn profit. Profit depends upon a large number of factors, the most important of which are the costs of the manufacturer and the volume of sales effected. Both these factors are interdependent – volume of sales depends upon the volume of production, which in turn is related to costs. Cost again is the result of the operation of a number of varying factors such as:

1. Volume of production,
2. Product mix,
3. Internal efficiency,
4. Methods of production,
5. Size of plant, etc.

Of all these, volume is perhaps the largest single factor which influences costs which can basically be divided into fixed costs and variable costs. Volume changes in a business are a frequent occurrence, often necessitated by outside factors over which management has no control and as costs do not always vary in proportion to changes in levels of output, management control of the factors of volume presents a peculiar problem.

As profits are affected by the interplay of costs and volume, the management must have, at its disposal, an analysis that can allow for a reasonably accurate presentation of the effect of a change in any of these factors which would have no profit performance. Cost-volume-profit analysis furnishes a picture of the profit at various levels of activity. This enables management to distinguish between the effect of sales volume fluctuations and the results of price or cost changes upon profits. This analysis helps in understanding the behaviour of profits in relation to output and sales.

Fixed costs would be the same for any designated period regardless of the volume of output accomplished during the period (provided the output is within the present limits of capacity). These costs are prescribed by contract or are incurred in order to ensure the existence of an operating organisation. Their inflexibility is maintained within the framework of a given combination of resources and within each capacity stage such costs remain fixed regardless of the changes in the volume of actual production. As fixed costs do not change with production, the amount per unit declines as output rises.

Absorption or full costing system seeks to allocate fixed costs to products. It creates the problem of apportionment and allocation of such costs to various products. By their very nature, fixed costs have little relation to the volume of production.

Variable costs are related to the activity itself. The amount per unit remains the same. These costs expand or contract as the activity rises or falls. Within a given time span, distinction has to be drawn between costs that are free of ups and downs of production and those that vary directly with these changes.

Study of behaviour of costs and CVP relationship needs proper definition of volume or activity. Volume is usually expressed in terms of sales capacity expressed as a percentage of maximum sales, volume of sales, unit of sales, etc. Production capacity is expressed as a percentage of maximum production, production in revenue of physical terms, direct labour hours or machine hours.

Analysis of cost-volume-profit involves consideration of the interplay of the following factors:

1. Volume of sales
2. Selling price
3. Product mix of sales
4. Variable cost per unit
5. Total fixed costs

The relationship between two or more of these factors may be (a) presented in the form of reports and statements, (b) shown in charts or graphs, or (c) established in the form of mathematical deduction.

### 11.3.1 Objectives of Cost-Volume-Profit Analysis

The objectives of cost-volume-profit analysis are given below:

1. In order to forecast profit accurately, it is essential to know the relationship between profits and costs on the one hand and volume on the other.
2. Cost-volume-profit analysis is useful in setting up flexible budgets which indicate costs at various levels of activity.
3. Cost-volume-profit analysis is of assistance in performance evaluation for the purpose of control. For reviewing profits achieved and costs incurred, the effects on cost of changes in volume are required to be evaluated.
4. Pricing plays an important part in stabilising and fixing up volume. Analysis of cost-volume-profit relationship may assist in formulating price policies to suit particular circumstances by projecting the effect which different price structures have on costs and profits.
5. As predetermined overhead rates are related to a selected volume of production, study of cost-volume relationship is necessary in order to know the amount of overhead costs which could be charged to product costs at various levels of operation.

### 11.3.2 Profit-Volume (P/V) Ratio

The ratio or percentage of contribution margin to sales is known as P/V ratio. This ratio is known as marginal income ratio, contribution to sales ratio or variable profit ratio. P/V ratio, usually expressed as a percentage, is the rate at which profits increase with the increase in volume. The formulae for P/V ratio are:

$$\text{P/V ratio} = \text{Marginal contribution/Sales}$$

Or

$$\text{Sales value} - \text{Variable cost/Sales value}$$

Or

$$1 - \text{Variable cost/Sales value}$$

Or

$$\text{Fixed cost} + \text{Profit/Sales value}$$

Or

$$\text{Change in Profits/Contributions/Changes}$$

A comparison for P/V ratios of different products can be made to find out which product is more profitable. Higher the P/V ratio more will be the profit and lower the P/V ratio, lesser will be the profit. P/V ratio can be improved by:

1. Increasing the selling price per unit.
2. Reducing direct and variable costs by effectively utilising men, machines and materials.
3. Switching the product to more profitable terms by showing a higher P/V ratio.

### Cost-Volume-Profit Analysis

**N. R. Parasuraman**

ONE issue of paramount interest to management is the impact of costs and volume on profits. If a linear relationship could be established among costs, volume and profits, it would help decision-makers to figure out the right volume, the right cost and consequently the right profit.

That profit is the difference between sales turnover (in value) and cost is common knowledge. Sales turnover equals sale price per unit multiplied by the number of units. This means that sales turnover goes up with higher volume and comes down with lower volume. One also knows intuitively that total cost rises with higher volume and falls with lower volume, but the extent of this movement is not known. Under the cost-volume-profit analysis (CVP analysis), given the cost pattern, the impact of costs on profits for various volumes, as also of volumes on profits, is studied.

The analysis would be easier if the cost can be segregated into fixed and variable. In fact, the basic tenet of CVP analysis is to split the cost into variable, which varies with volume, and fixed, which remains constant regardless of the volume. Let us assume that such a division of costs is easily possible. And it may be noted that even when such an absolute segregation is not possible, there are statistical tools which enable the analyst to do so with a fairly high degree of accuracy.

**Consider the following example:**

A firm sells its products at ₹ 10 per unit. The variable cost per unit is ₹ 6. And regardless of the volume, the firm has to spend ₹ 50,000 on other expenses (fixed expenses). In this case, the profit chart of the firm for various volumes can be analysed as follows:

Sale price per unit - ₹ 10

Variable cost per unit - ₹ 6

Contribution per unit - ₹ 4 (₹ 10 - ₹ 6)

No. of units required to meet fixed costs - ₹ 50,000/₹ 4 = 12,500 units

Here, the difference between the sales price per unit and the variable cost per unit is called the contribution per unit. This means that for every unit sold, ₹ 4 comes in as a contribution to meet fixed expenses. How many such units will be needed to meet the fixed expenses completely? This can easily be computed as 12,500. So, in terms of units, 12,500 units are required to meet both the variable and the fixed costs. This is called the break-even point (BEP) in units.

The relationship between contribution and sales can also be expressed as a ratio, which is called contribution margin. In the example, the contribution margin is 4/10 or 0.4. The BEP

in rupees can be found by dividing the fixed cost with the contribution margin. This will be ₹ 50,000/0.4 = ₹ 1,25,000.

Understanding the BEP concept enables one to take a number of strategic decisions.

The following is an illustrative list of the uses of CVP and BEP analyses:

- **Deciding on a level of sales to achieve a targeted profit:** At the BEP of sales, there is neither profit nor loss. It means that the contribution (sales minus variable expenses) has just about covered the fixed expenses. This suggests that for sales beyond this point, the entire contribution will be profits because there is no more fixed expenses to meet. So, if a profit of, say, ₹ 1,00,000 is targeted in the illustration, all that is to be done is to sell additional units that will make the incremental contribution beyond meeting the fixed expenses as ₹ 1,00,000.

In other words, the new volume is targeted to cover not only the fixed expenses of ₹ 50,000, but also the profit of ₹ 1,00,000. So, dividing ₹ 1,50,000 by the contribution per unit of ₹ 4 gives us 37,500 units. Thus, 37,500 units will have to be manufactured to achieve a profit of ₹ 1,00,000.

The number of units to be manufactured to achieve target profit = target profit plus fixed expenses divided by contribution per unit.

- **Determining the profit at a targeted level of sales:** Similarly, if the management has targeted a level of sales on the basis of its market survey or otherwise, the profits that will emerge from that level of sales can be determined using CVP analysis. The contribution margin per unit multiplied by the number of units produced over and above the BEP gives us this figure. Of course, profits can always be computed as the difference between sales and total cost. But what CVP analysis achieves is that incremental profits from selling additional units can be easily calculated on the basis of the established relationship between cost and volume.

- **Determining the impact of additional fixed costs:** If the fixed costs go up, the revised BEP can be computed. A no-profit, no-loss situation comes up only at the increased point now, consequent to the increased fixed costs. The entire structure of relationship between cost and volume will undergo a change consequent to this increase in fixed cost.

In real life, it may be difficult to segregate cost strictly into its fixed and variable elements. What can be attempted is to bring about as close a split as possible. The advantages of CVP analysis would far outweigh whatever difficulties one might face in segregation.

## 11.4 Break-even Point

Break-even analysis examines the relationship between the total revenue, total costs and total profits of the firm at various levels of output. It is used to determine the sales volume required for the firm to break-even and the total profits and losses at other sales level. Break-even analysis is a method, as said by Dominick Salvatore, of revenue and total cost functions of the firm. According to Marts, Curry and Frank, a break-even analysis indicates at what level cost and revenue are in equilibrium.

In case of break-even analysis, the break-even point is of particular importance. Break-even point is that volume of sales where the firm breaks even i.e., the total costs equal total revenue. It is, therefore, a point where losses cease to occur while profits have not yet begun. That is, it is the point of zero profit.

The following are the key methods of computing BEP:

### Break-even Point in Units

$$\text{BEP} = \frac{\text{Fixed Costs}}{\text{Selling price} - \text{Variable costs per unit}}$$

For Example, 
$$= \frac{\text{Fixed Costs ₹ 10,000}}{\text{Selling price ₹ 5 per unit} - \text{Variable costs ₹ 3 per unit}}$$

Therefore, 
$$\text{BEP} = \frac{\text{₹ 10,000}}{5 - 3} = 5,000 \text{ units.}$$

The conclusion that can be drawn from the above example is that sales volume of 5000 units will be the accurate point at which the manufacturing unit would not make any loss or profit.

### Break-even Point (Sales Volume ₹)

Break-even point in sales can be found out by two methods.

1. Selling Price Method
2. PV Ratio Method

1. **Selling Price Method:** Under this method Break-even sales volume in rupees is found out through the product of Break-even Point in units and selling price per unit.

$$\text{BEP (₹)} = \text{Break-even Point (units)} \times \text{Selling price per unit}$$

2. **PV Ratio Method:** Under this method, break-even sales volume in rupees can be determined through the following ratio

$$\text{BEP (₹)} = \frac{\text{Fixed Cost}}{\text{PV ratio}}$$

where 
$$\text{PV Ratio} = \frac{\text{Sales} - \text{Variable cost}}{\text{Sales}} = \frac{\text{Contribution}}{\text{Sales}}$$



*Example:* Calculate Break-even point ₹

Sales	6,00,000
Fixed Cost	1,50,000

The first step is to find out the total volume of variable expenses.

$$\begin{aligned} \text{Variable Expenses} &= \text{Direct Material} + \text{Direct Labour} + \text{Overhead Expenses} \\ &= ₹ 2,00,000 + 1,20,000 + 80,000 = ₹ 4,00,000 \end{aligned}$$

The second step is to find out the contribution.

$$\begin{aligned} \text{Contribution} &= \text{Sales} - \text{Variable Expenses} \\ &= ₹ 6,00,000 - 4,00,000 = ₹ 2,00,000 \end{aligned}$$

The third step is to find out PV ratio.

$$\begin{aligned} \text{PV ratio} &= \text{Contribution/Sales} \\ &= ₹ 2,00,000/₹ 6,00,00 = 1/3 \end{aligned}$$

The final Step is to find out Break-even sales

$$\text{Break-Even Point (Rupees)} = \frac{\text{Fixed Cost}}{\text{PV ratio}} = \frac{₹ 1,50,000}{1/3} = ₹ 4,50,000$$



*Note* It is not possible to find out the break-even points in units due to non-availability of selling price and variable cost per unit; this constrains the computation of contribution margin per unit.

### 11.4.1 Uses of Break-even Analysis

Break-even analysis is a very generalised approach for dealing with a wide variety of questions associated with profit planning and forecasting. Some of the important practical applications of break-even analysis are:

1. What happens to overall profitability when a new product is introduced?
2. What level of sales is needed to cover all costs and earn, say, ₹ 1,00,000 profit or a 12% rate of return?
3. What happens to revenues and costs if the price of one of a company's product is hanged?
4. What happens to overall profitability if a company purchases new capital equipment or incurs higher or lower fixed or variable costs?
5. Between two alternative investments, which one offers the greater margin of profit (safety)?
6. What are the revenue and cost implications of changing the process of production?
7. Should one make, buy or lease capital equipment?



### 11.4.2 Assumptions of Break-even Analysis

The break-even analysis is based on certain assumptions, namely:

1. All costs are either perfectly variable or absolutely fixed over the entire period of production but this assumption does not hold good in practice.
2. The volume of production and the volume of sales are equal; but in reality they differ.
3. All revenue is perfectly variable with the physical volume of production and this assumption is not valid.
4. The assumption of stable product mix is unrealistic.

### 11.4.3 Advantages of Break-even Analysis

The main advantages of using break-even analysis in managerial decision making can be the following:

1. It helps in determining the optimum level of output below which it would not be profitable for a firm to produce.
2. It helps in determining the target capacity for a firm to get the benefit of minimum unit cost of production.
3. With the help of the break-even analysis, the firm can determine minimum cost for a given level of output.
4. It helps the firms in deciding which products are to be produced and which are to be bought by the firm.
5. Plant expansion or contraction decisions are often based on the break-even analysis of the perceived situation.
6. Impact of changes in prices and costs on profits of the firm can also be analysed with the help of break-even technique.
7. Sometimes a management has to take decisions regarding dropping or adding a product to the product line. The break-even analysis comes very handy in such situations.
8. It evaluates the percentage financial yield from a project and thereby helps in the choice between various alternative projects.
9. The break-even analysis can be used in finding the selling price which would prove most profitable for the firm.
10. By finding out the break-even point, the break-even analysis helps in establishing the point wherefrom the firm can start payment of dividend to its shareholders.

### 11.4.4 Drawbacks of Break-even Analysis (BEA)

This analysis will be useful only in situations relatively stable and slow moving rather than volatile and erratic ones. In conditions when proper managerial accounting techniques and procedures are maintained, the BEA will be useful. In a particular period costs are affected not by the output of that period but due to past output or a preparation for future output. As such the BEA cannot pin down that cost is the result of output of a particular period. It is difficult to deal with selling costs under the framework of BEA because changes in selling costs are a

cause to bring out changes in output and not the result of output sales. In the real world, perfect competition is very rare and as such it is necessary to make calculations at different time periods. The relationship between cost, revenue and volume (output) is realistic only over narrow ranges of output and for long ranges. If too many products and too many plants are grouped together in a productive process, the BEA cannot identify which is good or which is bad, since all are grouped together. The BEA assumes that profits are the result of output but ignores that other factors like technological changes, improved management and variations in the proportions of fixed factors are also possible for profits. In spite of these, BEA is an important tool in decision making.

Margin of safety = Actual sales – Break-even Sales

or

$$= \frac{\text{Profit} \times \text{Selling Price per Unit}}{\text{Selling Price per Unit} - \text{Variable Cost Per Unit}}$$

## 11.5 Use of Cost Data in Decision Making

The break-even analysis uses the cost data to make decisions. The following are the key methods used for break-even analysis:

1. Break-even Charts
2. Algebraic Method

### 11.5.1 Break-even Chart

The difference between Price and Average Variable Cost (P – AVC) is defined as ‘profit contribution’. That is, revenue on the sale of a unit of output after variable costs are covered represents a contribution toward profit. At low rates of output, the firm may be losing money because fixed costs have not yet been covered by the profit contribution. Thus, at these low rates of output, profit contribution is used to cover fixed costs. After fixed costs are covered, the firm will be earning a profit.

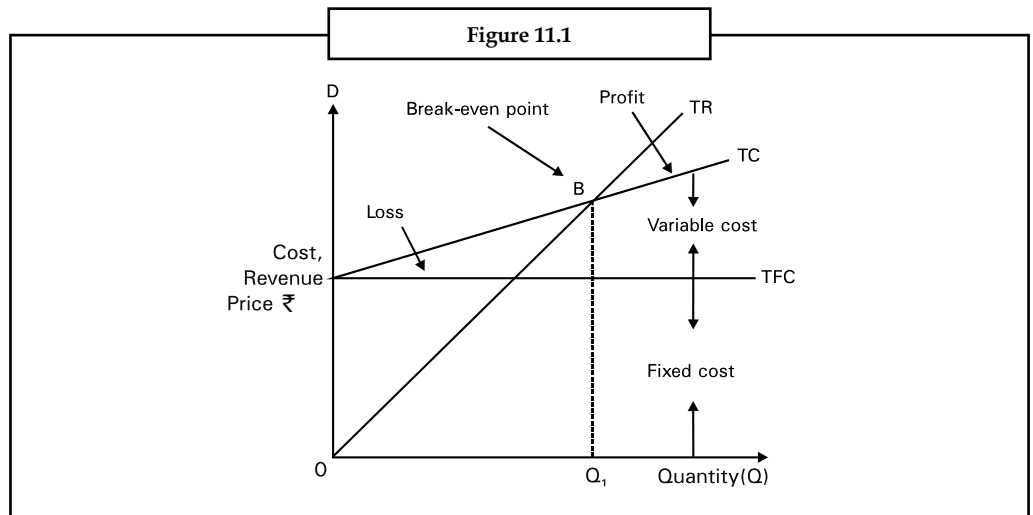
A manager may want to know the output rate necessary to cover all fixed costs and to earn a “required” profit of R. Assume that both price and variable cost per unit of output (AVC) are constant. Profit is equal to total revenue (P.Q.) less the sum of Total Variable Costs (Q.TVC) and fixed costs. Thus,

$$\pi_R = PQ - [(Q \cdot AVC) + FC]$$

$$\pi_R = TR - TC$$

The break-even chart shows the extent of profit or loss to the firm at different levels of activity. A break-even chart may be defined as an analysis in graphic form of the relationship of production and sales to profit. The Break-even analysis utilises a break-even chart in which the Total Revenue (TR) and the Total Cost (TC) curves are represented by straight lines, as in Figure 11.1.

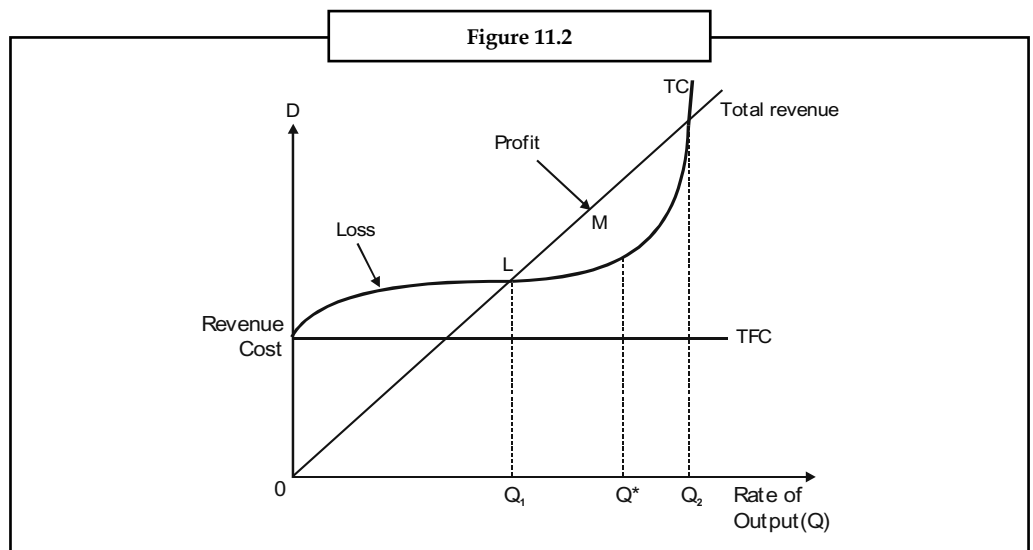

In the figure total revenues and total costs are plotted on the vertical axis whereas output or sales per time period are plotted on the horizontal axis. The slope of the TR curve refers to the constant price at which the firm can sell its output. The TC curve indicates Total Fixed Costs (TFC) (The vertical intercept) and a constant average variable cost (the slope of the TC curve). This is often the case for many firms for small changes in output or sales. The firm breaks even (with TR=TC) at  $Q_1$  (point B in the figure) and incurs losses at smaller outputs while earnings profits at higher levels of output.

Both the Total Cost (TC) and Total Revenue (TR) curves are shown as linear. TR curve is linear as it is assumed that the price is given, irrespective of the output level. Linearity of TC curve results from the assumption of constant variable costs.

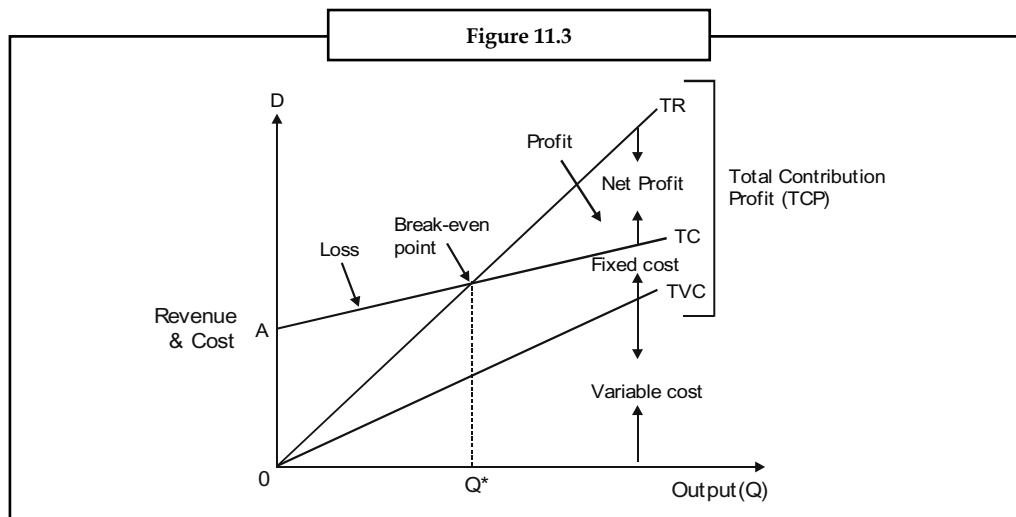
If the assumptions of constant price and average variable cost are relaxed, break-even analysis can still be applied, although the key relationship (total revenue and total cost) will not be linear functions of output. Nonlinear total revenue and cost functions are shown in Figure 11.2. The cost function is conventional in the sense that at first costs increase but less than in proportion to output and then increase more than in proportion to output. There are two break-even points – L and M. Note that profit which is the vertical distance between the total revenue and total cost functions, is maximised at output rate  $Q^*$ .



Of the two break-even points, only the first, corresponding to output rate  $Q_1$  is relevant. When a firm begins production, management usually expects to incur losses. But it is important to know at what output rate the firm will go from a loss to a profit situation. In Figure 11.2 the firm would want to get to the break-even output rate  $Q_1$  as soon as possible and then of course, move to the profit maximising rate  $Q^*$ . However, the firm would not expand production beyond  $Q^*$  because this would result in a reduction of profit.

### Contribution Margin

In the short run, where many of the firms costs are fixed, businessmen are often interested in determining the contribution additional sales make towards fixed costs and profits. Contribution analysis provides this information. Total contribution profit is defined as the difference between total revenues and total variable costs, which equals price less average variable cost on a per unit basis. Figure 11.3 highlights the meaning of contribution costs. Total contribution profit, it can be seen, is also equal to total net profit plus total fixed costs.



Contribution profit analysis provides a useful format for examining a variety of price and output decisions.

As is clear from Figure 11.3 Total Contribution Profit (TCP) = Total Revenue (TR) – Total Variable Cost (TVC)

$$= \text{Total Net Profit (TNP)} + \text{Total Fixed Cost (TFC)}$$

Therefore, if TNP = 0 then, TCP = TFC. This occurs at break-even point. From the above equation it is also clear that

$$\begin{aligned} \text{TR} &= \text{TCP} + \text{TVC} \\ &= (\text{TNP} + \text{TFC}) + \text{TVC} \end{aligned}$$

Total Contribution Profit (TCP)

$$\begin{aligned} &= \text{TR} - \text{TVC} \\ &= \text{Net Profit} + \text{Fixed Cost} \end{aligned}$$

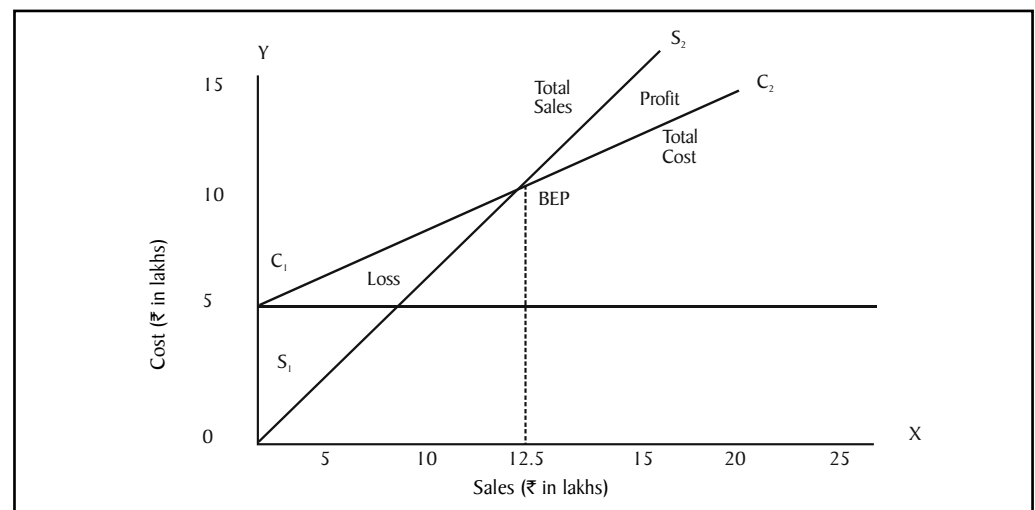

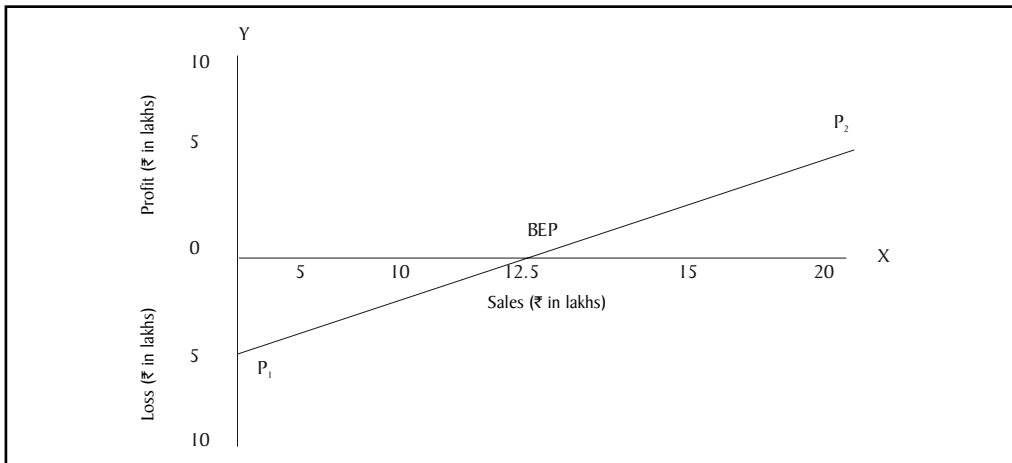

### 11.5.2 Algebraic Method

Break-even analysis can also be performed algebraically, as follows. Total revenue is equal to the selling price ( $P$ ) per unit times the quantity of output or sales ( $Q$ ). That is

$$TR = (P) \cdot (Q)$$

Total costs equal total fixed costs plus Total Variable Costs (TVC). Since TVC is equal to the Average (per unit) Variable Cost (AVC) times the quantity of output or sales, we have

$$TC = TFC + TVC$$

or,  $TC = TFC + (AVC) \cdot (Q)$

Setting total revenue equal to total costs and substituting  $Q_B$  (the break-even output) for  $Q$ , we have

$$TR = TC$$

$$(P) \cdot (Q_B) = TFC + (AVC) \cdot (Q_B)$$

Or,  $TFC = P \cdot (Q_B) - (AVC) \cdot (Q_B)$

$$TFC = Q_B \cdot (P - AVC)$$

$$OB \text{ (the break-even output)} = \frac{TFC}{(P - AVC)} = \frac{TFC}{ACM}$$

The denominator in the above equation (i.e.,  $P - AVC$ ) is called the contribution margin per unit (ACM) because it represents the portion of the selling price that can be applied to cover the fixed costs of the firm and to provide for profits.

### Introduction

The need for a decision arises in business because a manager is faced with a problem and alternative courses of action are available. A manager has to take different decisions like make or buy, continue or shut down, etc. to make the maximum profit. In deciding which option to choose he will need all the information which is relevant to his decision; and he must have some criterion on the basis of which he can choose the best alternative. Some of the factors affecting the decision may not be expressed in monetary value. Hence, the manager will have to make 'qualitative' judgements, e.g. in deciding which of two personnel should be promoted to a managerial position. A 'quantitative' decision, on the other hand, is possible when the various factors, and relationships between them, are measurable.

### 12.1 Concept of Decision-making

Marginal cost helps management to make decision involving consideration of cost and revenue. Basically, marginal costing furnishes information regarding additional costs to be incurred if an additional activity is to be taken up or the saving in costs which may be expected if an activity is given up. This can be compared with the benefit expected from the proposed course of action and thus the management will be able to take the appropriate decision.

Decision-making describes the process by which a course of action is selected as the way to deal with a specific problem. A decision involves the act of choice and the alternative chosen out of the available alternatives.

**Notes**

According to Heinz Wehrich and Horold Koontz, "Decision-making is defined as the selection of a course of action from among alternatives."

George R. Terry says, "Decision-making is the selection based on some criteria from two or more possible alternatives."

According to Haynes and Masie, "Decision-making is a course of action which is consciously chosen for achieving the desired results."

Following are the important areas of decision-making or applications of marginal costing:

1. Fixation of Price,
2. Decision to Make or Buy,
3. Selection of a Profitable Product Mix,
4. Decision to Accept a Bulk Order,
5. Closure of a Department or Discontinuing a Product,
6. Maintaining a Desired Level of Profit, and
7. Evaluation of Performance.

**12.2 Determination of Sales Mix**

In the market, dealership is offered by the various companies to the individual intermediaries in promoting the sale of products. Before reaching an agreement with the company to act as a dealer, normally every individual considers the profitability of the product mix offered by the firm. For example, There are two different companies brought forth their advertisements in offering the dealership to the individual trading firms *viz.* HCL and IBM.

The profitability under the dealership banner should be appropriately considered prior to take decision. To take rational decision, the firm should compare the profitability of both different dealerships of two different giant industrial brands. The greater the share of the profitability in volume will be selected and vice-versa.



*Example:* From the following information has been extracted of EXCEL Rubber Products Ltd:

Direct materials A	₹ 16
Direct Materials B	₹ 12
Direct wages A	24 Hrs at 50 paise per hour
Direct wages B	16 Hrs at 50 paise per hour

The profit level among the given various mixes, the mix (d) is able to generate highest volume of profit over the others.

**Determining optimum level of operations:** Under this method, the level has to be found out which is having lesser selling price, cost of operations and greater profits known as optimum level of operations

### 12.3 Make or Buy Decisions

The firms, which are routinely in need of spares, accessories are bought from the outsiders instead of any production or manufacturing, though the requirement is at regular intervals. Most of the automobile manufacturers are usually buying the components from outside instead of producing them on their own. The Maruti Udyog Ltd. had given a contract to the Nettur Technical Training Foundation, Bangalore to design the tool for the panel and to manufacture regularly to the tune of the orders.

The leading four wheeler manufacture in India is buying the panel from the NTTF on contract basis in stead of manufacturing.



*Did u know?* Why don't they manufacture in spite of buying them from the NTTF?

The main reason of buying is cheaper than the production of an article.



*Example:* The management of a company finds that while the cost of making a component part is ₹ 20, the same is available in the market at ₹ 18 with an assurance of continuous supply.

The first point to be found out that the contribution of the transaction. The cost of manufacturing should be compared with the price of the product which is available in the market.

The cost of manufacturing a component is ₹ 17.00. While calculating the cost of manufacturing a component, the fixed expenses was not considered. The fixed expenses were not considered for computation. Why?

The costs will be incurred irrespective of the production status of the firm; for which the expenses should not be added.

If the company manufactures the product/component at ₹ 17 which will facilitate to book profit ₹ 1 from the price of ₹ 18 which is available from the market.

The next stage is decision criteria.

**Worth of Production:** Cost of the production < Price of the product available in the market.

The firm is better advised to take the course of production rather than purchase of the product.

**Worth of Purchase:** Cost of the production > Price of the product available in the market

The product available in the market is same cheaper than the manufacturing of a product. The firm is better advised to buy the product rather than the manufacturing of a product. If the product price comes down to the price of ₹ 16 facilitates the firm to save ₹ 1 from the cost of manufacturing.

## 12.4 Own or Hire

Marginal costing helps in taking the decisions regarding the capital investment. Marginal costing helps to take the decisions for owning the capital asset or hire the asset.

Notes



*Example:* If company X needs a machinery for a specific project and after that project there is no use of the machinery then company can decide to hire the machinery for that project.

A company has its own trucks for transporting raw materials and finished products from one place to another. It seeks to replace these trucks by keeping public carriers. In making this decision, of course, the depreciation of the trucks is not to be considered but the management should take into account the present expenditure on fuel, salary to drive and maintenance.

**12.5 Shut Down or Continue**

As discussed earlier, marginal costing technique helps in deciding the profitability of a product. It provides the information in a manner that tells us how much each product contributes towards fixed cost and profit; the product or department that gives least contribution should be discarded except for a short period. If the management is to choose some product out of the given ones, then the products giving the highest contribution should be chosen and those giving the least should be discontinued.



*Example:* A company manufactures three products X, Y and Z. It has prepared the following budget for the year 2003:

Profit-Volume (P/V) ratio is the ratio of contribution to sales. It is expressed in terms of percentage. After preparing the above statement and analysis, we can make the following recommendations:

As discussed in the marginal cost statement, the contribution of product Z is ₹ 6,500 which goes toward the recovery of fixed cost of ₹ 9,800. If the production of product Z is discontinued, the company will lose the marginal contribution of ₹ 6,500 while it will have to incur the fixed cost of ₹ 9,800. The total profit of ₹ 57,000 will be reduced to ₹ 50,500 (57,000 - 6,500). Thus, it is advisable that the production of Z should not be discontinued. As regards the relative profitability, product X is more profitable than Y and Z as the P/V ratio in this case is highest. The production and sales of product X should, therefore, be encouraged.

### **Introduction**

Pricing which is part of the overall marketing strategy plays a very critical role in the success of a company as it is able to increase the profitability and or increase the market share.

Normally, the higher the prices means higher profit being attained but might mean lower market share. Pricing ties very closely with the various stages of a product life cycle. Under normal circumstances, selling price is based on total cost, i.e., production, administration and selling overheads – fixed as well as variable plus normal profit. In the long-term planning, selling price must cover all costs plus a desired profit. There are, however, a variety of business situations where fixation of selling price may vary from inclusion of desired profit to selling even below total cost. Marginal costing technique helps in determining the most profitable relationship between costs, prices and volume of business.

### **13.1 Need of Pricing Decisions**

When there is considerable unfilled capacity it may be necessary to accept a lower contribution in order to provide work in the factory. Alternatively, if there is sufficient order, normal price may be quoted and the contribution obtainable may be high. The aim of the fixer of prices is to

sell the present and future capacity for the greatest obtainable contribution. When the capacity remains unused, the potential contribution is being sacrificed and the acceptance of an order with a lower contribution will at least partially meet from fixed costs being incurred. This amount of contribution would otherwise be lost if the order is refused. In fixing the lower price than normal, the price fixed must take into consideration the following:

1. The amount of contributions at the proposed price;
2. The possibility of other more remuneration job;
3. Comparison with normal selling price in order to determine the concession being offered; and
4. The possible adverse effect upon the future sales and customer's confidence in the company's pricing or trading policy.



*Example:* X Ltd. is found to be working below the normal capacity due to recession. The directors have been approached by another company with an enquiry for a special purpose job. The costing department estimated the following in respect of that job:

Direct materials ₹ 1,00,000

Direct labour 5000 hours @ ₹ 3 = 15,000

**Overhead costs:** Normal recovery rates:

Variable = Re 1 per hour.

Fixed = ₹ 1.50 per hour.

You are required to advise the company on the minimum prices to be charged.

**Solution:**

Marginal costs will have to be determined as follows:

	(₹)
1. Direct materials	1,00,000
2. Add: Direct Labour	15,000
3. Add: Variable overhead @ Re 1 per hour for 5000 hours	5,000
4. Total marginal costs	1,20,000

The floor price, the absolute minimum price should be ₹ 1,20,000. That is, a total of marginal costs. At this level, it will not make any contribution. Hence, a certain portion of fixed costs must be added to the marginal costs to accept the job with profit. In this case, the fixed overhead is found to be ₹ 7,500 (5,000 hours × ₹ 1.5 per hour).

Thus, this technique assists in pricing a product.



#### Notes **Objectives of Pricing Decisions**

The following are the key objectives of pricing decisions:

1. The important pricing objective is to exploit the firm's competitive position in the market place.
2. The products are priced in such a way that sufficient resources are made available for the firm's expansion, developmental investment, etc.

3. Some companies adopt the main pricing objectives so as to maintain or to improve the market share towards the product. A good market share is a better indication of progress.
4. The pricing objectives may be to meet or prevent competition.
5. It also prevents price war amongst the competitors.
6. Product Line pricing to maximise long-term profits is another price objective.

### 13.2 Types of Pricing Decisions

The following are the key types of pricing decisions:

1. **Perceived Value Pricing Method:** In this method, prices are decided on the basis of customer's perceived value. They see the buyer's perceptions of value, not the seller's cost as the key indicator of pricing. They use various promotional methods like advertising and brand building for creating this perception.
2. **Value Pricing Method:** In this method, the marketer charges fairly low price for a high quality offering. This method proposes that price represents a high value offer to consumers.
3. **Going Rate Pricing:** In this method, the firm bases its price on the average price of the product in the industry or prices charged by competitors.
4. **Sealed Bid Pricing:** In this method, the firms submit bids in sealed covers for the price of the job or the service. This is based on firm's expectation about the level at which the competitor is likely to set up prices rather than on the cost structure of the firm.
5. **Psychological Pricing:** In this method, the marketer bases prices on the psychology of consumers. Many consumers perceive price as an indicator of quality. While evaluating products, buyers carry a reference price in their mind and evaluate the alternatives on the basis of this reference price. Sellers often manipulate these reference points and decide their pricing strategy.
6. **Odd Pricing:** In this method, the buyer charges an odd price to get noticed by the consumer. A typical example of odd pricing is the pricing strategy followed by Bata. Bata prices are always an odd number like ₹ 899.99 etc.



7. **Geographical Pricing:** This is a method in which the marketer decides pricing strategy depending on location of the customer like domestic pricing, international pricing, third world pricing, etc. Multinational firms follow such a pricing strategy as they operate in different geographic locations.
8. **Discriminatory Pricing:** This is a method in which the marketer discriminates his pricing on certain basis like type of customer, location and so on. It occurs when a company sells product or service at two or more prices that do not reflect a proportional difference in the costs. One can sell at different prices in different segments. Different prices for different forms of the same product can sell the same product at two different levels depending on the image differences.



#### Caution **Factors Affecting Pricing Decisions**

Before a decision on the pricing is made, certain factors need to be consider:

1. What are the objectives of the company – to maximize profit/to gain market share/ to penetrate the new market, etc.?
2. What are the existing economic conditions?
3. Any government regulations;
4. Cost structure of the organization;
5. Demand for the product which should includes a study of the price elasticity of demand;
6. Inflation;
7. Surplus production capacity;
8. Level of competition; and
9. Political scenario.

### 13.3 Methods of Pricing

The various methods of pricing include the following:

1. Full cost pricing;
2. Variable/Marginal cost plus pricing;
3. Rate of return pricing;

### 13.3.1 Full Cost Pricing

Full Cost Pricing is a traditional method of pricing a product. It has following features:

1. Most commonly used method;
2. Prices are set by adding a percentage of profit (either a mark up or a margin) to the total cost of the product;
3. Consistent with the absorption costing technique;
4. Commonly used by wholesalers, retailers, construction contractors, services, government contractors.

Full Cost Pricing is useful in situation where:

1. Products are made based on specification by the customers;
2. Main objective is to make profit after considering fixed costs of the business;
3. The costs are difficult to estimate in advance;
4. Expected demand at different price levels is difficult to estimate.



*Example:* Let's look at Product A:

Production cost as follows:

Variable cost-material \$1.50

Variable cost-labor \$1.50

Total variable cost \$3.00

Fixed cost \$3.00

(excludes administrative and selling overheads)

Required 50% mark up on total production cost.

For Full-Cost Plus Pricing: company wants Product A to at least cover its total production cost.

Full Cost Pricing has many advantages. A few of them are as under:

1. Easy and simple to understand;
2. Pricing decisions become standardized;
3. Adopts a conservative approach that in the long run to at least ensure the recovery of fixed cost of a business;

$$\text{Total cost} = \$ 3.00 + \$ 3.00 = \$ 6.00$$

$$50\% \text{ on total/full cost} = 50\% \times \$ 6.00 = \$ 3.00$$

$$\text{Hence, Selling price} = \$ 6.00 + \$ 3.00 = \$ 9.00 \text{ per unit.}$$

By pricing at \$ 9.00, the

4. Difficult of estimating demands can be avoided.

Like everything else, full cost pricing also has certain disadvantages which are as under:

Notes

1. Tendency to set prices on inaccurate estimates;
2. Challenges of apportioning the fixed overheads properly into different products;
3. Unsuitable for short term decisions making particularly in situation like surplus production capacity, tendering for contracts price and others;
4. Ignores competition and price elasticity of demand; and
5. Ignores opportunity costs and relevant costs.

### 13.3.2 Variable/Marginal Cost Pricing

Under marginal Cost pricing, selling price is determined by adding a mark up or margin on the total variable costs (marginal cost). Its salient features are as under:

1. Based on the assumption that any price above variable cost would generate a certain level of contribution towards meeting fixed costs;
2. Consistent with the marginal costing technique;
3. When using this pricing method, need to be careful to ensure that it is sufficient to cover all fixed cost and to generate sufficient margin for profit otherwise the long term survival of the business might be at stake.



*Example:* Let's look at Product A:

Production cost as follows:

Variable/direct material \$1.50

Variable/direct labor \$1.50

Variable Production overheads \$1.00

Variable Administrative overheads \$0.50

Variable Selling overheads \$0.10

Total variable costs \$4.60

Say required mark up of 65% \$3.00

Variable Cost Plus Pricing \$7.60

The selling price is determined at \$7.60 where the company wants Product A to at least cover its total variable cost and contribute towards recovery fixed costs and profit.

**Advantages of Variable/Marginal Cost Pricing are as under:**

1. As it adopts the margin cost approach, it provides better information as it segregate the variable and fixed costs;
2. Highlights the importance of contribution;
3. Useful for contract bidding where competition could be quite intense;
4. Eliminates the difficulty of computing fixed costs into the products.

**Disadvantages of Variable/Marginal Cost Pricing:**

1. For short-term pricing decision, it's alright otherwise needs to be very careful the pricing in the long-term can recover fixed costs and generate sufficient profit for the business;
2. Might be unsuitable for production costs consist a lot of fixed costs.

### 13.3.3 Rate of Return Pricing

For this type of pricing, the company needs to specify the rate of return on its capital invested. Similar to Cost pricing, the difference is that the marked up will be based on the target rate of return. The salient features include:

1. The target rate of return varies with market norm or what management considers a fair return.
2. Useful method to use when a business has invested too much on the project or products.
3. However, difficult to use where a company has too many product lines or competes in many markets.



*Example:* Capital invested/employed \$2,000,000

Target return 10%

Estimated costs \$500,000

$$\begin{aligned} \text{Mark up} &= \frac{10\% \times \$2,000,000}{\$500,000} \\ &= 40\% \end{aligned}$$

### 13.3.4 Break-even Pricing

For this type of pricing, the price at which the products will break-even is used. This break-even price will then be added a profit mark up.



*Example:* If Fixed Cost \$25,000, Variable cost \$2.00 per unit, Number of Units produced 4,000 and Mark-up is 15% on the break-even price, what will be selling price to the customers?

**Solution:**

$$\text{Break-even price} = \text{Fixed Cost} + \text{Variable Cost/Marginal Cost}$$

$$\text{Total Number of units produced} = \$25,000 + \$8,000$$

$$4,000 = \$8.25 + \text{mark up of 15\% } (\$1.24)$$

$$= \$9.50 \text{ which is the selling price to the customer.}$$

### 13.3.5 Minimum Pricing

For this type of pricing, the selling price is the lowest price that a company may sell its product. Normally, the price will be the Total Relevant Costs of Manufacturing. Its salient features include:

1. Useful method in situations where there is a lot of intense competition, surplus production capacity, clearance of old stocks, getting special orders and or improving market share of the product.
2. Minimum Price is Incremental costs of manufacturing + Opportunity Costs (if any),



*Example:* Assuming the following details of product X:

Material	\$2.50
Labor (2 hrs. @ \$3.00)	\$6.00
Variable production overhead	\$2.50
Fixed production overhead	\$1.20

Total	\$9.70	Notes
Say that the labor is in short supply and is used for other product Y which generates a contribution of \$6 per unit and requires 2 hours of the same labor.		
Material	\$2.50	
Labor	\$6.00	
Variable production overhead	\$2.50	
<i>Add:</i>		
Opportunity cost from labor scarcity:		
$\$6/2 \text{ hours} = \$3.00 \text{ per hr} \times 2 \text{ hr} = \$6.00$

### Product Pricing

One of the tougher decisions that a marketing manager faces is how to price a product in the market. In an existing market (i.e. where a new brand is being introduced in a category that already sees competition) the decision is a little easier than in a new market since the marketer can take some cues from the competition's price ranges.

In this situation, the marketer has to be clear about the segment being addressed by the new product. Once that is clear, he can choose from the following options:

1. Price the product on par with the competing product(s)
2. Price the product very close to the competing product(s)
3. Consciously price it quite a bit lower as an incentive to induce trial.

The third decision could prove counter-productive; a lower price could adversely affect the brand value perception unless the communication strategy establishes a value-for-money platform. The other danger is that it could prevent the brand from increasing the price even later, i.e. consumers who came in at the lower price may migrate away when the price is raised.

When launching a new product that is likely to create a new category altogether - as ready-to-eat chapatti did a few years back - the pricing decision is even tougher. Here, there is often no comparison point at all - the traditional method of making chapattis gives no pointers whatsoever to what consumers may pay for the new product.

Therefore, the marketer has to debate various scenarios. Pricing it low might encourage trials and good volumes, but the price may not prove viable in the long run. If priced too high, it could inhibit trials, so the product could be a non-starter.

Nonetheless, given that there are a large number of affluent consumers who are ready to spend, many marketers are in favour of pricing the product higher. It seems to be a given that a high price does more to create a perception of brand value than almost any other strategy.

As long as the boom in consumption sustains, this method would probably work well; if the economic conditions were to see a downtrend, then, probably, such a strategy would not work.

Unfortunately, market research does not help much in the area of pricing. Various pricing research models have been generated and being from the MR industry I have done my

share of testing these models. But in a research situation, consumers become artificially conscious of the price point and, hence, become artificially price sensitive too. Thus, it is not unusual to see research respondents saying that a price increase of ₹ 2 in a pack priced at ₹ 10 would make them switch brands; in actual fact, the consumers probably didn't know whether the price was ₹ 10 or ₹ 11.

Till research methods evolve in this area, pricing decisions will continue to need a lot of gut feel and sagacity from the marketer.

### **Introduction**

The reporting system involves all levels of management. The reports originate from junior levels of management and go up to top level management, consisting of Board of Directors. The sectional in-charge of every section regularly reports the progress of his section to his superior. Functional managers have Deputy Managers who control departmental sections. The combined reports of different sections reach the departmental manager called functional managers. Different functional managers submit the progress of their departments to the managing director. The brief summaries of departmental reports are submitted to the Board of Directors for reviewing policies and making strategy for the future. Information means data have been shaped into a form that is meaningful and useful to human being. Data are stream of raw facts reporting events occurring in organisation or physical environment before they have been organised and rearranged into a form that people can understand and use.

### **14.1 Principles of a Good Reporting System**

A good reporting system is helpful to the management in planning and controlling. Every level of management needs information relating to its activities centre so that effective planning may



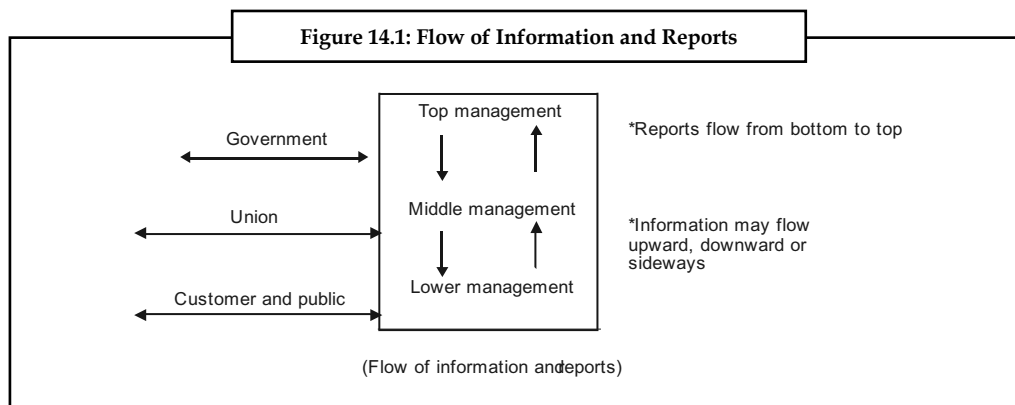
be undertaken and current activities may be controlled and necessary corrective action may also be taken in time, if needed. Some general principles are followed for making the reporting system effective. These principles are discussed below:

1. **Proper Flow of Information:** A good reporting system should have a proper flow of information. The information should flow from the proper place to the right levels of management. The information should be sent in the right form and at proper time so that it helps in planning and coordination. The frequency of reports will depend upon the nature of report, the types of data required for preparing the information and cost involved in preparing such reports. The flow of reports should be such that it does not cause delay in taking decisions. The reports should flow at regular intervals so that international needs of different managerial levels are met at a proper time.



**Caution** Flow of information is a continuous activity and effects all levels of the organisation information may flow upward, downward or sideways within an organization. Orders, instructions, plans, etc. may flow from top to bottom. Reports grievances, suggestions, etc. may flow from bottom to top. Notifications, letters, settlements, complaints may flow from outside. Information also flows sideways, from one manager to another at the same level through meetings discussions, etc.

2. **Proper Timing:** Since reports are used as a controlling device they should be presented at the earliest or immediately after the happenings of an event. The time required for preparation of reports should be reduced to the minimum; for routine reports the period should be known and strictly adhered to. It will be a waste of time and effort to prepare information that is too late to be of any use. The absence of information when needed will either mean wrong decisions or ferment of decisions on matters that may be urgent in nature.



3. **Accurate Information:** The information should be as accurate as possible. However, the degree of accuracy may differ in different reports. Sometimes, part information may be supplied as a guide for future policy making, so the degree of accuracy may be less. The supply of exact figures may involve a problem of understanding. Approximate figures are more understandable than accurate figures given up to paise. Accuracy should also not involve excessive cost of preparation nor it should be achieved at the sacrifice of promptness of presentation. It will be better to have approximate figures at a proper time than delayed information prepared accurately.

Notes

4. **Basis of Comparison:** The information supplied through reports will be more useful when it is supplied in comparison with past figures, standards set or objectives laid down. The decision-making authority will be able to make use of comparative figures while making a decision. Corrective measures can also be initiated to improve upon past performance.
5. **Reports should be Clear and Simple:** The information should be presented in a clear manner by avoiding extraneous data. Only relevant important information should become the part of a report. If supporting information cannot be avoided, then it should be given in appendix or separate chart should be attached to it.  

The method of presenting information should be such that it attracts the eye and enables the reader to form an opinion about the information. The graphic presentation of information will enable the reader to find out the trends and also to determine deviations more quickly than in other methods. The arrangement of presentation should be brief, clear and complete. Simplicity is a good guide for reports preparation.
6. **Cost:** The benefits derived from reporting system must be commensurate with the cost involved in it. Though it is not possible to assess the benefit of this system in monetary terms, there should be an endeavour to make the system as economic as possible.
7. **Evaluation of Responsibility:** The reporting system should enable the evaluation of managerial responsibility. The targets are fixed for various functional departmental heads. The record of actual performance is monitored along with the standards so as to enable management to assess the performance of different individuals. So, management reporting should be devised in a way that it helps in evaluating the work assigned to various persons.

**14.2 Introduction to Management Information System (MIS)**

Management Information System can be developed as an act of interrelated components that collect (or retrieve), process, store and distribute information to support decision-making, coordinate and control in an organisation.

**14.2.1 Attributes of Information**

For information to be useful to managers, it must possess certain attributes. Some of the important attributes are accuracy, timeliness, relevance and completeness.



Notes

**Attributes of Information**

Accuracy	Must be true and correct and must accurately describe the item or event.
Timeliness	Available when it is needed and without excessive delay.
Relevance	Pertains to the situation at hand. Information relevant at one time may not be relevant at another if it does not add to the knowledge needed by a decision maker.
Completeness	Provides the user with all details needed to understand a solution. Complete information (that is certainty) is rarely available.
Frequency	Prepared or presented to users often enough to be up-to-date.
Time horizon	Oriented toward past, present or future activities and events.
Scope	Broad or narrow in coverage of an area of interest.
Origin	May originate from sources within the organization or from external sources.
Form of presentation	Tables of numbers or graphic displays of information are the most common written or printed forms. May also include verbal presentation.

**14.2.2 Information Needs of Managers**

All managers require information to perform their managerial functions (mainly, planning and controlling) and make effective decisions. The information that managers require will vary, depending on the nature of the work they do and the tasks they seek to accomplish. Information needs also vary by levels in the organizational hierarchy (Table 14.1). For instance, top level managers need far less detail (as a general rule) than lower level managers. Since top-level managers have to take a broad perspective of the organisation and its mission, they only need information that helps them develop or enhance the perspectives.

Information that originates within an organisation is referred to as internal information. This type of information is essential for managing day-to-day operations. Some examples of internal information are:

1. Daily receipts and expenditures
2. Quantity of an item in hand or in inventory
3. Cost and selling price of the item
4. Salespeople's quotas

Information that originates outside the organisation is referred to as external information. Such information is often required by top level managers to plan and guide the organisation successfully.

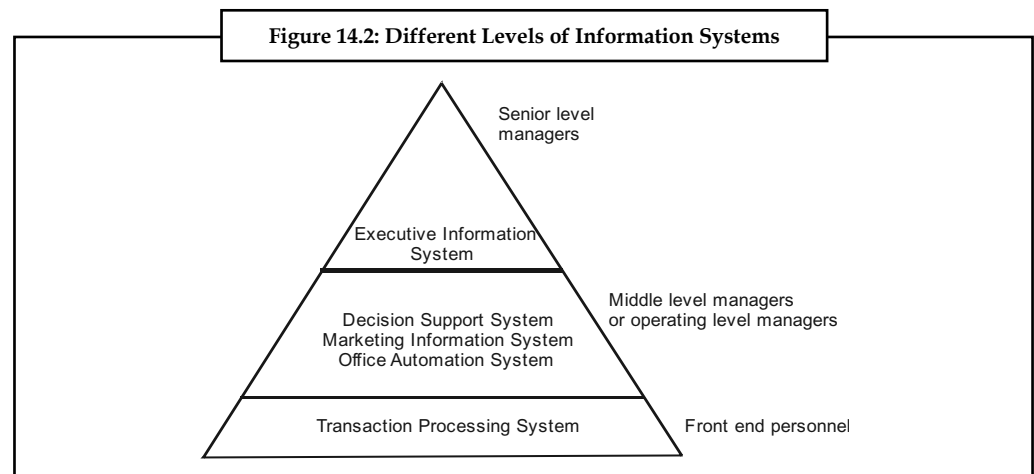
Some examples of external information are:

1. Demand for new products or services.
2. Information describes customer satisfaction with products and services. Information describing change in policies of suppliers.
3. Knowledge of promotional campaigns, price changes, or products planned by competing firms.
4. Details of changes in government regulations.

In many instances, firms have to provide information to external users. Some of these are:

1. Prices of items and services offered (to customers)
2. Quantity of items needed for manufacturing (to suppliers)
3. Sales revenues and profit earned (to the government).

Only an effective information system can provide managers with both internal and external information that is timely and accurate.



Management information system can be developed as an act of interrelated components that collect (or retrieve), process, store and distribute information to support decision-making, coordinate and control in an organisation. Information means that data have been shaped into a form that is meaningful and useful to human being. Data are a stream of raw facts reporting events occurring in an organization or physical environment before they have been organised and rearranged into a form that people can understand and use.

The importance of Management Information System has increased in recent times because of the following:

1. Emergence of global economy
2. Transformation of industrial economies – knowledge and information intense products have become available
3. Transformation of multinational enterprises
4. Emergence of digital form

### 14.3 Performance Measures

Performance measures are a central component of management information and reporting system. This section deals with performance measures for different levels of an organization and for managers at these levels – both financial and non-financial performance measures.

Performance measurements of an organisation unit should be a prerequisite for allocating resources within that organisation. When a unit undertakes new activities projections of revenues, costs and investments are made. An ongoing comparison of the actual revenues, costs and investments with the budgeted amounts can help guide top management's decisions about future allocations.

Performance measurement of managers is used in decisions about their salaries, bonus, future assignments and status, which motivate managers to strive for the goals used in their evaluation.

**14.4 Performance Reports: Format and Essential Features**

1. **Tailored to the organisation structure and controllability:** The performance report system should be structured to the organisation structure of the enterprise in the same way as budgeting and accounting systems. There should be a separate performance report for each responsibility centre, starting with those at the lowest level which in turn feed into summary reports for each higher level.
2. **Designed to implement the exception principle in management:** Performance report must clearly distinguish between controllable and non-controllable items. Performance measurement requires that actual results be compared with plans, objectives and standards so that differences (exceptions) call management attention to high, low and satisfactory performance. The variances from plans signal the need for investigation and possible action. The action may be corrective, commendatory or revisory. Both favourable and unfavourable variances justify investigation. Unfavourable variances may signal danger and further investigation generally is necessary to pinpoint the precise cause.
3. **Repetitive and relate to short-time spans:** Performance should be repetitive, generally on a monthly basis, although certain problems may suggest the need for weekly or even daily reports that focus on a particular problem.
4. **Adapted to the requirements of the principal user:** Performance reports serve the evaluation and decision-making needs of the user.
5. **Simple, understandable and report only essential information:** Reports should not be too long; complex tabulations should be avoided. Reports should be carefully screened to eliminate all nonessential information. Many performance reports include too much data rather than too little.



**Caution** Performance reports should be standardised. Executive becomes accustomed to certain terminology, forms and methods of presentation and know where to look to find the specific information. Despite the desirability of standardising performance reports, constant attention must be given to improving them. Improvement necessarily involved changes, but desirable changes, if made at an opportune time and adequately presented, can be accomplished usually with a minimum of confusion. Reports must be kept relevant.

6. **Prepared and presented promptly:** Consistent with the cost of detailed record-keeping and reporting, performance reports should be available on a timely basis. To achieve a realistic balance between immediate reporting and the costs of detailed reporting, monthly performance reports are widely used by industry. When special problem areas are involved, weekly and even daily reporting may be necessary, at least for a time.
7. **Effective management follow-up procedures:** Follow-up procedures constitute a key aspect of effective control. Some companies require written explanations of significant variances. The follow-up procedures preferred by other companies involve constructive conferences where the causes are discussed and corrective action is decided upon. Follow-up procedures should begin at the management level in the executive committee meeting, for example, where both unsatisfactory and satisfactory conditions are discussed and analyzed. Decisions should be made concerning ways and means of correcting unsatisfactory conditions. Favourable variances should be accorded equivalent study, (1) to determine whether the goals were realistic, (2) to give recognition to those responsible for high performances, (3) possibly to transfer some "know-how" to other subdivisions of the company.

Group and individual conference should be held at the various management levels for effective correction action. Follow-up procedures should embody constructive action to correct unfavourable conditions rather than punitive action for failures, the results of which obviously cannot be erased. Another important aspect of follow-up procedure is that the resulting action is strictly a line responsibility rather than a staff responsibility. The budget director, controller or other staff officer should not undertake, nor be assigned, the responsibility of enforcing the budget.

1. Identification of responsibility
2. Distinction between controllable and non-controllable items
3. Specific time dimensions - month and cumulative to date
4. Method of reporting variances
5. Adjustment of the (planned) amounts to actual output (that is flexible/variable budget approach).
6. Detail on each category (including service usage in units) and
7. Explanatory comments and suggestions.

**Comments:**

1. Output was 13 percent below the planned level due to production scheduling pull back to accommodate 5000 units unfavourable sales volume variance, the department met its production schedule as adjusted.
2. Unfavourable variances in service usage should be carefully investigated to determine underlying causes.

To have the maximum benefit, the monthly report should be designed to indicate the performance of each individual having supervisory responsibility. A well-designed control report should be completely integrated i.e., each schedule should look on a responsibility basis so that (i) major variation may be traced to the source of the problem and (ii) the various segments comprise within themselves a complete report. Please refer to the illustration on previous page - Performance Reports SP Manufacturing Company.



Distribution of the monthly performance report (and its segments) should follow essentially the same pattern as the annual profit budget plan. Certain executives need the complete monthly performance report. Other members of the management only need those schedules related to their particular responsibility centres. Lower levels of management may receive only one of the detailed segments. On the other hand, the higher the level of management, the greater the need for summaries, yet these summaries must be supported by adequate detail to identify particular aspects of operations.

Types of reports for different levels of management:

1. **Top management including Board of Directors and Financial Management:**
  - (a) Balance Sheet
  - (b) Profit and Loss Statement
  - (c) Position of Stock
  - (d) Disposition of funds and working capital
  - (e) Capital expenditure and financial commitments together with the progress of projects in hand.
  - (f) Cash flow statement
  - (g) Sales, production and other appropriate statistics.
2. **Sales Management:**
  - (a) Actual sales compared with budgeted sales to measure performance by products, territories, individual salesman and customers.
  - (b) Standard profit and loss by product for fixing selling prices and to concentrate on sales of most profitable products.
  - (c) Selling expenses in relation to budget and sales value analysed by products, territories, individual salesman and customers.
  - (d) Bad debts and accounts which are slow and difficult to collect.
  - (e) Status report on new or doubtful customers.
3. **Production Management:**
  - (a) *To buyer:* Price variations on purchases analysed by commodities
  - (b) *To foremen/shop leader:*
    - (i) Operational efficiency for individual operations duly summarised as departmental average.
    - (ii) Labour utilisation report and causes of lost time and controlled time.
    - (iii) Indirect shop expenses against the standard allowed and
    - (iv) Scrap report.
  - (c) *Works Manager/Departmental Managers:*
    - (i) Departmental operating statement.
    - (ii) General works operating statements – expenses relating to all works expenses not directly allowable or controllable by departments.
    - (iii) Plant utilisation report.
    - (iv) Departmental scrap report and
    - (v) Material usage report.

4. **Specific Report:** These reports may be prepared at the request of general management or at the initiative of the controller. The necessity for them may, in some cases, arise on account of the need for more detailed information on matters of interest first revealed by the routine reports. These reports may range over a very wide read. Some of the matters in respect of which such reports may be required can be:
- (a) Taxation legislation and its effects on profits
  - (b) Estimates of the earning capacity of a new project
  - (c) Breakeven analysis
  - (d) Replacement of capital equipment
  - (e) Special pricing analysis
  - (f) Make or buy certain components
  - (g) Statement of surplus available for payment of bonus.

## 14.6 Keywords
